Agenda Item 1: Progress Report on the Implementation of the 2025 AFI Plans Work Programme

(Presented by the Secretariat)

SUMMARY

This Working Paper presents the status of implementation of the 2025 AFI Plans and HRDF work Programme, covering activities carried out from January to December 2025, as approved by the 27th AFI Plan and the 13th AFI SECFAL Plan SCs meetings held in 2024 in Libreville, Gabon; and the 1st AFI Plans SC meeting held in Victoria Falls, Zimbabwe, from 28 and 29 May 2025.

While several activities benefited from partner support and ICAO-managed funding mechanisms, sustainable and predictable funding remains a challenge and is addressed in further detail under WP/01E.

Action by the meeting is proposed in Paragraph 4. Further details are provided in Attachments A and B.

1. INTRODUCTION

- 1.1 The 27th AFI Plan and the 13th AFI SECFAL Plan SCs meetings held in 2024 in Libreville, Gabon; and the 1st AFI Plans SC meeting held in Victoria Falls, Zimbabwe, from 28 and 29 May 2025, approved the activities, projects, and budget of the AFI Plans for 2025. Prior to the Victoria Falls meeting, the Chairperson of the AFI Plan SC authorized the continuation, early in 2025, of activities under the approved 2024 Work Programme.
- **1.2** Activities in 2025 were implemented based on the priorities approved by the Steering Committee. Development of the projects was guided by needs assessments and analysis undertaken by the Secretariat. A summary of activities implemented, ongoing or pending is provided as Attachment A (AFI Plan and HRDF) and Attachment B (AFI SECFAL Plan).

2. DISCUSSION

2.1 *Implementation of AFI Plan and HRDF*: most of the planned activities and projects under AFI Plan and HRDF for 2025 were implemented. These include support to States to strengthen their oversight systems and resolve SSCs, assistance for aerodrome certification, delivery of HRDF-funded training, follow up activities on the outcomes of the study for RSOOs, and technical support for the infrastructure gap analysis. Details are provided in attachment A.

- 2.2 Implementation of the AFI SECFAL Plan: In 2025, the AFI SECFAL Plan implemented most of approved activities, largely funded by ICAO through its regular budget or other funds such as the No Country Left Behind resources with additional support from partners such as the European Civil Aviation Commission (ECAC), the International Organization for Immigration (IOM) and Transport Cananda. Details are provided under Attachment B. Other activities were implemented using voluntary contributions of the AFI SECFAL Plan, while some activities have been classified as pending and have been incorporated in the 2026 approved Work programme.
- 2.3 A summary of the 2025 available funds, commitments, contributions and remaining balances for 2026 are provided below.
