



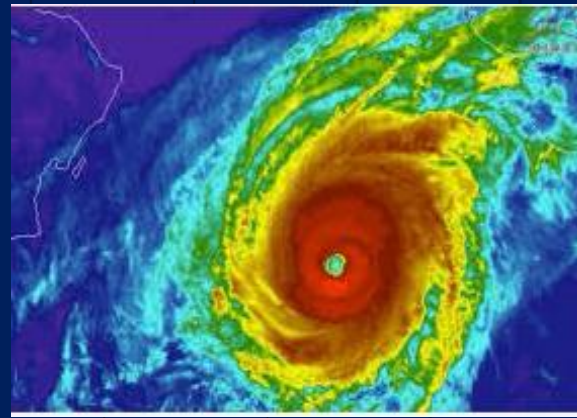
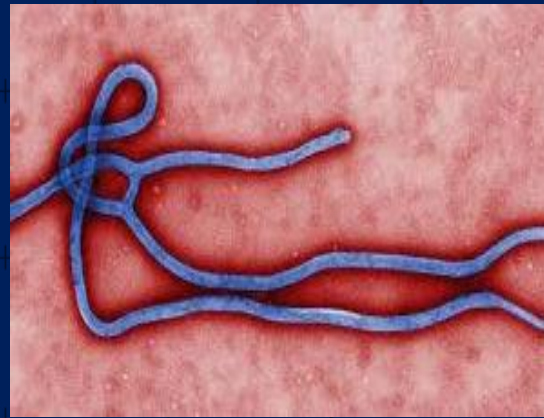

“Emergency preparedness refers to actions introduced before the onset of an emergency to improve the effectiveness, efficiency, timeliness and accountability of emergency responses to save lives and provide protection” UNHCR



Risk assessment and Emergency Preparedness

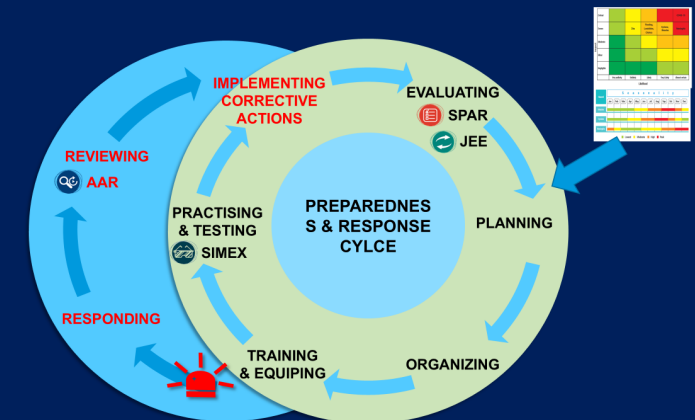
- To enhance level of preparedness in accordance with IHR (2005) countries are required to:
 - Conduct a risk assessment to identify the hazards that pose a very high or high risk
 - Develop and implement an all-hazard emergency response plan
 - Develop and implement contingency plans for the hazards that pose a very high or high risk.

PREPAREDNESS AND READINESS

- OPR is the status of specific functional capabilities that are **activated, fast-tracked, or prepositioned** in anticipation of needing to respond quickly and appropriately to a **priority, imminent, or simulated threat**.
- OPR functional capabilities **bridge** preparedness and response in the health emergency cycle and involve triggering well-characterized anticipatory actions
- Long and medium-term preparedness are prioritized in the National Action Plan for Health Security (NAPHS) to address gaps identified in International Regulations (IHR) core capacities
- An OPR plan prioritizes the critical actions required for an effective imminent response, addressing gaps



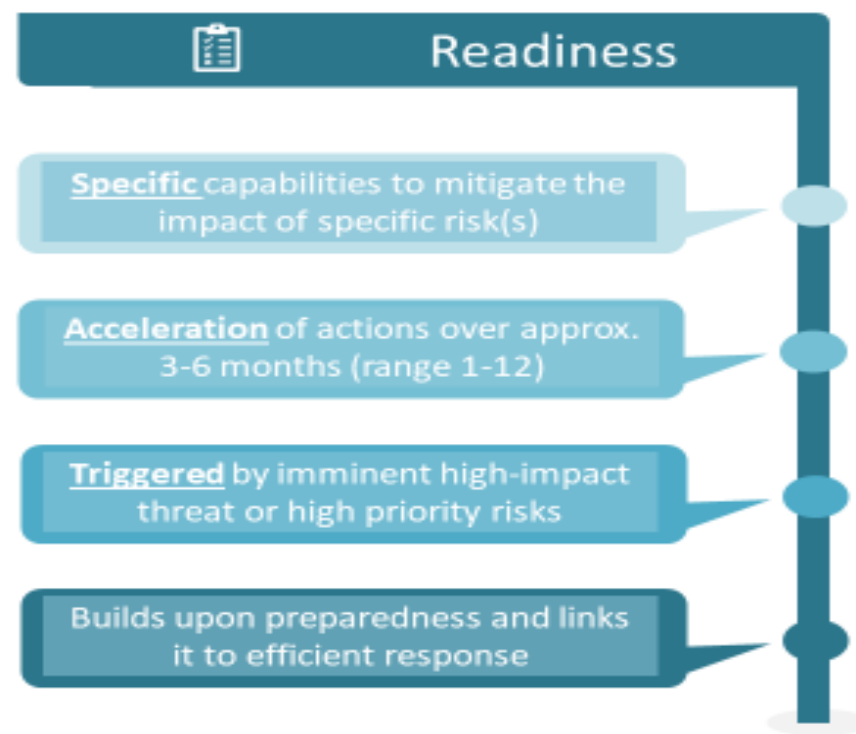


Preparedness vs. readiness/mitigation

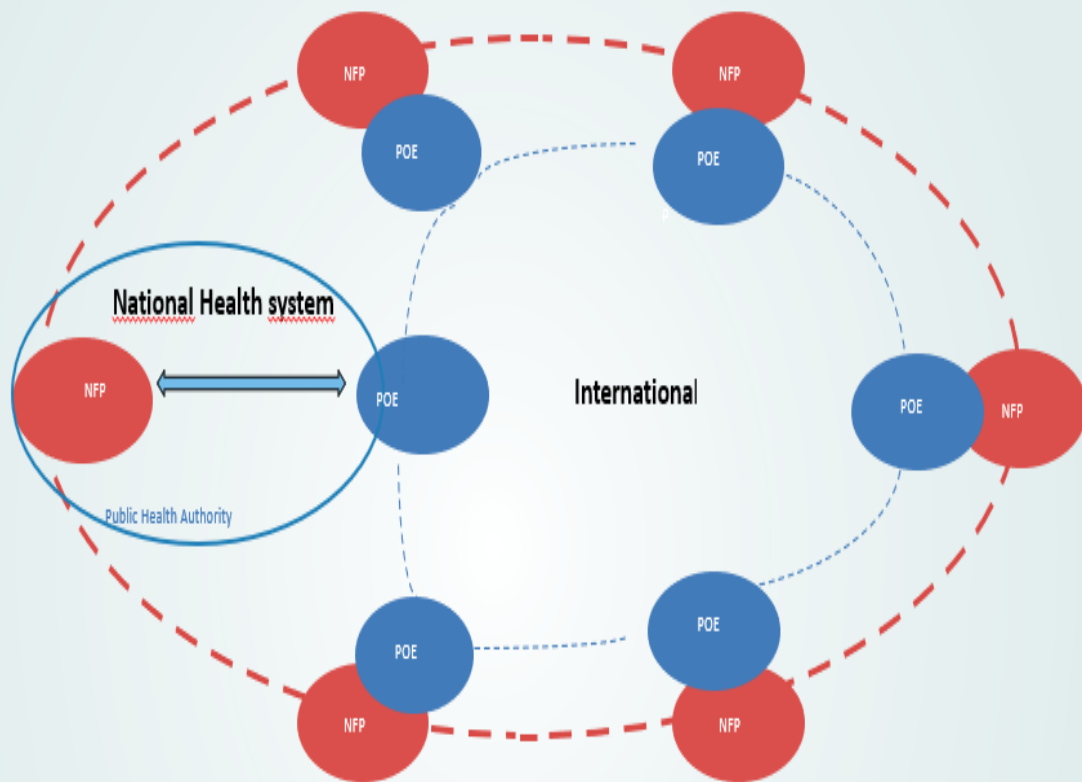
Response Pillar Status

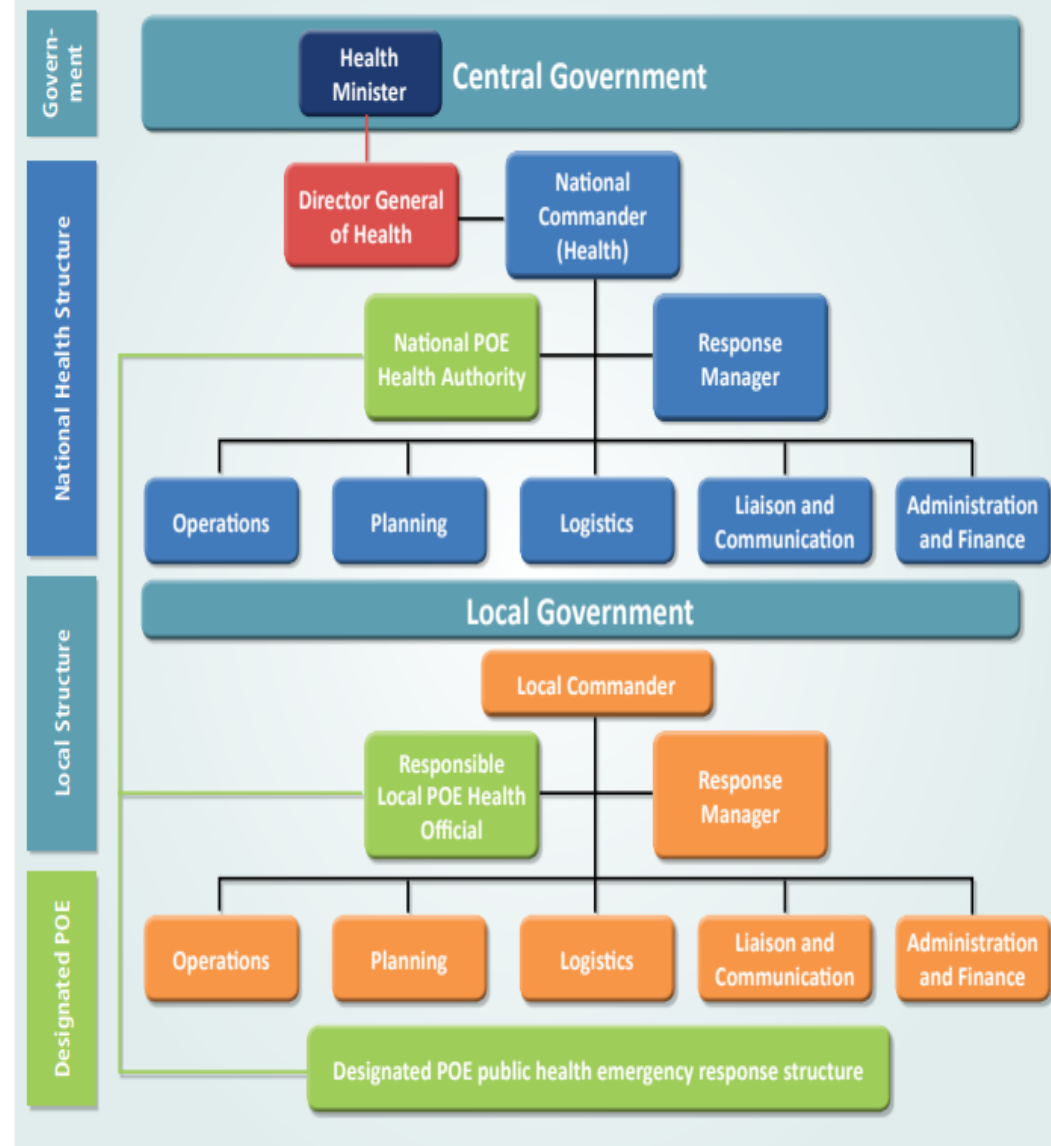

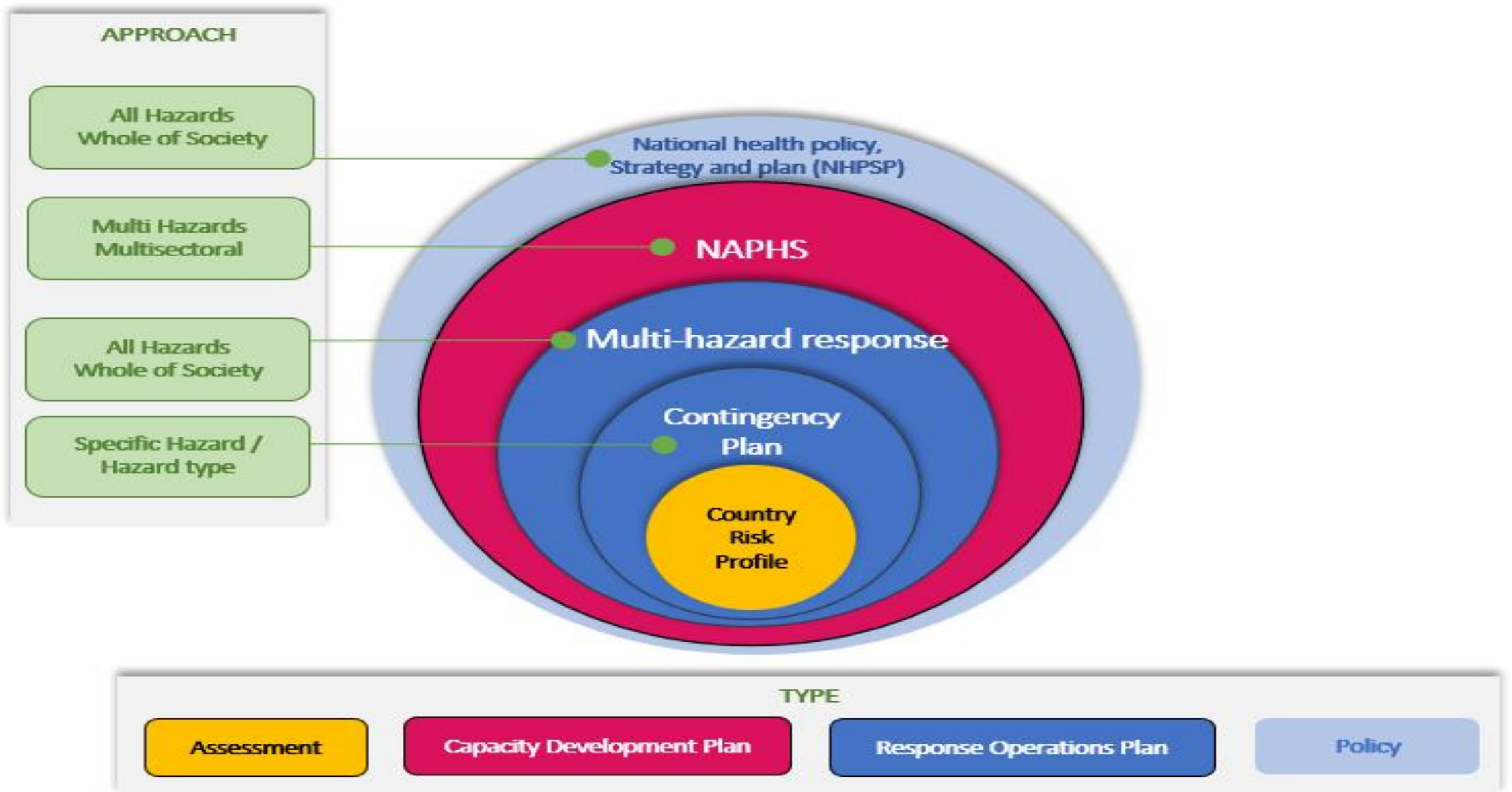

- What is a contingency plan?

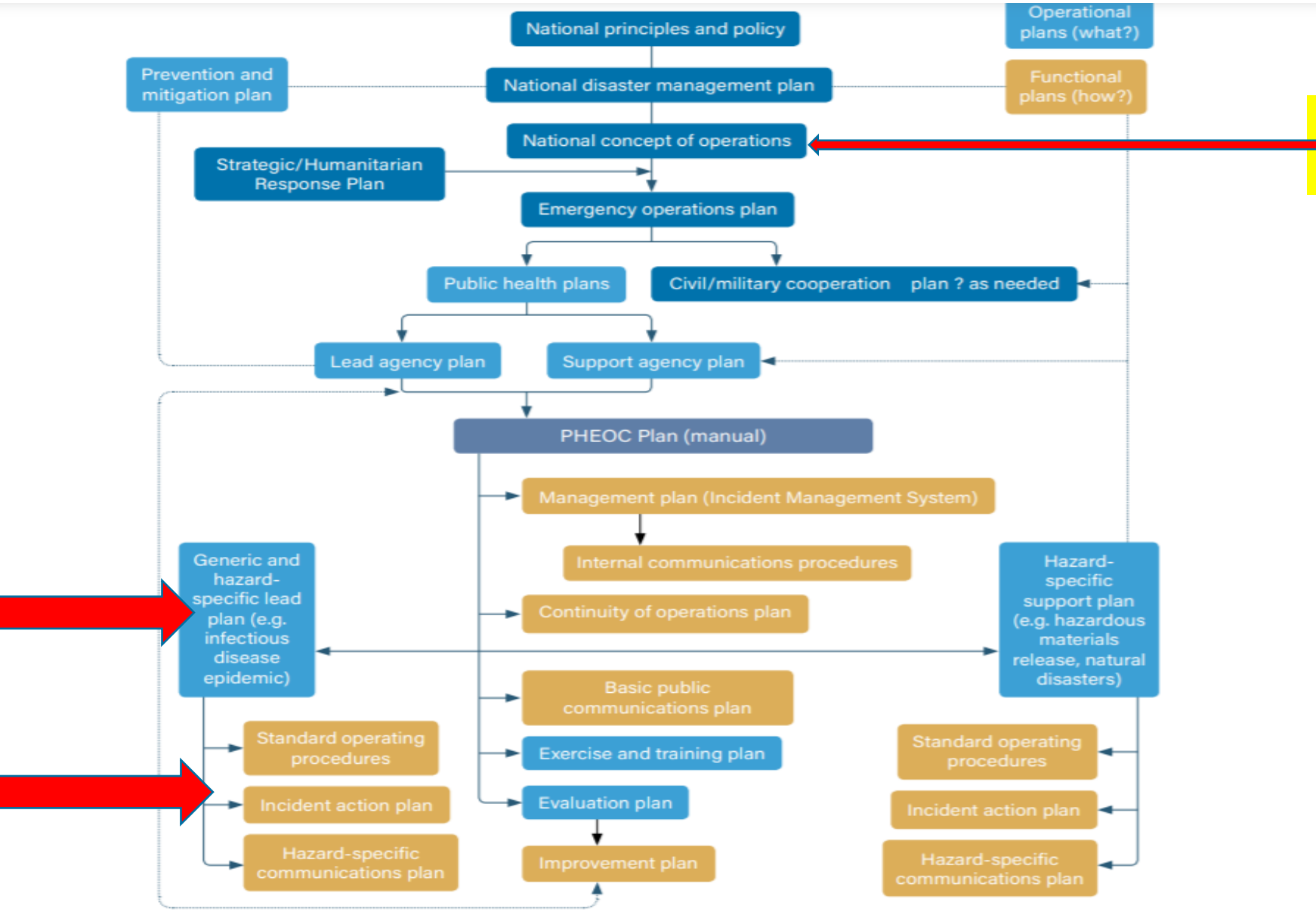
“A plan to deal with particular aspects of a specific threat that is different from other threats. ”

“A plan that sets out the hazard-specific measures required for prevention, preparedness, response and recovery in order to minimise the level of risk posed by that hazard”

- What is a Multihazard or All-Hazard preparedness and response plan?

*“a document that describes how an agency or organization or **country** will manage its responses to emergencies of various types by providing a description of the objectives, policy and concept of operations for the response to an emergency. It also lays out the structure, authorities and responsibilities for a systematic, coordinated and effective response”*

A **national action plan for health security (NAPHS)** to which stakeholders commit to improving a country's level of preparedness over a given period of time

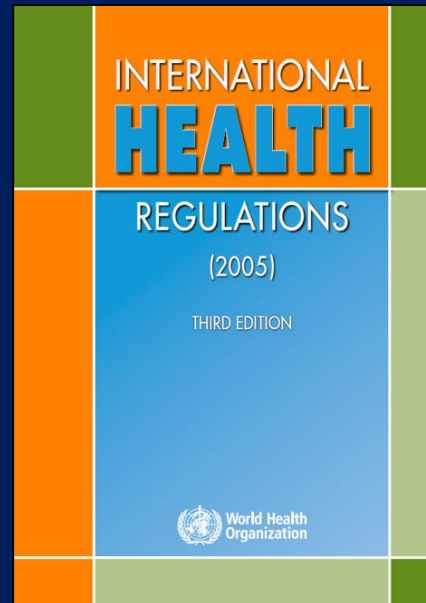
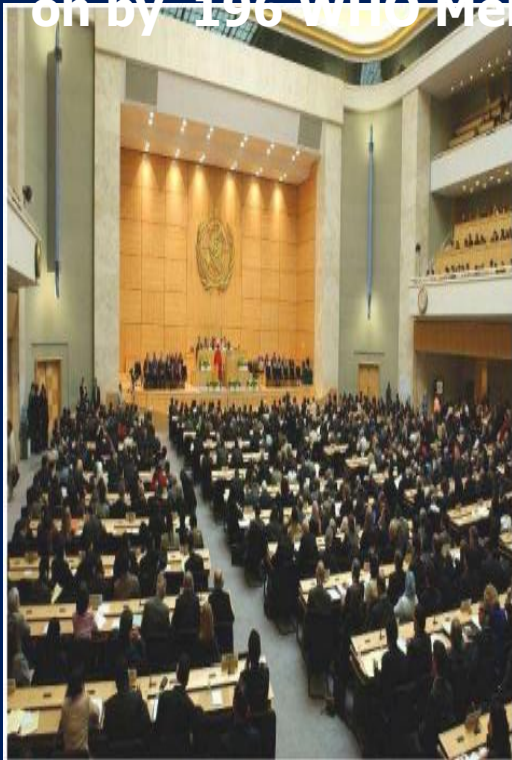

The International Health Regulations (IHR 2005)

- Adopted in 2005; entered into force in 2007; **legally binding, global health security framework agreed on by 196 WHO Member States**



- Strengthened national capacity for **surveillance and control, including at ports, airports and ground crossings, and travel and transport**
- Prevention, prepare for, alert and response** to international public health emergencies
- Global partnership and international collaboration
- Rights, obligations and procedures, and progress monitoring

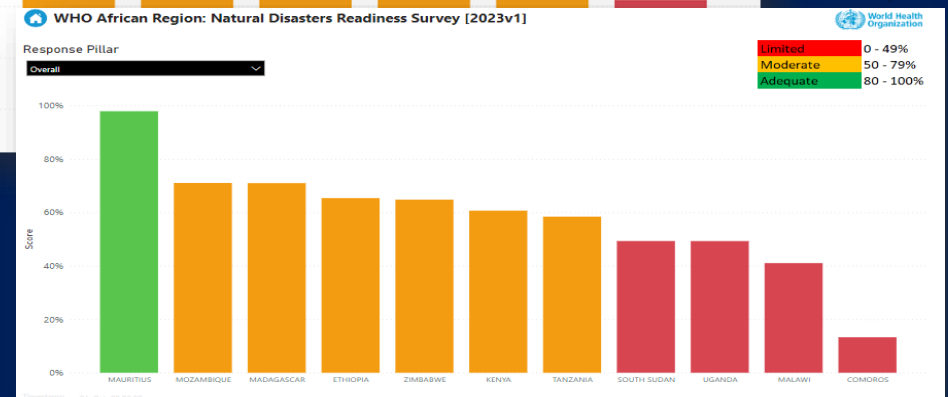
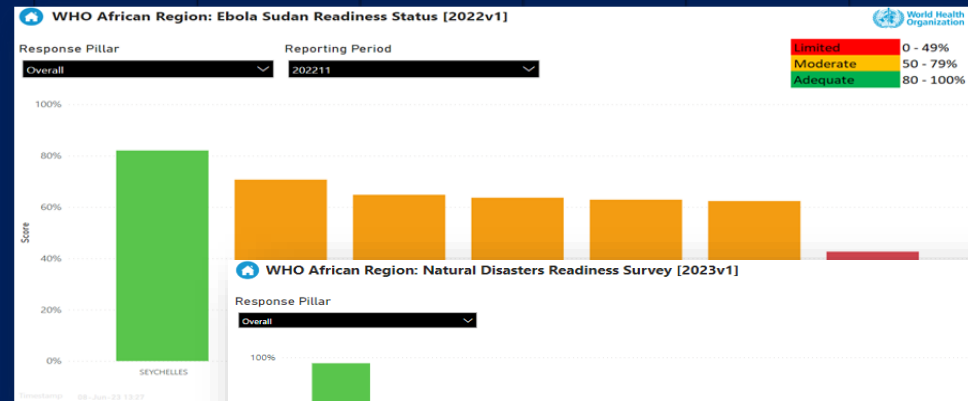
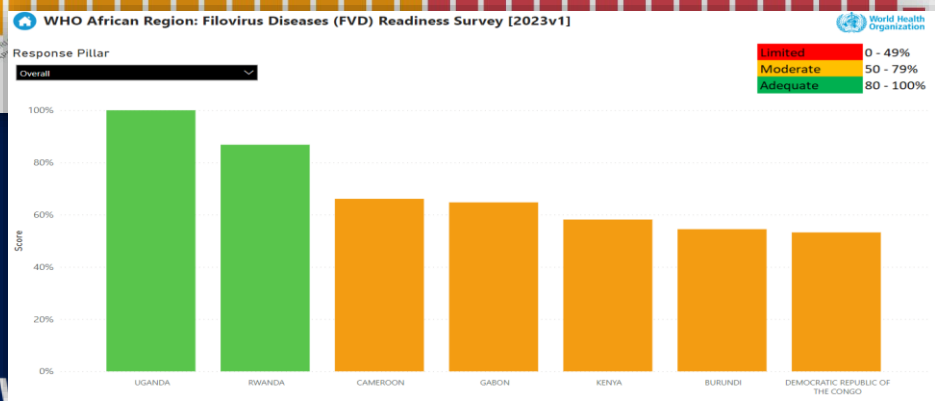
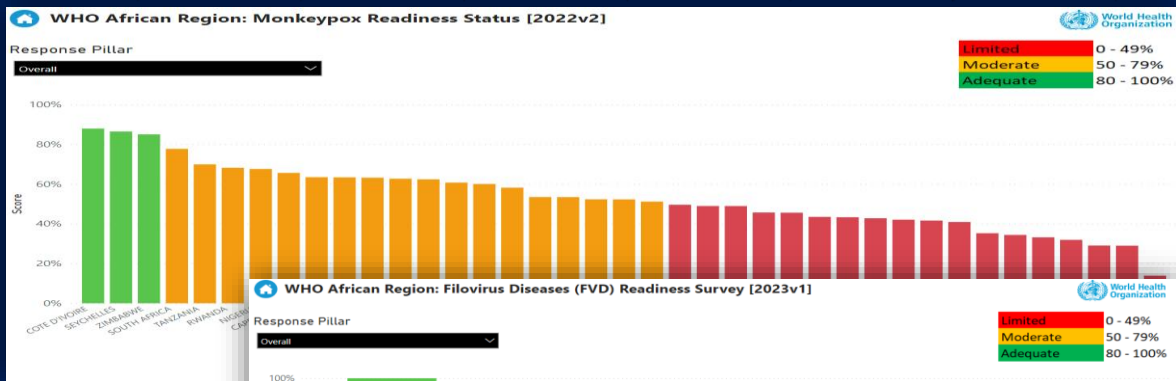
AFRO has recently supported prioritized countries to conduct readiness assessments and to implement readiness activities as below:

All **47** AFRO countries, including response countries for the **2022, 2024- multi Mpox-country outbreaks**

Prioritized countries for the FVD VHF: 2025- MVD Tanzania, SVD Uganda, EVD DRC, MVD Eth outbreaks

36, including response countries for the **2023 multi-country Cholera outbreaks.**

11 prioritized countries for **natural disasters (EL- Nino and cyclones), Also developed a POE VHF assessment tool**



Readiness/preparedness initiatives contd.

- **Operational** readiness training hosted in Rwanda for FVC countries 2024
- **AI based Readiness Intelligence Tool Pilots:** The RIT pilot was rolled out in Nigeria, South Sudan and Chad. Discussions are underway to conduct a multi-country RIT workshop and roll out.
- **POE/Border Health Framework:** AFRO, in collaboration with Africa CDC, are developing a regional border health framework (the first draft is under review and will be shared with member states for inputs).
- **Preparedness in Humanitarian Framework:** a draft is currently developed to be disseminated
- **Community Readiness TTX:** AFRO, HQ and partners (UK HSA) conducted community readiness TTX in Ghana in early 2024, Uganda 2025 and planning for a TTX in 2026 trying to push for implementation in Border communities
- **Mass Gathering:** AFRO is developing the List of Events (LoEs) for mass gatherings 2025- 2026 to support country readiness for mass events.utilizing global online mass gathering tool
- **Webinars:** Cholera and Marburg in Feb 2025; PoE/border health in August Sept 2025; Risk calendars and predictions and anticipatory actions on Sept 2025 and plans underway for Framework launch webinar.
- AVOHC SURGE training for over 3,000 government personnel in the region, (target increased to 5000), JEAP program is strengthening in Workforce, OSL, Laboratory etc. regional stockpiles in Nairobi and Dakar
- FETP frontline trainings for POE personnel being piloted- South Africa, other trainings being facilitated as requested – pandemic fund- Towards strengthening the Africa regional strategy for health security and emergencies 2022-2030 & COVID-19 lessons
- Support to countries to conduct exercises. PRoBE project in planning stage

Challenges

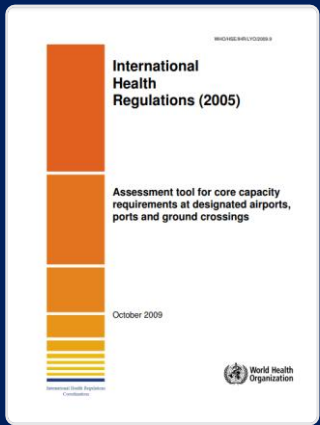
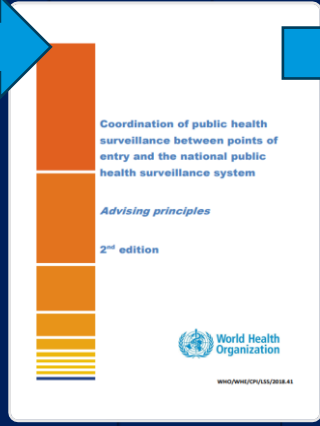
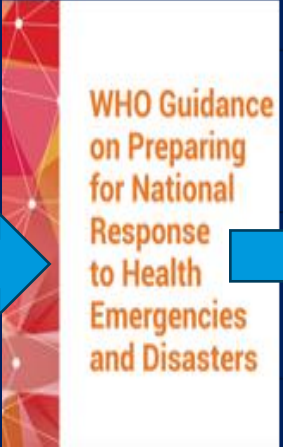
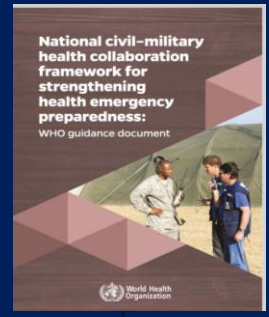
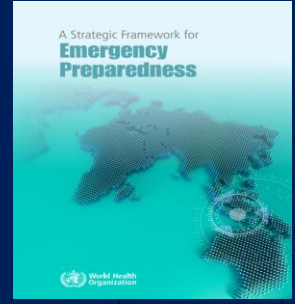
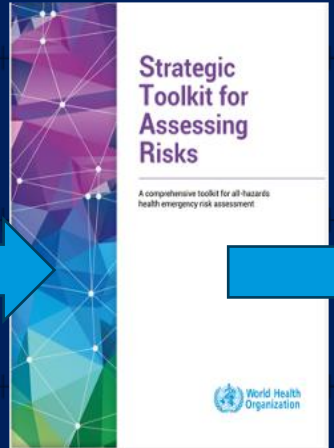
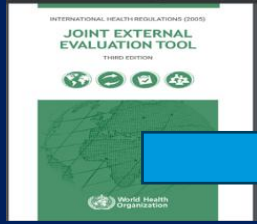
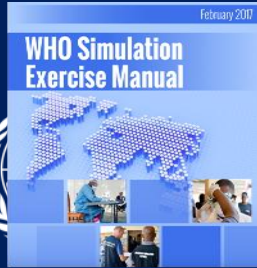
- Delays in completion and sharing of the readiness assessment tools
- Limited HR capacities
- Focus on the national level
- Competing emergencies hence delays in getting feedback from countries
- Insecurities in some countries
- Funding gaps and Low funds utilization by countries

Recommendations

- Enhance coordination and information sharing
 - Timely completion and sharing of readiness checklist and development/updating CP & SPRPs
 - Strengthen workforce planning through engagements with partners
 - Rollout of readiness activities to the sub-national level
 - Strengthen cross-border collaboration
 - Support prioritized readiness countries in conducting hazard-specific readiness assessments Ensure efficient and timely utilization of funds
