USOAP celebrates its 1000th activity in 2023

USOAP will soon celebrate USOAP-1000, a milestone that marks the significant aviation safety improvements that ICAO and its Member States have achieved.

The audit of South Africa in March 2023 will be the 1000th activity conducted under the Programme. USOAP-1000 will be celebrated in both South Africa and Montreal in the ICAO headquarters.

Ceremonies are planned to present the USOAP milestones and achievements as well as to recognize contributions of staff and supporters to the success of the Programme. ICAO officials and representatives of ICAO Member States, international organizations, the aviation industry and the media are expected to attend the event.

USOAP-1000 is not the just commemoration of a historical milestone for the Programme. It is also an outreach activity to promote USOAP at large and encourage States to improve their safety records and level of effective implementation of ICAO's SARPs.

USOAP-1000, the audit of South Africa (22 March - 1 April) was successfully concluded

ICAO last audited South Africa in 2017, when the State scored a respectable 87.39% of Effective Implementation (EI).

The 2023 audit was kind of different. It was the USOAP 1000th activity, which the host State enthusiastically agreed to celebrate.

The USOAP team led by Louis Kweku Opoku (Ghana) consisted of auditors from nine different nationalities, each of them specializing in one of the eight technical areas.

Reportedly, the audit team had received full collaboration from the able staff of the SACAA who facilitated the audit.

Thus, the audit team was able to conclude its audit as planned and join the USOAP-1000 Gala organized by the gracious hosts from the SACAA.

The final audit results of South Africa will be released in Q3 this year.
