REVISIONS TO THE LIST OF N.O.S. AND GENERIC PROPER SHIPPING NAMES

SUMMARY

This working paper proposes to revise the list of n.o.s. and generic proper shipping names in Attachment 1;2 to align with the UN Model Regulations.

Action by the DGP: The DGP is invited to consider revising the list of n.o.s. and generic proper shipping names in A1;2 of the Technical Instructions to align with the associated list in the UN Model Regulations.

1. **INTRODUCTION**

- 1.1 Specific entries cover a group of substances or articles of a particular chemical or technical nature, such as UN 1964, **Hydrocarbon gas mixture**, **compressed**, **n.o.s.***.
- 1.2 General entries cover a group of substances or articles having one or more general dangerous properties, such as UN 1993, **Flammable liquid**, **n.o.s.***.
- 1.3 According to the above definitions, in the list of n.o.s. and generic proper shipping names contained in Attachment 1, Chapter 2), there are eleven entries listed under the specific entries that should be under the general entries, including:

Articles containing flammable gas, n.o.s.* (UN 3537);
Articles containing non-flammable, non toxic gas, n.o.s.* (UN 3538);
Articles containing flammable liquid, n.o.s.* (UN 3540);
Articles containing flammable solid, n.o.s.* (UN 3541);
Articles containing a substance liable to spontaneous combustion, n.o.s.* (UN 3542);

Articles containing a substance which emits flammable gas in contact with water, n.o.s.* (UN 3543);

Articles containing oxidizing substance, n.o.s.* (UN 3544); Articles containing organic peroxide, n.o.s.* (UN 3545); Articles containing toxic substance, n.o.s.* (UN 3546);

Toxic solid, flammable, inorganic, n.o.s* (UN 3535); Articles containing corrosive substance, n.o.s.* (UN 3547).

1.4 A double check was also made between the Technical Instructions and the list in the UN Model Regulations, Appendix A, and the differences were found different. So revisions to the eleven entries are suggested to align with the UN Model Regulations.

2. **ACTION BY THE DGP**

2.1 The DGP is invited to consider revising the list of n.o.s. and generic proper shipping names in A1;2 of the Technical Instructions to align with the associated list in the UN Model Regulations.
