Sir/Madam,

I have the honour to inform you that the International Civil Aviation Organization (ICAO) under the Comprehensive Regional Implementation Plan for Aviation Safety in Africa (AFI Plan) is organizing a Government Safety Inspector (GSI) course in airworthiness. The course is scheduled to be held in Johannesburg, South Africa, from 11 to 29 July 2011.

The GSI Airworthiness course covers the basic concepts and steps involved in certifying an Approved Maintenance Organization (AMO) as well as those airworthiness aspects relating to the certification of an Air Transport Operator.

The aim of the course is to provide participants with the knowledge and skills required to conduct certification by following the five-phase certification process based upon ICAO Standards and Recommended Practices (SARPs). During the course, participants will follow a "mock operator" seeking certification through each phase of the certification process based on the Model Civil Aviation Regulations (MCARs). Exercises will be conducted in which participants will evaluate excerpts of the mock operator's manuals and make observations of the operator's demonstrations to ensure compliance with the MCARs and advisory materials.

The course will be conducted in the English Language and priority will therefore be given to applicants from Anglophone States.
