CONVENTION ON INTERNATIONAL CIVIL AVIATION  
ARTICLE 50(a), SIGNED AT MONTRÉAL ON 6 OCTOBER 2016**

<sup>1</sup> The instrument of ratification by New Zealand contains the following declaration:  
“consistent with the constitutional status of Tokelau and taking into account the commitment of the Government of New Zealand to the development of self-government for Tokelau through an act of self-determination under the Charter of the United Nations, this ratification shall not extend to Tokelau unless and until a Declaration to this effect is lodged by the Government of New Zealand with the depositary on the basis of appropriate consultation with that territory.”

<sup>2</sup> At the time of ratification, the Government of the United Kingdom declared that the Protocol is ratified “in respect of: The United Kingdom of Great Britain and Northern Ireland; The Bailiwick of Guernsey; The Bailiwick of Jersey; The Isle of Man; Turks and Caicos Islands; South Georgia and the South Sandwich Islands; The Sovereign Base Areas of Akrotiri and Dhekelia in Cyprus; and British Antarctic Territory”.
