By a Note dated 17 July 2001, deposited on 6 September 2001 with ICAO, the Government of the Federal Republic of Yugoslavia declared itself bound, as a successor State to the Socialist Federal Republic of Yugoslavia, by the provisions of, *inter alia*, this Agreement, with effect from 27 April 1992, the date of State succession. (The former Socialist Federal Republic of Yugoslavia had signed this Agreement on 16 June 1987 and ratified it on 6 April 1988.)
