- 1 Signed without reservation as to acceptance.
- 2 Reservation made at the time of signature and ratification that the Government of Turkey does not consider itself bound by Article XI, paragraph 1, of the Convention on the Marking of Plastic Explosives for the Purpose of Detection.
Declaration made at the time of ratification and pursuant to Article XIII, paragraph 2, of the said Convention that Turkey is not a producer State of plastic explosives.
- 3 Association with the Programme as a Ground Segment Provider.
- 4 The instrument of ratification by Turkey contains the following reservation in accordance with Article 57:
“The said Convention shall not apply to international carriage by air performed and operated directly by the Republic of Turkey for non-commercial purposes in respect to its functions and duties as a Sovereign State and to the carriage of persons, cargo and baggage for Turkish military authorities on aircraft registered in or leased by the Republic of Turkey, the whole capacity of which has been reserved by or on behalf of such authorities.”
- 5 At the time of ratification, Turkey made declarations under Articles 39(1)(a), 39(1)(b), 40, 50 and 54(2).
- 6 At the time of ratification, Turkey made declarations under Article XXX(1), (2) and (3).
- 7 At the time of signature, Turkey made the following declaration:
“Signing of the Convention on the Suppression of Unlawful Acts Relating to International Civil Aviation (2010) and the Protocol Supplementary to the Convention for the Suppression of Unlawful Seizure of Aircraft (2010) by the Republic of Turkey should in no way be construed as implying any obligation on the part of Turkey to enter into any dealing with the countries that Turkey has no diplomatic relations with, within the framework of the said Convention and the Protocol.”

Upon ratification of the Convention, Turkey made the following reservation and declaration, respectively:

“The Government of the Republic of Turkey declares that it does not consider itself bound by the Article 20, Paragraph 1 of the Convention on the Suppression of Unlawful Acts Relating to International Civil Aviation, 2010.”
