NOTES

- 1 Acceptance of the Protocol on the Authentic Trilingual Text of the Chicago Convention is deemed by virtue of adherence to that Convention, as provided by Article V of the Protocol.
- 2 Reservation: The Government of Belarus does not consider itself bound by Article 24, paragraph 1, of the Tokyo Convention.

Declaration dated 17/12/87 by the Byelorussian Soviet Socialist Republic (now the Republic of Belarus) that “the accession of the Byelorussian Soviet Socialist Republic to the Convention on Offences and Certain Other Acts

Committed on Board Aircraft does not affect its rights and obligations under agreements in force on the suppression of acts of unlawful interference with civil aviation, to which it is a Party”.

- 3 Reservation: The Government of Belarus does not consider itself bound by Article 12, paragraph 1, of the Hague Convention.
- 4 Reservation: The Government of Belarus does not consider itself bound by Article 14, paragraph 1, of the Montreal Convention.
- 5 Declaration in accordance with Article XIII, paragraph 2, of the Convention (accompanying the instrument of approval) that Belarus is not a producer State of plastic explosives.
- 6 On 28 June 2011, Belarus deposited its instrument of accession in respect of the Convention only, without declarations. On 27 September 2011, Belarus notified the depositary of the making of a declaration pursuant to Article 54(2) which enabled the deposit on the same date of the instrument of accession in relation to the Aircraft Equipment Protocol. The Protocol and the Convention as applied to aircraft equipment enter into force for Belarus on 1 January 2012.
