NOTES

- ¹ Sweden signed the International Air Transport Agreement on 7/12/44 and ratified it on 19/11/45 (with effect from that same date). The Agreement was subsequently denounced by the Government of Sweden on 29/4/82, which denunciation took effect on 29/4/83.
- ² Signed without reservation as to acceptance.
- ³ Declaration: In a letter dated 8/11/55 transmitted with its Instrument of Ratification, the Government of Sweden indicated that it does not consider that the Geneva Convention, as ratified by Mexico, will come into force between Sweden and Mexico.
- ⁴ Upon signature of the Convention, Sweden, Member State of the European Community, declared that, “in accordance with the Treaty establishing the European Community, the Community has competence to take actions in certain matters governed by the Convention”.
- ⁵ On 8 September 2003, the depositary registered withdrawal by Sweden of its instrument of ratification of Additional Protocol No. 3 which had been deposited on 4 May 1988.
- ⁶ Declaration, in accordance with Article XIII, paragraph 2, of the Convention, that Sweden is a producer State of plastic explosives.
- ⁷ Association with the Programme as a User State.
