¹ The International Air Transport Agreement was signed on behalf of Thailand on 7/12/44 and ratified on 6/3/47 (effective that same date). This Agreement was, however, subsequently denounced by Thailand on 18/3/53, which denunciation took effect on 18/3/54.

² Declaration made at the time of accession that Thailand is not a producer State of plastic explosives.
Reservation: the Kingdom of Thailand is not bound by paragraph 1 of Article XI, except with an explicit declaration on its part and on a case by case basis.

³ Association with the Programme as a Ground Segment Provider.

The instrument of accession by Thailand contains the following declaration in accordance with Article 57:

“the Convention shall not apply to:

- a) international carriage by air performed and operated directly by the Kingdom of Thailand for non-commercial purposes in respect to its functions and duties as a sovereign State; and
- b) the carriage of persons, cargo and baggage for its military authorities on aircraft registered in or leased by the Kingdom of Thailand, the whole capacity of which has been reserved by or on behalf of such authorities.”
