I have the honor to inform you that the ICAO Asia-Pacific Flight Procedure Programme (FPP) will conduct *the Helicopter Point in Space (PinS) Workshop, from 12 to 15 November 2019*. This workshop will take place at the ICAO Asia and Pacific Regional Sub-Office (RSO) in Beijing, China.

In its role to assist States in Phase III implementation, ICAO FPP is pleased to conduct a dedicated workshop for FPP member States as the helicopter PinS procedure design is complex by nature. This workshop highlights the challenges faced and covers all the helicopter specific criteria. The workshop will be composed of three parts, knowledge expansion, exercise and experience sharing. The first part will review ICAO requirements and available materials that can be referred to Helicopter Point in Space. The second part will practice how available materials can be applied to real case and how to document it. The last part will share State's best practices and experiences with participants. In this regard, States are invited to present their best practices or share experiences gained during Helicopter Point in Space, especially on, but not limited to, the topics depicted in the Workshop Programme (Attachment A).

The Helicopter Point in Space Workshop is opened to any interested individuals with professional responsibilities related to Helicopter PinS procedure design, including regulators, safety managers, air traffic controllers, procedure designers and pilot. Thus, it would be highly appreciated if your State/Administration could disseminate this invitation to pertinent stakeholders.


