I have the honor to inform you that the ICAO Asia-Pacific Flight Procedure Programme (APAC FPP) will conduct the RNP AR Workshop from **30 March to 03 April 2026** at ICAO APAC Regional Sub-Office (RSO), Beijing, China.

The workshop covers the underlying principles and procedure design criteria of RNP AR Approach as laid down in ICAO Required Navigation Performance Authorization Required (RNP AR) Procedure Design Manual (Doc.9905). Theoretical sessions will be followed by practical exercises for the implementation of the criteria. As the workshop, including all materials, will be conducted in English, participants should have adequate communication skills in English.

States/Administrations are cordially invited to nominate participants for in-person attendance. To provide the best training environment, enrolment will be limited to fifty participants. Priority for this course will be given first to Active Participating States/Administrations, and then to User States of APAC FPP. Given the considerable demand for this course, priority should be specified if a State/Administration nominates more than three candidates. The RNP AR workshop will be free of charge for APAC FPP members. However, participants' respective State/Administration is expected to fund their
