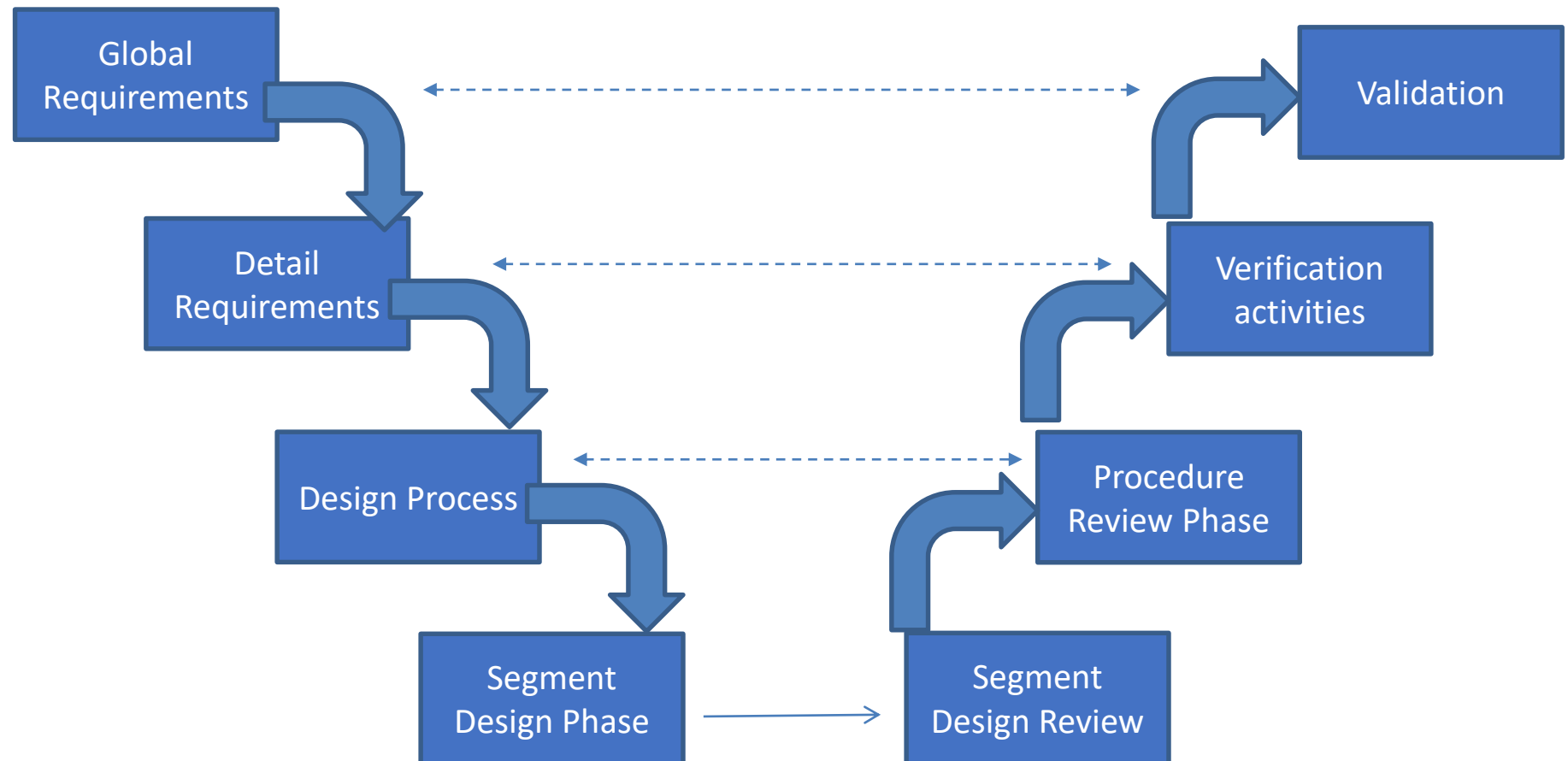




Related validation for flight procedure design

Related validation for flight procedure design



- Verification vs Validation

Verification	Validation
Design Outputs meet Design Inputs	Design meets user needs
Procedures, Segments and unit testing	Test focused at ‘System’ level
During Development	After Development
Can be performed by ‘All Designer’ team	Shall be performed on the aerodrome that the procedure will be used, or equivalent ‘airport’ (for FFS)
Performed against the requirements established by the Standards	Performed against the selected user needs

Related validation for flight procedure design



- Flight Validation
 - The obstacle environment where the procedure is located
 - The fly-ability of the procedure
 - The ARINC 424 coding of the procedure
 - The effects of different weather (wind and temperature) conditions
 - For different take-off loads and weather conditions
 - The different types of GPS augmentation
 - Other requirements from users, EOSID e.g.

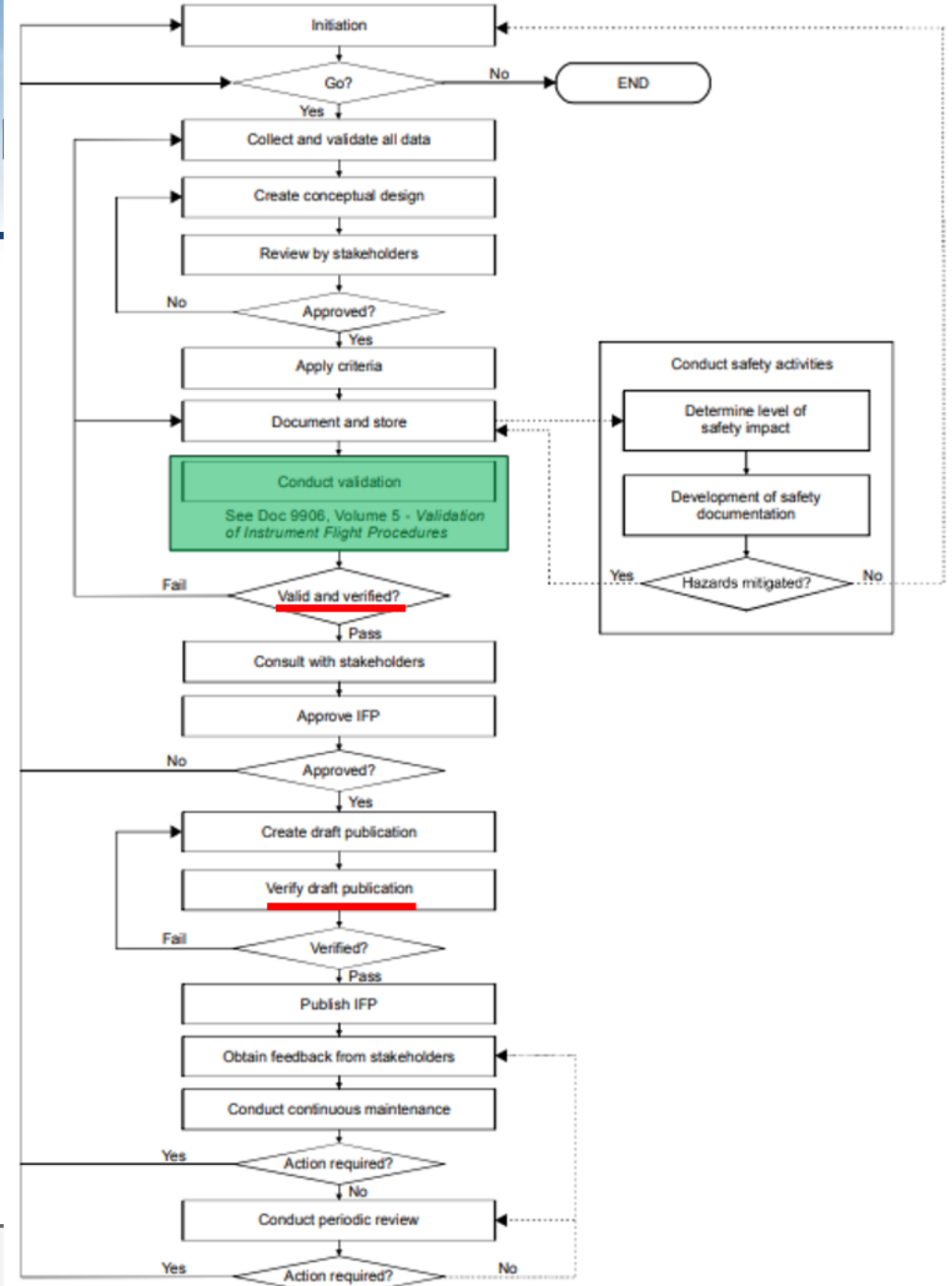

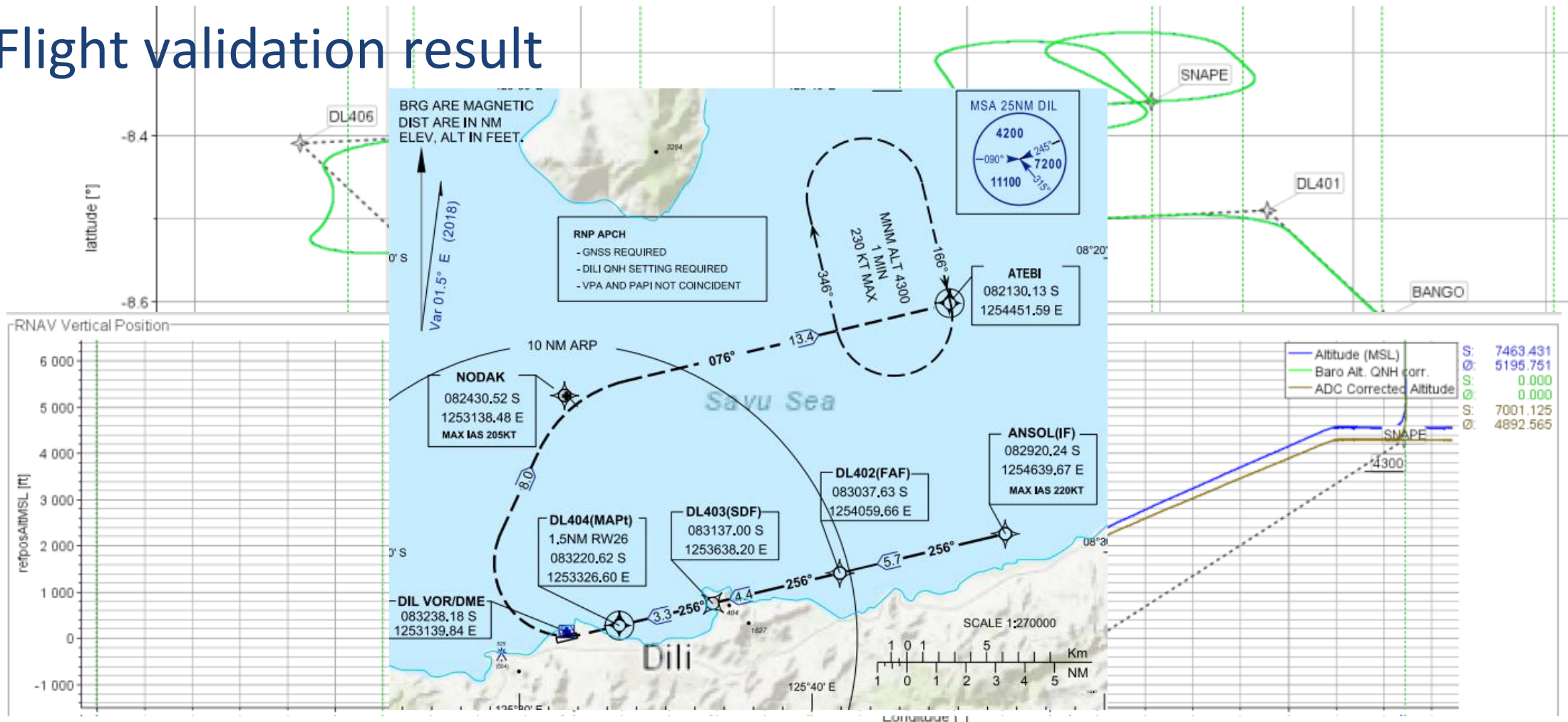
