Action required: Take necessary action and submit nomination **by 9 June 2020**

Dear Sir/Madam,

I wish to refer to APAC State Letter Ref.: T 8/5.10.1 – AP038/20 (CNS) regarding the revised dates of the first meeting of the Asia/Pacific GBAS/SBAS Implementation Task Force (APAC GBAS/SBAS ITF/1) dated 26 February 2020. Considering the current situation and the consequent restrictions on travel in the APAC Region, the ICAO Secretariat has decided **to host the meeting via video conferencing from 23 to 24 June 2020.**

To ensure effectiveness and efficiency of conducting the meeting through video conference, the draft agenda is revised focusing the core business of the meeting. As it is the first meeting of the task force, the meeting will review the Terms of Reference and develop an initial list of actions items. The election of chairpersons and information papers from States on the current GBAS/SBAS implementations will be deferred to the face to face meeting to be determined.

States/Administrations are therefore requested to nominate relevant personnel with appropriate GBAS/SBAS expertise in technical, operational, safety and regulatory aspects to participate in the work of the Task Force. In addition, International Organizations recognized by ICAO Council are also invited to nominate their representatives to join the meeting. Please use the revised registration form and send it back to ICAO Secretariat **no later than 9 June 2020**. All registered participants will receive an email directly from the Secretariat with an invitation link and appropriate instructions. A video conference test session will be organized on 19 June for those interested.


