TERMS OF REFERENCE

Adopted by ACCRPG/1, 05 June 2020

1. Name and establishment of group

1.1. ICAO APAC COVID-19 CONTINGENCY AND RECOVERY PLANNING GROUP (ACCRPG)

1.2. The ICAO APAC DGCA *Information Sharing web-conference*, on the subject of COVID-19, 31 March 2020, decided to form a task force/group to assist the DGCAs in coordinating their approach to the management of civil aviation through, and out of, the current extraordinary circumstances resulting from the COVID-19 pandemic.

2. Membership and appointment

2.1. The size of the group should be commensurate with the need for expeditious and efficient handling of group's business.

2.2. Membership should provide the group with ready access to required research and supporting expertise, demonstrated experience in contingency management, post recovery and adequate geographical representation.

2.3. Members should be nominated by the Civil Aviation Authorities and international organizations concerned and confirmed by ICAO.

2.4. The term of the group will be for one year. However, the term may be extended by the DGCAs as necessary.

2.5. The Secretary of the group is the ICAO APAC Regional Director; with assistance from additional ICAO staff as necessary.

3. Chairing

3.1. The group shall elect a Chairperson at its first meeting from experts nominated by the members.

4. Frequency of meetings and quorum

4.1. The group will determine an appropriate frequency and schedule for its meetings.

4.2. A simple majority of members is required for the group to carry a motion.

5. Record of meetings

5.1. The group will record key discussion and outcomes of each meeting in the form of a progress report.

5.2. The Secretary will be responsible for the records of the group's meetings.

6. Reporting mechanism

6.1. The Secretary will deliver oral and/or written progress reports to the DGCAs, ICAO and other key stakeholders as necessary.

7. Functions and delegated authority

7.1. The purpose of the group is to take into account the priority of ICAO's strategic objectives and work proactively in coordination with the DGCAs, International Organisations, ICAO (HQ and Regional Offices) and other relevant bodies to assist the DGCAs with coordinating the management of international civil aviation contingencies of the COVID-19 pandemic.

7.2. The role of the group is to advise the DGCAs on aviation policy issues.

7.3. The scope of the group will accommodate contingencies of the immediate, recovery and post-recovery phases of the COVID-19 pandemic.

7.4. The key functions of the group are the following:

7.4.1. Obtain and share information on the implementation by Member States, ICAO, International Organizations, industry and other key stakeholders of measures to manage civil aviation contingencies of the COVID-19 pandemic;

7.4.2. Inform the DGCAs on a regular basis of the coordinated measures to manage civil aviation contingencies of the COVID-19 pandemic to encourage harmonised application;

7.4.3. Identify, anticipate, prioritize and make recommendations to address specific issues arising from the ICAO *Council Aviation Recovery Task Force* (CART), which require, or will in the future require remedial or preventive action by Member States and/or ICAO; and

7.4.4. Coordinate work and assist States and industry with the implementation of the CART's work.

1.1. The ICAO Asia and Pacific (APAC) Office hosted the Eighth Meeting of the ICAO APAC COVID-19 Contingency and Recovery Planning Group (ACCRPG/8) via web-conference from Bangkok, Thailand, on 13 November 2020.

2. Attendance

2.1. Over eighty-nine (89) participants joined the Meeting from twenty (20) Member States/Special Administrative Regions and ten (10) International Organizations and aviation industry partners. The list of registered participants is at **Appendix A** to this Report.

3. Officers and Secretariat

3.1. Mr. Jim Wolfe, *Assistant Secretary, COVID International, Department of Infrastructure, Transport, Regional Development and Communications, Australian Government*, and Mr. Conrad Clifford, *Regional Vice President, Asia Pacific, International Air Transport Association (IATA)*, presided as Co-Chairs of the Meeting.

3.2. Mr. Arun Mishra, *Regional Director, ICAO APAC Office*, acted as Secretary for the Meeting; assisted by members of the ICAO Secretariat.

4. Language and Documentation

4.1. The working language of the Meeting was English, inclusive of all documentation and this Report. REPORT ON AGENDA ITEMS

1. Opening of the meeting and working arrangements

1.1. The Secretary officially opened the Meeting at 10:00 hrs. in Bangkok on 13 November 2020 (ICT, UTC+7). The Secretary and the Co-Chairs provided opening remarks and welcomed all participants to the Meeting.

1.3. The Secretariat disseminated a copy of the Report from the previous meeting, ACCRPG/7, to all members and focal points of the ACCRPG and posted the Report of ACCRPG/7 on the ICAO APAC Office website: <https://www.icao.int/APAC/ACCRPG/Pages/2020-ACCRPG7.aspx>

2. ACCRPG Sub-Group reports and Work Program

Presentation (1) by the Public Health Sub-Group Rapporteur: *Progress Report – Public Health Sub-Group (PH/SG)*

2.1. The PH/SG convened online for its 8th and 9th meetings on 1 and 15 October 2020, respectively.

2.2. The PH/SG identified its current, top three (3) challenges as follows: i) Establish structured communications between Aviation and PH Authorities (Regional); ii) Testing / Quarantine / Recovered Persons (International harmonised regime); and iii) Challenges in implementing CART guidance (States' feedback).

2.3. In support of i), above, WHO / ICAO convened a Joint Webinar on 5 October 2020 and ICAO convened an online *Aviation – Public Health Experts' Roundtable Discussion* on 4 November 2020.

2.4. In support of iii), above, the PH/SG submitted, for ICAO CART’s consideration, an analysis of APAC States’ responses to the CART Guidance checklist, as follows:

Airport Module	
Terminal Building	- Increase use of A/C and effective filtration systems to keep air clean
General Check-in	- Self-sanitizing technology - Greater use of standardized digital identity management solutions
Security Screening	- Use of mobile boarding pass scanners - Passengers to use automatic boarding pass scanners

Disembarking/Arrival	- Automation of identity verification process
Baggage Claim Area	- Self-service kiosks or online options to report lost luggage

Air System Ops	- Dispatch of aircraft with air conditioning packs inoperative
Cargo Module	- Crew rotations to maintain for 14-day periods
Crew Module	- Not to subject Crews to screening/restrictions applied to other travellers - Flight-deck to be fully sanitized, prior to each cockpit crew change - On-board Safety demonstrations - Crew accommodation during lay-over

Presentation (2) by the Security and Facilitation Sub-Group Rapporteur: Progress Report – Security and Facilitation Sub-Group (AVSEC-FAL/SG)

2.5. The 8th ACCRPG AVSEC/FAL subgroup meeting was held on the 29th October 2020 and provided information on the dissemination of the "Update to ICAO AVSEC Contingency Measures for COVID-19". Three significant points included in the update document relate to the transportation of lifesaving medical equipment including vaccines, once available, as air cargo and appropriate security measures and controls for such items. As of June 2021 Account Consigners for all cargo flights will be phased out as per ICAO State letter AS 8/2-16/85 dated 16 September 2016. States unable to comply with the new policy should advise ICAO in advance. With regard to security controls for liquids and gels (LAGs), alcohol-based hand sanitizers may be temporarily exempted from current LAGs restrictions, if authorized by the appropriate authority. However, if LAGs screening equipment is available, then this should continue to be utilized

2.6. ACI Asia-Pacific presented on the challenges faced by airports due to the pandemic and provided details of potential alternative measures to physical distancing at airport security checkpoints. The preventive measures have been implemented by airports in security operation to prevent the spread of Covid-19, and the potential challenges in security operations, especially when traffic starts to return. 2.7. The meeting was also briefed on the forthcoming Regional AVSEC Coordination Forum (RASCF). The RASCF scheduled for 1 and 2 December as a virtual meeting will include an agenda item on COVID AVSEC & FAL Restart and Recovery. The invitation has been sent to all APAC States and the deadline of submission for online registration is 13th November 2020 and for the submission of papers/presentations 20th November 2020.

Presentation (3) by the Safety Sub-Group Rapporteur: *Progress Report – Safety Sub-Group (SAF/SG)*

2.8. SAF/SG updated ACCRPG/8 on: i) the progress of the safety related CART Recommendations REC #1, #2 and #3; ii) additional safety recommendation at CART Phase II, REC #12; iii) discussion on transportation of vaccines by air with relevant SMEs in progress; and iv) update from HQ OPS on COVID-19 OPS website, QRGs, Travel Bubble for crew training/checks and APAC CRRIC implementation status for safety recommendations.

Presentation (4) by the Secretariat: *APAC COVID-19-Related ATM Operations and Contingency Coordination*

2.9. The ICAO APAC Office developed the *APAC Regional Strategy for COVID-19-Related ATM Contingency Recovery* as a strategy to assist States and ANSPs assessing, planning and managing resumption of traffic and to establish communications, information sharing, coordination and collaboration between ANSPs, and as a mechanism to identify where CCTs may be needed.

2.10. The ICAO APAC Office convened an online *APAC COVID-19-Related ATM Economics Seminar* on 8 October 2020 to share economics-related information to assist the recovery of air transport operations during and after the COVID-19 pandemic. The seminar included presentations on the following subjects:

- Drivers for Economic Change
- National Air Navigation Planning
- Aviation Industry Engagement

2.11. The Secretariat reminded the meeting of the following recommendation agreed by the seventh meeting of the ACCRPG:

(ACCRPG/7) DRAFT Recommendation XX: Air Navigation Services Planning to Support Post-COVID-19 Aviation Recovery

That, considering the dramatically different operating environment, States urgently review and update their National Air Navigation Plans (NANPs) in close coordination with Air Navigation Service Providers (ANSPs) and airspace users, to ensure that:

1. any new ANSP projects that entail cost to airspace users in terms of equipage, efficiency, mandates, etc. still have a positive cost-benefit to the air navigation system; and
2. current ANSP systems and procedures are reviewed to explore measures that can be taken to increase airspace user operating efficiencies (such as using 5NM horizontal surveillance-based separations within the applicable airspace); and
3. ANSPs are prepared in terms of capacity to manage increases in traffic from recovery policies or a change in the pandemic's status.

3. Outcomes from the ICAO Aviation-Public Health Experts' Roundtable - 4 November 2020

Presentation (5) by the Public Health Sub-Group Rapporteur: ICAO Aviation-Public Health Experts' Roundtable

3.1. The Roundtable themed “*Future of Aviation: Facing the New Normal with COVID-19*” was organized following the ACCRPG/6 held on 28 August 2020 which recommended ICAO to convene a special “Roundtable” to assist States to exchange views, bridge understanding and build consensus on aviation public health-related measures in the APAC region. Over 200 participants attended which included national public health professionals and Ministries and aviation sector representatives from aviation Ministries, CAAs, airports, airlines and International Organizations.

3.2. Delivering the Opening Remarks, Dr Fang Liu, Secretary General of ICAO reminded the audience of the dire effects of COVID-19 on airport and airline financial viability which may result in a far less connected post-pandemic world. The regions with higher levels of intra-regional traffic such as APAC will recover more quickly as shown by ICAO traffic data, she highlighted. Such positive indicators could leverage Public Health Corridors or other near-term travel bubble solutions to further enhance public confidence in air travel, noted the Secretary General. Aviation will rely on Public Health authorities to help determine a prudent balance between testing and quarantine requirements. She pointed to the CART Phase II's updated guidance and upcoming Manual on Testing and Cross Border Risk Management Measures which aim to help countries assess testing options as a means to alleviate quarantine measures where possible. Dr Babatunde Olowokure, Director of Health Security and Emergencies (DSE), WHO also made brief remarks at the opening.

3.3. Twenty public health and aviation experts from 9 APAC States (Australia, China, India, Japan, Malaysia, Republic of Korea, Singapore, Sri Lanka and Thailand) participated as panellists in the roundtable which was moderated by Professor Teo Yik Ying, Dean of Saw Swee Hock School of Public Health, National University of Singapore. While Professor Teo set the scene for the discussion with an introductory presentation, Professor David Heymann, Chair of the WHO Strategic and Technical Advisory Group for Infectious Hazards shared on the importance of a standardised risk assessment in facilitating safe travel.

3.4. The roundtable consisted two segments, viz. ‘*Examining strategies to recover air travel*’ which discussed to identify strategies for safe and gradual resumption of international air travel (particularly for mass tourism), without the vaccine being available in scalable manner and ‘*Enhancing Mutual trust*’, which discussed ways to establish building blocks for enhanced trust and mutual respect across countries for a globally harmonized accreditation system for testing capacity.

3.5. The panel discussion converged on the relevance of commonly agreed risk assessment framework focused on both equal risk levels and equal response capacity as an enabler to build the trust between States for travel resumption.

- a) Key issues surfaced by speakers:
 - Impediments to air travel recovery
 - Potential resurgence of community transmission with expansion of border re-openings
 - Operational complexities of air bubble and transit arrangements
 - Testing capacity

- b) Convergence towards key guiding principles:
- A robust and agile risk assessment framework (harmonised approach)
 - A nuanced and risk calibrated approach (leverage on mitigating measures)
 - Alignment between CAA and PHAs (communication; coordination)
 - Adopting a scientific and evidence-based approach
 - Local public health measures (capacity; processes; responsiveness)
 - A harmonised data collection and sharing framework (transparency; trust)

3.6. Overall, the Roundtable discussion was beneficial in promoting a better understanding of the various considerations and concerns of various Aviation and PH experts in re-opening borders, especially the perspectives of PH experts. Participants were able to hear various approaches adopted by States, which would serve as motivators at national level discussions. The Roundtable was a stepping stone for further dialogue and engagements between CAAs and PHAs, thus all participants and their respective Organizations are encouraged to take the conversation further.

3.7. The Final Report has been compiled and will be disseminated to the participants to be used to provide policy and strategic inputs to the respective States. 4. Update on CART Developments

Presentation (6) by the Secretariat: *Review of Council Aviation Recovery Task Force (CART) Phase II deliverables*

4.1. The deliverables of CART II have been structured in two main documents: a) the High-Level Cover Document (HLCD), and b) the second edition of the Take Off Guidance Document (TOGD), which includes the ICAO Manual on Testing and Cross Border Risk Management Measures.

4.2. The HLCD, while recognizing the sovereignty and authority of States over their national recover, introduces three new recommendations, supplementing the eleven recommendations contained in the CART Report disseminated in June 2020. These additional three recommendations accompany the new and updated guidance introduced in the TOGD related to a) aviation safety-related measures, b) testing and cross border risk management measures, and c) Public Health Corridors (PHCs).

4.3. States are strongly encouraged to collaborate with each other to establish Public Health Corridors. To facilitate implementation of PHCs, the ICAO i-PACK “Establishing a Public Health Corridor” is available to States.

4.4. For technical guidance on the assessment and development of States’ overall risk management strategy, including the possible use of testing and the establishment of PHCs, the TOGD directs to the ICAO Manual on Testing and Cross-Border Risk Management Measures. The Manual includes, a Risk Management Framework with a decision-making tool to determine the risk of transporting potentially infectious passengers and advice on factors States could consider should they elect to implement testing.

4.5. In addition to updating Modules related to all aspects of operations in airports, aircraft, crew and cargo, the TOGD introduces new references to risk mitigation measures applicable to aviation sectors other than commercial air transport such as air traffic control, and general and business aviation.

4.6. In conclusion, the ACCRPG agreed to:

- a) adopt the presented CART II HLCD, including the three additional recommendations, and the second edition of the TOGD;
- b) instruct the APAC Member States to publicize and disseminate both documents and the Manual on Testing and Cross-Border Risk Management Measures to as wide an audience as possible; and
- c) Support the continuation of CART, in anticipation of upcoming developments, including testing and vaccines and associated challenges such as the efficient transport of vaccines by air.

4.8. To support States in implementing the measures and recommendations contained in the ICAO CART Report, and to help monitor progress of implementation by States, ICAO created the (online) COVID-19 Response and Recovery Implementation Centre (CRRIC).

4.9. Only two (2) APAC States are yet to nominate a CRRIC Focal Point: Democratic Peoples' Republic of Korea and Palau.

4.10. The CRRIC State Activity Status dashboard indicated that the recent level of activity of APAC States on the CRRIC compared to other ICAO regions, has progressed noticeably post-ACCRPG7, following a strong outreach effort by the ICAO APAC Office.

- CRRIC Focal Points nominated: APAC 95%;
- CART Recommendation Gap Analysis fully reviewed: APAC 64%;
- Public Health Risk Mitigation Measures reviewed: APAC 36%;
- Active on CRRIC in last 7-days: APAC 28%.

4.11. Post-meeting note on Action Required: With the addition of the three (3) new recommendations [CART Recommendation 12, 13 and 14], following the publication of CART Phase II, States are invited to report level of implementation for those 3 new recommendations on the COVID-19 Response and Recovery Implementation Centre (CRRIC) by 13 December 2020.
