ASSISTANCE REQUIREMENT FOR ICAO APAC STATES WITH LOW AGA EI

(Presented by COSCAP-SA)

SUMMARY

This Working Paper is based on Survey Questionnaire for States in APAC Region with low AGA EI score (i.e., below 75%) and to establish the requirements for assistance in enhancing their EI scores.


This paper establishes correlation between survey outcome vis-à-vis USOAP-CMA audit findings, for Critical Elements CE-3, CE-4 and CE-5.

1. INTRODUCTION


- 1.1 With reference to AP-AA/WG Task 1/1, India, Bangladesh, Nepal and Thailand were assigned the task to prepare a survey questionnaire for States in APAC Region which have not completed certification for all international aerodromes, having an AGA EI score less than 75% and/or have Air Navigation Deficiencies, and to establish the requirements for assistance in enhancing the EI scores in needy States.
- 1.2 The draft questionnaire based on ICAO USOAP Critical Elements (CE) was prepared and presented during the Second Meeting of the Asia/Pacific Aerodrome Assistance Working Group (AP-AA/WG/2, Bangkok, Thailand, 27 to 30 January 2020) as AP-AA/WG/2-WP/08. The draft questionnaire was approved by the Forth Meeting of APANPIRG Aerodrome Operations and Planning Subgroup (AOP/SG/4) and circulated to APAC States/Administrations for gathering required data/information.
- 1.3 The survey questionnaire was sent out to 40 States in APAC Region including United States, and 2 Special Administration Regions of China, Hong Kong and Macao. Till 09 March 2022 only 18 APAC States/Administrations responded to the survey questionnaire. The percentage of States/Administrations responding to survey questionnaire was merely 45%.

2. DISCUSSION

2.1 The results of the survey indicated that only 50% States have EI in AGA area greater than 75%. The States with 60% -75% AGA EI are 22% and 28% States have less than 60% score. Therefore 50% of States have to enhance their EI scores in order to meet the GASP 2022 target of 75%.





2.2 The overall responses from the States against all Critical Elements CE-1 to CE-8 are presented in figure-2. The results show most of the responses of questionnaires by the States are 'Yes' except few 'No' responses in CE-3, CE-4, CE-5, CE-6 and CE-8.




2.3 However, during an assistance mission to States under COSCAP-SA project, the AGA PQs were analyzed for understanding the trend and it was observed that identical challenges were encountered by all the eight States in the areas of CE-3, CE-4 and CE-5. In order to understand the status of AGA CE-3, CE-4 and CE-5 in other States, the same analysis was extended to the other COSCAP regions and similar trends and challenges were registered for most of the States, particularly in COSCAP-SEA Region.

2.4 The survey responses received from 18 countries against CE-3, CE-4 and CE-5 can be assessed from the bar-chart given in Fig-3, Fig-4 and Fig-5 respectively.







2.5 The analysis of PQs pertaining to CE-3, CE-4 and CE-5 from USOAP-CMA for APAC states reveal status contrary to the responses registered on the survey questionnaire by 18 countries. The table showing common area where assistance may be required is appended below: (*Satisfactory*: **Sat**; *Not-satisfactory*: **Un-Sat**; *Not assessed*: **N-As**; *Not Applicable*: **N/a**)
