#### APAC AIG STANDING AND ANNUAL WORK PROGRAMME

(Presented by APAC-AIG Chairperson)

#### **SUMMARY**

Asia Pacific – Regional Aviation Safety Plan 2020-2022 (AP-RASP 20-22) version was adopted by RASG-APAC in February 2020 for the implementation by all the stakeholders through a collaborative approach.

Based on the action item by Decision APRAST 16/4, APAC RO circulated a State Letter; REF.: T 6/8.1.2 – AP089/21 (FS) dated 10 May 2021 inviting nominations of experts to work in Action Item Groups as Champions, Leaders and Members. However, ORG Action Item Groups still may require continued nominations to reinforce the groups and support the progress in achieving timelines.

Further, AP-RASP Road Map has Six Action Items, indicated below in Paragraph 2.3 of this Paper, that requires attention of the meeting, as APAC AIG has been identified as a Stake Holder of AP-RASP 20-22.

Supporting implementation of AP-RASP, proposed Action by the meeting is in paragraph 3.0 below.

#### 1. INTRODUCTION

- 1.1 Implementation of the all-important safety plan for Asia and Pacific Region popularly known as **AP-RASP**, and its current version 20-22, has been commenced no sooner it has been endorsed and published in ICAO RASG-APAC website in early 2020.
- 1.2 Next version of AP-RASP 23-25 is also being drafted, aligning towards the latest version of GASP 23-25 of ICAO and would be submitted to RASG-APAC/12 for endorsement in next week by the Ad-Hock Working Group appointed for the purpose.
- 1.3 AP-RASP Road Map has identified various Action Items (AIs) that is considered as necessary for the improvement of Safety through a collection of SEIs mainly in two streams of Actions; OPS and ORG Safety Enhancement Initiatives (SEIs). Implementation of the OPS SEIs have already been entrusted traditionally to SEI WG of APRAST whereas ORG SEIs have been further cascaded down to Action Items (AIs) and entrusted to smaller Groups. In addition, identification of some of the Action Custodians/Leaders have been entrusted to APRAST for further clarifications. Moving it

forward, based on a Working Paper submitted by Secretariat, APRAST decided and followed with a circulation of a State Letter inviting States/Administrations, Industry partners to nominate Champions, Leaders and members for all of the concerned AIs.

- 1.4 In response, Secretariat received fourteen (14) experts nominations from States/Administrations and two (02) from Industry partners after which a consolidation of the groups and working on AIs by the Groups essentially meeting the timelines commenced.
- 1.5 For the enhanced understanding, some essential definitions are depicted below as an excerpt from AP-RASP 20-22 Appendix A Road Map:

# APPENDIX A. AP-RASP 2020-2022 EDITION ROADMAPS The AP-RASP Org and Ops Roadmaps are detailed in Tables 1-8. Each Roadmap covers the following points:

- a) Regional Goal. The APAC Regional Goals I-V support the APAC region's strategic approach to managing safety at the regional level.
- b) Target(s). Targets which serve to fulfil their respective Regional Goal, including the year(s) in which the respective Target is expected to be achieved.
- c) GASP SEI. Where the Actions stem from the SEIs in the GASP Roadmap, specific references are made for easier reference.
- d) Action. A description of the specific SEI or initiative, and the tasks required for its implementation. The Actions support the Targets of the Regional Goals.
- e) Action Custodian. Appointed by APRAST to lead the group of stakeholders identified to further develop specific details for implementation of the respective Action.
- f) **Timeline**. The year(s) in which the respective Action is expected to be implemented.
- g) Stakeholders. The entities/ stakeholders in the APAC region, to which the Actions is addressed.
- *h) Metrics.* A description of the specific Target, and the indicators required for performance measurement.
- 1.6 Attention may be drawn to above (g) Stake Holders, who shall have the right to formulate contributions to each Action Item through the Action Custodian. In the APAC Road Map, there are Six Action Items, which has APAC-AIG as Stake Holders.
