- 1.1 The Ninth Meeting of the Air Traffic Management Sub-Group (ATM/SG/9) of the Asia Pacific Air Navigation Planning and Implementation Regional Group (APANPIRG) was held by Video Teleconference (VTC) from 01 to 05 November 2021. The meeting was attended by 292 registered participants from 27 States, two Special Administrative Regions of China and six International and Air Traffic Management-related industry partner organizations.
