Introduction

- Amendment 1 to Annex 19 was adopted in March 2016 with a delayed applicability of November 2019.
- The Safety Management Panel (SMP) endorsed Amendment 2 to Annex 19 at SMP/5 held Q4 2021.
- Proposed changes to Annex 19 stem from a variety of sources, including;
 - a) terms of reference of the SMP;
 - b) collective experience of the SMP in implementing SSPs and SMSs; and
 - c) information collected through ICAO implementation support initiatives.



Proposals of interest to AvMed

- Based on lessons learned from COVID-19, new STD proposed to ensure the
 role of CAAs is appropriately reflected in emergency response planning
 and crisis management at the State level to effectively address the impacts
 to and from aviation, for the management of aviation safety.
- Note aimed at States and service providers, highlighting the importance of considering the impact on aviation safety from risk management strategies implemented in other domains (for example, security, facilitation, economics and environment) and vice versa



Proposals of interest to AvMed

- Proposed amendments to support the implementation of the SMS framework
- New STD to support the identification of interfaces
- New STD to ensure products and services that have an impact on safety are covered by the SMS
- Existing STD amended to further emphasize the need to identify hazards across interfaces



Proposals of interest to AvMed

- New Note highlighting <u>human performance considerations</u> are implicit in the establishment and management of an SSP and in the assessment and monitoring of a safety management system (SMS).
- New Note highlighting <u>human performance considerations</u> are implicit in the establishment and management of an SMS.
- References to Manual on Human Performance (HP) for Regulators (Doc 10151).





 Proposal to develop guidance describing the importance of mental and physical health and wellbeing of staff to improve human and system performance.






Other areas of collaboration between SM Unit and AvMed
