I have the honor to invite your State/Administration to participate in the Ninth Meeting of the Performance Based Navigation Implementation Coordination Group (**PBNICG/9**) to be held through video conference from **22 to 24 March 2022**. To ensure effectiveness and efficiency of conducting the meeting through video conference, the draft agenda is focused on the core business of the meeting.

The PBNICG has the primary aim to support, harmonize and prioritize the implementation of PBN. As PBN implementation in the region is still lagging behind the target, this meeting will discuss the following in order to accelerate PBN Implementation in the region:
