ICAO APAC WEBINARS: IMPLEMENTATION OF CRV

SUMMARY

This paper presents the ICAO APAC proposed webinar on **Implementation of CRV** to be held on **29 June 2022** via Video Tele-Conferencing (VTC).

1. INTRODUCTION

1.1 In 2021, ICAO APAC office had organized a series of webinars. The webinars primary objective were to increase participants' awareness and understanding of the ICAO requirements needed to support regional planning and implementation activities, including implementation of Regional Aviation Safety Plan 20-22, the Asia/Pacific Seamless ANS Plan, and the Beijing Declaration.

1.2 The series of webinars included ICAO APAC Regional Cybersecurity webinar on 14 June 2021, SWIM workshop on 6-7 July 2021, Webinar on Implementation of CRV in APAC region on 20 July 2021, and Webinar on Implementation of ADS-B on 1 September 2021, which were related to CNS. The webinars were highly appreciated by member states by participating in high numbers and by providing positive feedbacks. One of the feedbacks was to request to ICAO APAC office to organise such webinars in 2022.

1.3 In last year, the ICAO Asia Pacific Implementation of CRV Webinar was held on 20 July 2021. The webinar was organised via Video Tele-Conferencing (VTC) using Microsoft Teams.

1.4 The Webinar was attended by **121** participants from **18** States/Administrations, **2** airlines industries and a telecommunication provider from Australia, Bangladesh, Bhutan, China, Hong Kong China, Fiji, India, Indonesia, Malaysia, New Zealand, Pakistan, Philippines, Republic of Korea, Singapore, Sri Lanka, Thailand, USA, Viet Nam, All Nippon Airways, Korean Air, PCCW and ICAO. 2. DISCUSSION**Webinars/Workshops in 2021**

2.1. ICAO APAC office issued a state letter with Ref: RSO - AP 056/21 (RSO) dated 7 April 2021 on the subject ICAO APAC Webinars 2021 (*May 2021- November 2021*). The state letter mentioned a series of **18 webinars** being organised by ICAO APAC office on various topics which includes but not limited to CNS, ATM, MET, Environment, Aviation Safety, Airport Operations, etc. The series of webinars included ICAO APAC Regional Cybersecurity webinar on 14 June 2021, SWIM workshop on 6-7 July 2021, Webinar on Implementation of CRV in APAC region on 20 July 2021, and Webinar on Implementation of ADS-B on 1 September 2021.

2.2. The ICAO APAC Webinar on **Implementation of CRV in APAC region** was successfully conducted on **20 July 2021**. The objectives of the Webinar were to share a brief introduction, concepts, and regional activities of Asia Pacific Common Regional Virtual Private Network (CRV) along with the progress of implementation of CRV in APAC region. Concluding message was to urge non-implemented States to implement CRV and to request the support of CRV implemented States by sharing lessons learned and/or best practices.

2.3. Total **Four** (4) presentations were delivered by CRV experts from New Zealand, Fiji, USA, and Hong Kong, China. During the Webinar, Questions and Answers (Q & A) sessions were held at end of each presentation through the Pigeonhole tool. Throughout the Webinar, a total of **40 questions** were asked and *more than 15 feedbacks* for the Webinar were provided by Participants with **100% positive response**.

2.4. Based on Q&A sessions and submitted survey responses from Member States, the need for potential discussion with PCCWG for extension of CRV Implementation deadline beyond the end of 2022 due to COVID-19 crisis as it is continued in 2021, the need for flexibilities in the package options selection by Member States, and the need for a platform for sharing lessons learnt and best practices based on experiences by Member States, which are using CRV, were felt. ICAO Secretariat took necessary action about these discussion in CRV OG.

Webinars/Workshops in 2022

2.1 In 2021, ICAO APAC office proposed to organise **3 days face-to-face workshop** on Cybersecurity in 2022. However, due to the uncertainty caused by the COVID-19 pandemic even in 2022, all face-to-face meetings and other face-to-face events would be kept on hold until situation gets normal and allows people to travel.

2.2 ICAO APAC Office organised **Mode S Workshop** on **22 March 2022** via **Video Tele Conferencing (VTC)**. The workshop was organised along with Fifth Meeting of Mode S Downlinked Aircraft Parameters Working Group (Mode S DAPs WG/5) held on 23-25 March 2022 by VTC.

2.3 ICAO APAC office has planned a webinar on **Implementation of CRV** on **29th June 2022** to facilitate better usage and understanding of the CRV OG Operations Manual and other important information required for implementation of CRV in APAC region. The detailed agenda and program for the webinar is provided in **Appendix A** to the paper.

2.4 ICAO APAC Office has planned for other webinars to be done in the year 2022 in CNS and other domains. The information about all webinars was shared by the State Letter **Ref: O 7/1 - AP 059/22** dated **28 March 2022**. The list included total **14 number of webinars** on various subjects. The State Letter included the other information about all webinars in addition to the ICAO APAC CRV

Webinar and necessary guidelines for registration to the webinar. The State Letter and its attachments are provided in **Appendix B** to this paper.

2.4 Member States/administration are encouraged to take advantage of above mentioned virtual events by participating and contributing for the webinars/workshops.


