In order to make the meeting more productive and effective, participating Administrations/International Organizations are urged to submit papers and presentations to the meeting **no later than three weeks prior to the meeting date**, via email to the Regional Office. A working paper/information paper template is available from the ATM/SG/11 web page on the ICAO Regional Office website. In the event that papers are received after **Friday 08 September 2023** they will normally be treated as flimsies, and may only be presented to the meeting if time permits and after all other papers correctly submitted before the deadline have been read.

Your Administration is also reminded of *Conclusion ATM/SG/10-1*, which urged Asia/Pacific Administrations to report their implementation status of the performance expectations of the following regional plans, at least once annually, by **not later than 28 February each year**:

- a) Regional ATM Contingency Plan;
- b) Regional Framework for Collaborative ATFM;
- c) Regional Plan for Collaborative AIM; and
- d) Regional SAR Plan.

Status reports provided to the ICAO Regional Office will be reported to ATM/SG/11. As 2023 is the first year of the revised reporting date, late status reports received by not later than **Friday 08 September 2023** may be included in the relevant Secretariat Working Paper. The ATM Regional Plans' Monitoring and Reporting Forms are available in MS Excel format on the ICAO Asia/Pacific Regional Office eDocuments web page at: https://www.icao.int/APAC/Pages/edocs.aspx.

Administrations currently having ATM-related APANPIRG ATM and Airspace Safety Deficiencies recorded are encouraged to provide information on corrective actions taken, for update of the Deficiencies List. In this regard I also take this opportunity to remind your Administration of Conclusion APANPIRG/33/14 – Update of Information in APANPIRG Air Navigation Deficiencies Reporting Form.
