I wish to invite your Administration/Organization to attend the ICAO Aviation Data and Analysis Seminar hosted by the ICAO Asia and Pacific Office in Bangkok, Thailand, from 13 to 15 December 2023.

ICAO has developed advanced dashboards for Member States and aviation stakeholders to monitor and assess key trends in air transport. These tools encompass a wide array of analytics ranging from operations to financials, including evolution of passenger and cargo traffic, aircraft fleet usage, traffic by Flight Information Region (FIR), and revenue impact on airlines, airports and air navigation services providers (ANSPs).

The objective of the Seminar is to bring together all stakeholders (Regulators, Air Navigation Service Providers - ANSPs, Aerodrome Operators, Aircraft Operators, International Organizations and Industry) to review the current situation and trends of aviation in the APAC Region. It will also focus on the latest ICAO big data analysis in aviation and forecasting techniques, as well as the progress in the area of a global aviation competitiveness index. The use of civil aviation data analysis for planning and decision making in ICAO, national administrations, airlines, airports and ANSPs will also be addressed.

Presentations will include the latest applications in data and analytics that are used for efficient decision making by different aviation stakeholders. A number of discussion panels will be held to address interesting subjects, such as information systems to improve airline efficiency, economics of airports and ANSPs.

During this three-day event, a simultaneous exhibition will be held on-site to showcase various products related to the subject matter and speaking slots are available in the form of sponsorship in addition to the possibility of sponsoring the refreshment breaks.
