I wish to invite your State/Administration to participate in the Eleventh Meeting of the Aeronautical Communication Services Implementation Coordination Group (ACSICG/11) of APANPIRG to be held from 19 to 22 March 2024 in ICAO APAC Regional Office, Bangkok, Thailand.

The Objective of the Meeting is to progress the implementation of aeronautical communications infrastructure and services in the Asia and Pacific Regions. The ACSICG/11 is expected to review the progress of the CRV project, the AMHS/ATN and AIDC implementation status, deliberate on routing issues, transition strategy from AMHS to SWIM, Inter-regional AFS connection, AFS related cybersecurity issue, AMS and Datalink communication, and a joint session with Meteorological Information Exchange Working Group of APANPIRG (MET/IE/WG) to further promote the IWXXM transportation over AMHS.
