SUMMARY

This paper provides APAC average AGA EI scores derived from the USOAP – CMA online framework and USOAP CMA Audit common findings in AGA area.

1. INTRODUCTION

1.1 The USOAP CMA aimed at assessing Contracting States' capabilities to ensure an effective oversight of the aviation systems through the implementation of the eight critical elements of a safety oversight system. These critical elements include in particular:

The "Establishment CEs":

Critical Element (CE) 1 – Primary aviation legislation

Critical Element (CE) 2 – Specific operating regulations

Critical Element (CE) 3 – State system and functions

Critical Element (CE) 4 – Qualified technical personnel

Critical Element (CE) 5 – Technical guidance, tools and provision of safety-critical information

The "Implementation CEs":

Critical Element (CE) 6 – Licensing, certification, authorization and approval obligations

Critical Element (CE) 7 – Surveillance obligations

Critical Element (CE) 8 – Resolution of safety issues

- 1.2 The USOAP CMA focused on eight audit areas as follows:
 - 1) Primary aviation legislation and specific operating regulations (LEG);
 - 2) Civil aviation organization (ORG);
 - 3) Personnel licensing and training (PEL);
 - 4) Aircraft operations (OPS);
 - 5) Airworthiness of aircraft (AIR);

- 6) Aircraft accident and incident investigation (AIG);
- 7) Air navigation services (ANS); and
- 8) Aerodromes and ground aids (AGA)
- 1.3 ICAO launched the third edition of the Safety Oversight Manual (Doc 9734), Part A

 The Establishment and Management of a State Safety Oversight System. It is expected that this manual will assist States in establishing and implementing their safety oversight systems.
- 1.4 The *Universal Safety Oversight Audit Programme Continuous Monitoring Manual (Doc 9735)* provides detailed information about USOAP CMA, specifically the policy, procedures and guidance on the management and conduct of programme activities under the CMA. The Doc 9735 is available at https://soa.icao.int/USOAPLibrary/Library.aspx.

2. DISCUSSION

ICAO USOAP CMA activities in APAC States in 2023

- The USOAP CMA Activity Plan, which is issued as an Electronic Bulletin and posted on ICAO-NET twice a year, lists the scheduled USOAP CMA activities and can be accessed at ICAO secure portal (https://soa.icao.int/USOAPLibrary/Library.aspx). ICAO Electronic Bulletins (EBs) 2024/2 and 24/12 dated 26 January 2024 and 4 July 2024 are provided in **Attachments A & B** respectively.
- 2.2 States are selected for CMA audits and ICVMs based on various factors, including risk indicators, previous audit results, deferrals, the level of activities in the State and progress made by States in resolving identified deficiencies. ICAO also conducts ICVMs for States with a Significant Safety Concern (SSC), once sufficient information is received indicating that the SSC has been resolved.
- 2.3 Each year, ICAO also carries out a number of off-site validation activities for States which have satisfactorily addressed certain findings (mostly related to Critical Elements 1 to 5) in the relevant audit areas.
- 2.4 In 2023, two CMA audits (including 1 focused audit), one ICVM and one SSPIA were conducted in APAC States:

- ICAO conducted the USOAP CMA Workshop for Asia and Pacific States from 30 2.6 April to 02 May 2024 in APAC Office, Bangkok, Thailand. Over 150 participants, comprising 84 onsite and over 80 online participants attended the workshop, representing 24 APAC Member States.

- 2.10 It is noted that there is still a lower EI score (APAC average AGA EI and its corresponding CEs) for June 2024 compared to EI data for June 2021 despite of improvement in EI by some States that had received CMA activities (Audit, ICVM and Offsite Validation) since 2021. This could be primarily due to adjustment of the EI because of the reduction of AGA PQs from 168 (2017 AGA PQs) to 143 (2020 AGA PQs) numbers (please refer to AOP/SG/8-IP/05 for USOAP CMA Protocol Questions 2020 Edition).
- 2.11 EIs in AGA Area derived from iSTARS4 USOAP Data Table for Asia and Pacific States are provided in **Attachment C** to this Working Paper.
- 2.12 There are 15 APAC States with AGA EI Scores more than or equal to 75% as shown in the Table 5 below.

- 2.15 As per above analysis conducted by ICAO APAC Office, it was revealed the following results:
 - 1) **19** APAC States have their EI in AGA area less than 60%;
 - 5 APAC States have their EI in AGA area more than 60% to less than 75%; and
 - 3) **15** States have their EI in AGA area more than or equal to 75%

Therefore, 24 States with EI less than 75% would require more resources and efforts to enhance their EI and meet the 75% EI target by 2024 as set forth in the ICAO Global Aviation Safety Plan (GASP) 2023-2025 (Doc 10004).

USOAP Findings in AGA area

- 2.16 The most common findings in AGA area are related to:
 - <u>outdated primary aviation legislation</u> [CE-1] not reflecting the current civil aviation situation or not establishing a civil aviation authority with the necessary human resources and vested with necessary powers, including for issuing, suspending or cancelling aerodrome certificates;
 - <u>the absence of specific operating regulations</u> [CE-2] transposing into national standards from Annex 14 provisions and prescribing the conditions and criteria for the certification of aerodromes;
 - <u>the lack of dedicated entity within the CAA</u> [CE-3] tasked with aerodrome regulation and certification, or when this entity exists, inadequate technical staff due to difficulties in attracting and retaining qualified personnel and/or of inadequate technical staff job descriptions not covering all the fields of expertise required for aerodrome certification and continuing surveillance;
 - the lack of training programme taking account of technical staff training requirements [CE-4] and defining the various training activities required to access the various levels of aerodrome inspector functions;
 - <u>the lack of guidance material</u> [CE-5] intended for aerodrome operators as well as for regulatory technical staff, including the lack of an approved process describing the various steps for the certification of an aerodrome and up-to-date ICAO documentation;
 - the lack of an aerodrome inspector's handbook with methodology and procedures for initial audit and continuing surveillance, including checklists in the various disciplines [CE-5] to assist in the conduct of office review of aerodrome manuals and on-site aerodrome inspections;
 - <u>the lack of implementation of aerodrome certification and safety</u> <u>management requirements</u> and publication of status of certification of aerodromes in the AIP [CE-6];
 - <u>the lack of policy and procedures for accepting non-compliance</u> with established requirements, including risk assessment mechanism and notification procedures [CE-6];
 - the lack of surveillance programme and plan for continuing surveillance of certified aerodromes [CE-7] and a methodology to address safety concerns identified during surveillance inspections, and enforcement procedures [CE-8].

State's Actions on USOAP CMA On-line Framework (OLF)

- 2.17 The following actions are required from States through USOAP CMA OLF:
 - a) continuous update of the compliance checklist/EFOD and SAAQ;
 - b) submission of the Corrective Action Plans (CAPs) on the USOAP CMA OLF, and inform the ICAO Regional Office when complete and ready for review; and

c) implementation of the CAPs and complete the self-assessment of the PQs on the OLF, including uploading the evidence documents, to report the progress on the OLF, and inform the ICAO Regional Office when complete and ready for validation.

3. ACTION BY THE MEETING

- 3.1 The Meeting is invited to note the information contained in this paper and:
 - a) urge States/Administrations to take action in accordance with Paragraph 2.17;
 - b) urge States with EI less than 75% to put more resources and efforts to improve EI to meet the 75% of GASP target by 2024; and
 - c) encourage States to approach respective COSCAPs, Pacific Aviation Safety Office (PASO) or ICAO APAC Office if State(s) require assistance in their preparation for USOAP CMA activity.

ICAO UNIVERSAL SAFETY OVERSIGHT AUDIT PROGRAMME — ACTIVITY PLAN

- 1. The International Civil Aviation Organization (ICAO) Universal Safety Oversight Audit Programme (USOAP) Activity Plan, published twice a year and posted on the USOAP Continuous Monitoring Approach (CMA) online framework (https://www.icao.int/usoap), lists the completed and planned CMA audits, ICAO Coordinated Validation Missions (ICVMs), State Safety Programme Implementation Assessments (SSPIAs), off-site validation activities and workshops for the past and current year (see Attachments A and B for details). The activity plan published in January constitutes an update to the activity plan published in June of the previous year. The 2024 activity plan was first published on 29 June 2023 through Electronic Bulletin (EB) 2023/29.
- 2. States are selected for CMA audits and ICVMs based on various factors, including risk indicators, previous audit results, deferrals, the level of activities in the State and progress made by States in resolving identified deficiencies. ICAO also conducts ICVMs for States with a Significant Safety Concern (SSC), once sufficient information is received indicating that the SSC has been resolved.
- 3. To support the USOAP CMA objectives, States are strongly urged to accept the dates of a scheduled USOAP activity and to refrain from making deferral requests. Any such requests shall be subject to the provisions of Article 14 of the Memorandum of Understanding (MOU) signed with ICAO regarding the USOAP CMA and of Chapter 3, 3.5.4 of ICAO Doc 9735 (5th Edition 2023).
- 4. Each year, ICAO also carries out a number of off-site validation activities for States which have satisfactorily addressed certain findings (mostly related to Critical Elements 1 to 5) in the relevant audit areas. Off-site validation activities completed in 2023 are shown in Attachment A.
- 5. In 2023, 15 CMA audits (including 3 focused audits) and 6 ICVMs were completed, along with one off-site validation activity and 3 SSPIAs.
- 6. For 2024, 20 USOAP CMA activities have been scheduled (excluding off-site validation activities): 17 CMA audits and 3 ICVMs. States interested in receiving a CMA activity (either on-site or off-site), including on a cost-recovery basis for on-site activities, are advised to contact the Deputy Director, Monitoring, Analysis and Coordination, Air Navigation Bureau by email at USOAPInbox@icao.int. Such requests will be considered based on various factors listed in paragraph 2 above, as well as available ICAO resources.

ICAO UNIVERSAL SAFETY OVERSIGHT AUDIT PROGRAMME — ACTIVITY PLAN

- 1. The International Civil Aviation Organization (ICAO) Universal Safety Oversight Audit Programme (USOAP) Activity Plan, published twice a year and posted on the USOAP Continuous Monitoring Approach (CMA) online framework (https://www.icao.int/usoap), lists the completed and planned CMA audits, ICAO Coordinated Validation Missions (ICVMs), off-site validation activities and workshops for the current and coming year (see Attachments A and B for details). A provisional activity plan for the coming year is published in June, followed by an updated version published in January of the following year.
- 2. States are selected for CMA audits and ICVMs based on various factors, including risk indicators, previous audit results, deferrals, the level of activities in the State and progress made by States in resolving identified deficiencies. ICAO also conducts ICVMs for States with a Significant Safety Concern (SSC), once sufficient information is received indicating that the SSC has been resolved.
- 3. To support the USOAP CMA objectives, States are strongly urged to accept the dates of a scheduled USOAP activity and to refrain from making deferral requests. Any such requests shall be subject to the provisions of Article 14 of the Memorandum of Understanding (MOU) signed with ICAO regarding the USOAP CMA and of Chapter 3, 3.5.4 of ICAO Doc 9735 (5th Edition 2023).
- 4. Each year, ICAO also carries out a number of off-site validation activities (including integrated validation activities) for States which have satisfactorily addressed certain findings in the relevant audit areas.
- 5. As of the end of June 2024, 8 CMA audits and 2 ICVMs were completed.
- 6. For 2025, 21 USOAP CMA activities have been scheduled: 18 CMA audits and 3 ICVMs. States interested in receiving a CMA activity (either on-site or off-site), including on a cost-recovery basis for on-site activities, are advised to contact the <u>Deputy Director, Monitoring, Analysis and Coordination, Air Navigation Bureau</u> by email at <u>USOAPInbox@icao.int</u>. Such requests will be considered based on various factors listed in paragraph 2 above, as well as available ICAO resources.
- 7. In the first half of 2024, 4 USOAP CMA workshops were conducted and 1 more is planned for the second half of the year. For 2025, 2 workshops have been tentatively scheduled.
