#### **APAC AIG ANNUAL WORK PROGRAMME 2024-2025**

(Presented by Secretariat)

#### **SUMMARY**

Asia Pacific – Regional Aviation Safety Plan 2020-2022 (AP-RASP 20-22) version was adopted by RASG-APAC in February 2020 for the implementation by all the stakeholders through a collaborative approach. The updated version of AP-RASP 2023-25 is published in July 2023.

Based on the action item by Decision APRAST 16/4, APAC RO circulated a State Letter; REF.: T 6/8.1.2 – AP089/21 (FS) dated 10 May 2021 inviting nominations of experts to work in Action Item Groups as Champions, Leaders and Members. However, ORG Action Item Groups still may require continued nominations to reinforce the groups and support the progress in achieving timelines.

Further, AP-RASP Road Map has Seven Action Items, indicated below in Paragraph 2.3 of this Paper that requires attention of the meeting, as APAC AIG has been identified as a Stake Holder of AP-RASP 2023-25.

Supporting implementation of AP-RASP, proposed Action by the meeting is in paragraph 3.0 below.

#### 1. INTRODUCTION

- 1.1 AP-RASP 2023-25 is already published in ICAO APAC Website aligning towards the latest version of GASP 2023-25 as approved by RASG-APAC/12 and a permanent Working Group is created where AP-RASP WG Co-Chair State and Industry is been also elected during APRAST/20. The AP-RASP WG shall work under APRAST, which will primarily revise the document and monitor implementation of AP-RASP Roadmap for each triennium.
- AP-RASP Road Map has identified various Action Items (AIs) that is considered as necessary for the improvement of Safety through a collection of SEIs mainly in two streams of Actions; OPS and ORG Safety Enhancement Initiatives (SEIs). Implementation of the OPS SEIs have already been entrusted traditionally to SEI WG of APRAST whereas ORG SEIs have been further cascaded down to Action Items (AIs) and entrusted to smaller Groups. In addition, identification of some of the Action Custodians/Leaders have been entrusted to APRAST for further clarifications. Moving it forward, based on a Working Paper submitted by Secretariat, APRAST decided and followed with a circulation of a State Letter inviting States/Administrations, Industry partners to nominate Champions, Leaders and members for all of the concerned AIs.

1.3 Attention may be drawn to above (g) Stake Holders, who shall have the right to formulate contributions to each Action Item through the Action Custodian. In the APAC Road Map, there are Seven Action Items, which has APAC-AIG as Stake Holders.

#### 2. DISCUSSION

- 2.1 Details of the Tasks are given in the Road Map of AP-RASP 2023-25 version. APAC AIG has the role to play for effective implementation of the AP-RASP 2023-2025 Org Roadmap in Appendix A addressing the Targets (T-7, T-10, T-16 and T-18) and Action Items (A.II.1/2025, AIII.1/2025, AIII.2/2025, A.V.1/2025, A.V.2/2025, A.V.3/2024 and A.V.7/2025).
- 2.2 Action items that requires attention of APAC-AIG as a Stake Holder and as intended by AP-RASP 2023-25; A.II.1/2025, AIII.1/2025, AIII.2/2025, A.V.1/2025, A.V.2/2025, A.V.3/2024 and A.V.7/2025.
- 2.3 The Above tasks were captured as the Yearly Work Programme 2023-24 and the same has to continue in 2024-25 to implement the AIG related AP-RASP Action Items in the ORG Roadmap.
