**PROGRESS UPDATE ON DEVELOPMENT OF
THE REGIONAL MONITORING AND REPORTING SCHEME
FOR A-CDM IMPLEMENTATION IN THE ASIA PACIFIC REGION**

SUMMARY

This paper provides a progress update on the development of the Regional Monitoring and Reporting Scheme for A-CDM Implementation in the Asia Pacific Region.

1. INTRODUCTION

1.1 During the ATFM/SG/13 meeting, the following conclusion was agreed:

1.1.1 It was proposed to develop an annual regional monitoring and reporting scheme for the elements of the Asia Pacific A-CDM Implementation Plan and the task to be undertaken by ATFM/IR/SWG.

1.1.2 The meeting agreed to the proposal. The Chair reminded the ATFM/IR/SWG members to include A-CDM experts in the ATFM/IR/SWG for this task. IATA suggested that Airport Council International (ACI) might also be included in this matter, which was agreed by the meeting.

1.2 Hong Kong China, as the rapporteur of ATFM/IR/SWG, drafted a monitoring and reporting scheme and held a kick-off meeting online on 19 March 2024 to initiate the discussions and gather suggestions among members of ATFM/IR/SWG.

2. DISCUSSION

Draft Monitoring and Reporting Scheme

2.1 In early March 2024, Hong Kong China shared a preliminary draft of the Monitoring and Reporting Scheme with members of ATFM/IR/SWG on various reporting items, metrics and results of response as part of the Regional A-CDM Monitoring and Reporting Scheme.

2.2 Members of ATFM/IR/SWG were then invited to join the kick-off meeting online on 19 March 2024. Representatives from the following member states/ organizations participated in the meeting:

2.2.1 ACI, Hong Kong China, IATA, Indonesia, Japan, Mongolia, New Zealand, Republic of Korea, Singapore and Thailand.

2.3 Participants were briefed on the background information required for the development of the proposed reporting and monitoring scheme and constructive comments were received. Subsequently, further comments and suggestions had been received from various parties after the meeting.

Roadmap for Development

2.4 Relevant feedback received will be consolidated for the refinement of the draft scheme which will be shared with members of the ATFM/IR/SWG in due course. It is planned to hold additional online meetings to discuss and iron out the details after the ATFM/SG/14. The target roll out date is Q1 2025.
