SUMMARY

This paper presents the outcomes of the Eighth Meeting of the APANPIRG Aerodrome Operations and Planning Subgroup (AOP/SG/8), relevant to the ATM/SG.

1. INTRODUCTION

1.1 The Eighth Meeting of the Aerodrome Operations and Planning Sub-Group (AOP/SG/8) was held in Bangkok, Thailand from 15 to 19 July 2024. The report of AOP/SG/8 is available at https://www.icao.int/APAC/Meetings/Pages/2024-AOP-SG-8.aspx.

2. DISCUSSION

Relevant Outcomes of ATM/SG/11, ATFM/SG/14, AAITF/19 and ICAO APAC/MID ATM Contingency Planning Workshop

2.1 AOP/SG/8 noted that AAITF/19 had agreed to the following Decision:

Decision AAITF/19-3: Establish APAC Common SWIM Aeronautical Information Services Ad hoc Group

That, AAITF establishes the APAC Common SWIM Aeronautical Information Services Ad hoc Group.

- 2.2 As airport operation-related information would need to be exchanged through SWIM, the AOP/SG/8 was invited to participate in the APAC Common SWIM Aeronautical Information Services Ad hoc Group to discuss the proposed business functionality of APAC Common SWIM Aeronautical Information Services by SWIM TF.
- 2.3 India expressed willingness to join the APAC Common SWIM Aeronautical Information Services Ad hoc Group, and they would get back to the Secretariat for final confirmation after consulting with the relevant Authority in India.

Publication of the Status of Certification of Aerodromes in AIP

2.4 States / Administrations that have yet to publish the status of certification of aerodromes in AIP AD 1.5 are provided in **Table 1**.

- 2.5 The following States have published the status of the Certification of Aerodromes in other Section of AD in AIP as below:
 - 1) Solomon Islands AD 1.1, 1.1.5
 - 2) US Territories (American Samoa, Guam and Norther Mariana Islands) AD 2.6.
- 2.6 States that have published the status of certification of aerodromes in other Sections of AD were encouraged to publish in AD 1.5 to align with the AIP template as recommended in *Appendix* 2 to PANS-AIM (Doc 10066).
- 2.7 Asia Pacific Regional Guidance on Aeronautical Information Publication AD 1.5 Status of Certification of Aerodromes approved by AOP/SG/4 (Video Teleconference, 10 13 November 2020) and published by ICAO Asia and Pacific Office, Bangkok on ICAO APAC Website eDocuments under AGA heading (https://www.icao.int/APAC/Pages/eDocs.aspx) may be referred by States/Administrations for this purpose.

Enhanced Global Reporting Format for Assessing and Reporting Runway Surface Conditions

- 2.8 AOP/SG/8 noted that 15 States had informed to ICAO APAC that they had implemented GRF in 2021; however, only 14 States from Asia and Pacific Regions have published procedures for assessment and reporting of runway condition report in AIP as of 22 March 2024.
- Annex 15 Aeronautical Information Services (AIS) requires that any permanent changes in the AIP shall be published as AIP Amendments (6.3.1.2 of Annex 15 refers). Therefore, the procedures for assessment and reporting of runway condition report and issuance of the new SNOWTAM format should also be published in national AIP. The most appropriate section for publication of above information in AIP could be "AD 1.2.2 Snow plan" (refer to Appendix 2 of PANS-AIM (Doc 10066)).
- 2.10 The list of the Asia Pacific States that have published procedures for assessment and reporting of runway condition report in AIP is depicted in the **Table 2** below:
