Subject: The Sixth Meeting of the Bay of Bengal Traffic Flow Review Group (BOBTFRG/6) (Bangkok, Thailand, 14 – 15 November 2024)

Sir/Madam,

I wish to invite your Administration to participate in the Sixth Meeting of the Bay of Bengal Traffic Flow Review Group (BOBTFRG/6, a Small Working Group established to undertake tasks on behalf of the South Asia-Indian Ocean Southeast Asia ATM Coordination Group – SAIOSEACG), which will be held in Bangkok, Thailand from 14 – 15 November 2024.

The BOBTFRG/6 meeting will address several priorities that have potential to enhance our collective airspace management efforts. These include the improvement and efficiency of FLAS in Bay of Bengal (BOB) Airspace, ensuring that our operations are optimized for safety and effectiveness.

This meeting will also focus on the reduction of longitudinal spacing, which is essential for improving traffic management and capacity and will delve into performance-based and distance-based separation minima to uphold the highest standards of safety and efficiency. The discussion on implementing 50 NM longitudinal separation with PBCS in BOB Airspace will explore the benefits of advanced communication and surveillance technologies.

Another key topic will be the implementation of RNP 4 (or RNP 2) routes in BOB Airspace, which is vital for enhancing route efficiency and safety. This meeting will also engage in other in-depth and technical discussions aimed at improving route efficiency, ultimately enhancing aircraft operations and expanding aviation capacity in the Bay of Bengal region.

Your participation in these comprehensive discussions is important to contribute to increasing the efficiency and safety of aircraft operations, while also expanding aviation capacity in the BOB region.

I have the honor to inform you that the ICAO Asia-Pacific Office will conduct the Second Free Route Airspace (FRA) Implementation Workshop in the Asia Pacific (APAC) Region, scheduled for **November 13th, 2024** (Wednesday). The workshop will be held at ICAO APAC Regional Office, Bangkok, Thailand. In light of the strong interest to last year's webinar and the demand expressed in subsequent meetings, ICAO recognized the need for a more interactive workshop format. This event will strategically align with the SCSTFRG/12 (November 11-12, Monday and Tuesday) and BOBTFRG/6 (November 14-15, Thursday and Friday) meetings, enhancing the efficiency of our collaborative efforts and maximizing travel economy for participants. This hybrid workshop would also be available for online participation.

Free Route Airspace (FRA) is transforming air traffic management across the globe, proving its worth through remarkable gains in operational efficiency and significant reductions in environmental impact. With Europe, North and South America, and parts of Africa already reaping the benefits of FRA, the Asia-Pacific region is also moving in the same direction. Following a successful pilot project for Free Route Operations/User Preferred Routes between cities in Southeast Asia and Oceania, the APAC region is on the brink of leading in a new era of advanced FRA initiatives.

This workshop will be a good resource for navigating the complexities of airspace design under FRA, employing tools and simulations, enhancing coordination among ATC centers, tackling cross-border issues, and understanding training requirements for both ATC and airline operators.

This workshop will be an opportunity for collaboration and learning, designed to equip participants with the knowledge and skills needed for FRA, leveraging it to enhance airspace efficiency and sustainability across the APAC skies..
