PROGRAMME PROGRESS REPORT

(Presented by the COSCAP-SEA Secretariat)

EXECUTIVE SUMMARY

This paper presents the progress achieved in implementing the COSCAP-SEA Programme activities for the period from April 2021 to March 2024.

Action: The Steering Committee is invited to review and comment on the progress achieved during the reporting period.

1. **INTRODUCTION**

- 1.1 This paper presents the progress achieved in implementing the COSCAP-SEA Programme activities during the period from April 2021 (after latest SCM/20) to March 2024.
- 1.2 Since April 2020, the implementation of the COSCAP-SEA Programme activities has been impacted by the travel restrictions due to the COVID-19 pandemic. To ensure the continuity of the COSCAP-SEA activities, coordination was achieved with all partners and several activities were delivered using virtual platforms. However, on-site technical missions outside Thailand could not be performed until early January 2022 and thereafter 5 on-site Technical Assistance to Singapore, Cambodia, Timor-Leste, Viet Nam and Philippines were completed respectively, 2 hybrid trainings in Thailand, and 1 on-site training in Singapore.
- 1.3 During the vacancy of the COSCAP-SEA Chief Technical Advisor and Programme Coordinator (CTA/PC) position, from May 2022 to July 2023, the APAC Regional Office of ICAO appointed one of its officers as acting CTA/PC for ensuring continuation of the programme. The new CTA/PC joined the programme on 26th July 2024.

2. **DISCUSSION**

- 2.1 The COSCAP-SEA Programme activities are based on the Programme Document objectives, State Assistance Needs Survey, and the Annual Work Plan approved during the annual Steering Committee Meeting and updated periodically with the approval of the Chairperson.
- 2.2 The Work Plan was implemented in coordination with the ICAO APAC RO, other APAC COSCAPs, ICAO ANB/TCB/GAT, and COSCAP-SEA partner States, International Organizations, and Industry.
- 2.3 The Programme objective is to enhance the safety and efficiency of air transport in the COSCAP-SEA Member States through coordination, assistance and harmonization efforts aiming to strengthen States' safety oversight and safety management capabilities, and their compliance with the applicable ICAO provisions in an effective, sustainable, and resilient manner. This is implemented through a State-cantered, risk-based, and result-oriented approach following seven strategic priorities, which are in line with ICAO's global and regional priorities:
 - > SP1 Identifying and mitigating potential immediate risks for safety,
 - > SP2 Effectively fulfilling the State's certification/licensing/approval, surveillance, and enforcement responsibilities,
 - > SP3 Identifying and mitigating key emerging risks as well as specific risks related to the COVID-19 pandemic,
 - > SP4 Enhancing the State safety oversight system in an effective, sustainable, and resilient manner,
 - > SP5 Ensuring the establishment and implementation of an independent and effective accident and serious incident investigation system in each State,
 - > SP6 Establishing and implementing effective safety data collection and processing systems, and
 - > SP7 Continuously progressing SSP implementation.
- 2.4 The COSCAP-SEA meetings, missions and training events completed since April 2021, are presented in Appendices A and B with reference to the corresponding Programme Objectives. A summary of the description of the activities completed is presented in Appendix C. A summary of the number of participants of each State attending the training events is presented in Appendix D.
- 2.5 **Appendix A** contains a copy of the approved 2021/2022 Annual Work Plan (last updated on 25 March 2022) for reference. **Appendix B** contains the programme progress summary report, covering activities in the reporting period i.e., up to march 2024. **Appendix C** contains details on the participation of Member States to COSCAP-SEA capacity building activities for the period up to March 2024
- 2.6 In the reporting period, COSCAP-SEA conducted 6 on-site technical assistance missions in a total of 6 member States. In addition, COSCAP-SEA provided 50 training activities to 2,294 participants in both on-site and virtual classroom delivery mode with the valuable support of the DGAC France, FAA, UK CAA, EASA, IATA, Airbus and Boeing.
- 2.7 During 19th Steering Committee Meeting held in November 2019, States agreed to extend the Programme beyond its Phase IV for another 5 years. During 20th Steering Committee virtual Meeting held in March 2021, Secretariate presented WP-4 on transition of COSCAP-SEA Programme to its Phase V and proposed Revision F of the Programme Document. In accordance with Conclusion 20/5 (2); all member States have already signed the final version of the Programme Document for Phase V (Revision F), which covers the five-year period from July 2021 to June 2026.
- 2.8 In order to initiate the activities, with the suggestion of the Team-Leader-SEARAST, an Interim SERAST was held on 27th March 2024. The virtual event was to discuss the updates since

last SEARAST meeting. The last SEARAST meeting (SEARAST/21) was held from 17 to 18 November 2021 on virtual platform. An Interim SEARAST Meeting was conducted on 27 March 2024 with approval of SEARAST Team Leader to take the update on the progress since last regular SEARAST Meeting.

2.9 Further to the 18th COSCAP-SEA Steering Committee Meeting, which requested member States and Safety partners to consider offering experts to work in COSCAP-SEA Programme office, the DGCA of Indonesia kindly extended it secondment of an airworthiness expert on a part-time basis for the second year to continue supporting COSCAP-SEA Programme.

3. **CONCLUSION**

- 3.1 COSCAP-SEA completed many activities covering all programme objectives during the reporting period. From April 2021 onwards, COSCAP-SEA, in close coordination with, and with significant support from its Partners, managed to provide training activities using a virtual platform. Some of the training which could not be conducted will be rescheduled in the proposed Annual Work Plan (2024-25)
- 3.2 While the performance of on-site technical assistance missions outside Thailand were far and few during the assessment period, COSCAP-SEA has resumed on-site missions in recent times. The upcoming years will witness more on-site missions as per programme objectives for Phase-V.
- 3.3 In accordance with 18th COSCAP-SEA Steering Committee Meeting request for providing experts to COSCAP-SEA Programme, the CAAs and esteemed Partners may consider secondment of experts.
