I am pleased to invite your Administration to nominate participants to attend the Transition of Strength of Pavements from Pavement Classification Number (PCN) to Pavement Classification Rating (PCR) to be held in a virtual classroom on 15 May 2024. This webinar has been planned to prepare the States in implementation of the SARPs on strength of pavements in an aerodrome by November 2024, and as prioritized in the Work Plan approved by the COSCAP SEA Steering Committee.

The webinar is designed for the States' Civil Aviation Authority (CAA), AIS personnel and aerodrome operators with an intent to discuss the requirements for transition to PCR and related milestones. Earlier the ICAO APAC Regional Office organized a technical workshop "ICAO Aerodrome Pavement Workshop from 7 to 9 February 2024 supported by FAA. The CTA/PC will facilitate the webinar.
