I wish to invite your Administration/Organization to participate in the Second Webinar on Unmanned Aircraft Systems - Remotely Piloted Aircraft Systems (UAS/RPAS) Implementation/Regulation for the Asia-Pacific (APAC) Region, scheduled to take place via video teleconference on **11-12 December 2024**. The ICAO Asia and Pacific Regional Sub-Office (RSO) will be hosting this two-day event, with sessions of three hours each day.

The webinar will focus on updates in global interoperability of UAS/RPAS and conventional aircraft operations. ICAO will handle regulatory discussions and updates on international development efforts, while States/Administrations and international organizations will cover practical drone usage and management. A key topic for discussion, "How to Secure the Safety of Manned Aircraft from UAS Operations around Aerodromes" will provide a platform to explore safety challenges and technical limitations and developments in UAS operations at and around aerodromes

Specifically, the event will address the integration of drones into the aviation system, particularly through advancements in anti-drone technology and effective drone management for airport and associated airspace safety. It will also cover the use of drones in flight inspections, offering valuable insights into enhancing aviation safety and operational efficiency.
