2. DISCUSSION

EUR Doc 041

2.1 At AAITF/19, it was agreed to adopt the latest edition of EUR Doc 041 (issued in December 2020) as regional guidance. The following is the relevant conclusion.

Draft Conclusion AAITF/19-2: Revised Guidance on the Issuance of SNOWTAM

That, the revised EUR Doc 041 – Guidance on the Issuance of SNOWTAM (V.1.1) at **Appendix E to the Report** be uploaded on the ICAO Asia/Pacific Regional Office eDocuments web-page, to replace the existing.

- 2.2 EUR Doc 041 is a valid document that provides detailed guidance on SNOWTAM. Other Regional Offices are also aware of its relevance. It has been noted that some Regional Offices adopt only Part III of Chapter 7 in ICAO Doc 8126, while considering EUR Doc 041 as a reference document to be used at the discretion of individual States.
- 2.3 Accordingly, it is proposed that Action Item 19/5 be considered completed and closed.

- 2.4 ICAO Doc 7383, Aeronautical Information Services Provided by States, is available on the ICAO Portal. The current edition is No. 102, published in June 2014. As more than a decade has passed since the last update, certain information contained in the document is now outdated.
- 2.5 States are able to submit update requests through ICAO's GIS platform; however, due to a lack of human resources, the timeline for the revision of the document remains undetermined.
- 2.6 Accordingly, it is proposed that Action Item 19/8 be considered completed and closed.
