SUMMARY

This paper summarizes the outcomes of the APANPIRG/35 & RASG-APAC/14 Midyear Review and Thirteen PIRG & RASG Regional Coordination Meeting held on 28 August 2025.

Strategic Objectives:

*A: **Safety** – Enhance global civil aviation safety*

*B: **Air Navigation Capacity and Efficiency**—Increase the capacity and improve the efficiency of the global aviation system*

1. INTRODUCTION

1.1 APANPIRG/35 & RASG-APAC/14 Midyear Review and Thirteen PIRG & RASG Regional Coordination Meeting was held in Bangkok, Thailand, on 28 August 2025 in Hybrid format. The meeting was attended by the APANPIRG Vice-Chairpersons, RASG-APAC Chairperson and Vice-Chairperson, Chairpersons/Co-Chairpersons of APANPIRG's and RASG-APAC Contributory Bodies and the Secretariat.

1.1 The APANPIRG/35 & RASG-APAC/14 Midyear Review and Thirteenth PIRG & RASG Regional Coordination Meeting was held on 28 August 2025 in ICAO Bangkok Office in the Hybrid format (face-to-face and video teleconference).

3. Summary of Discussions

Agenda Item 1 — Progress updates on the APANPIRG/35 Conclusions and Decisions – Action Plans

3.1 The Report of the APANPIRG/35 Meeting was reviewed by the ANC Working Group of the Whole for Strategic Review and Planning (SRP) on 12 February 2025 (please refer to AN-WP/9822 placed in **Appendix A**). The Meeting recorded its appreciation for APANPIRG Chair for his personal attendance and preparation of APANPIRG/35 report to the SRP/ANC. The Meeting noted that ANC had taken appropriate actions on Conclusion APANPIRG/35/2 and Decision APANPIRG/35/6 which are provided in Appendix to AN-WP/9822.

3.2 The Meeting noted that the follow-up actions on 8 Conclusions and 2 Decisions of APANPIRG/35 were completed, with 3 Conclusions (35/1, 35/4 & 35/5) remaining open.

3.3 Regarding Conclusion APANPIRG/35/5: Regional Guidance for Space Object Launch and Re-Entry Coordination, both Vice-Chairs of APANPIRG agreed to include the "Identification of POC in the Launching ATS Authority" in para 3.2.2 of the Asia/Pacific Regional Guidance for Space Object Launch and Re-Entry Activities, as recommended by the Chair of ATM/SG and the Secretariat.

3.4 The Secretariat would issue a single State letter addressing Conclusions APANPIRG 35/1, 35/4, and 35/5 following this Meeting. After the issue of the State letter, the action by the Secretariat on all 11 APANPIRG's Conclusions would be marked as completed.

3.5 The Meeting was informed that ICAO had not received any nomination from States and Administrations for a secondment to ICAO APAC Office in Aviation Meteorology (MET) following the publication/issue of the State letter on secondment opportunity in accordance with Decision APANPIRG 35/11.

3.6 Regarding outstanding APANPIRG's Air Navigation Deficiencies, the Meeting was appraised that States/Administrations were followed up by the Secretariat prior to APANPIRG's Sub-Groups Meetings and reminded them to provide satisfactory evidence of the implementation of the Corrective Action Plan (CAP) as well as provide updated CAPs. Vice-Chair Ms. Theresa informed the Meeting that she had coordinated with Directors of Civil Aviation from Pacific Small Islands Developing States (PSIDS) and would discuss how the outstanding deficiencies could be resolved.

3.7 Updated progress on *APANPIRG/35 Conclusions/Decisions - Action Plan* is placed in **Appendix B**.

3.8 Both Vice-Chairs agreed with the Provisional Agenda of APANPIRG/36 (**Appendix C**). APANPIRG/36 would be held from 24 to 26 November 2025 in Bangkok.

Agenda Item 2 — Progress updates on the RASG-APAC/14 Conclusions and Decisions – Action Plans

3.9 The RASG-APAC/14 Report was reviewed by the ANC Working Group of the Whole for Strategic Review and Planning (SRP) on 12 February 2025 (please refer to AN-WP/9822 placed in **Appendix A**). The meeting recorded significant challenges to aviation safety oversight in the APAC region, with issues persisting particularly in key areas such as accident investigation and State Safety Programme (SSP) implementation, especially for smaller States.

3.10 The Meeting noted the restructuring of APRAST contributing bodies, with the transition of the former AP-RASP and SEI groups to the ORG Working Group and OPS Working Group, respectively. The restructuring included the formulation of task forces under each respective working group and assignment of specific responsibility to each task force. The Meeting noted that the restructure required formalization in the appropriate TORs and endorsement in RASG-APAC/15.

3.11 The Meeting noted that the follow-up actions on the 05 Decisions out of 10 were completed, and rest 05 Decisions on RASG-APAC 14/2, 14/3, 14/4, 14/5 and 14/10 were noted as ongoing.

3.12 Updated progress on RASG-APAC/14 Conclusions/Decisions - Action Plan and Annual Work Programme is placed in **Appendices D1 & D2**.

Agenda Item 3 — 13th PIRG & RASG Regional Coordination

3.13 The Meeting reviewed the coordination responsibilities agreed at previous regional coordination meetings. Two new items were added, with APANPIRG assigned as the lead for "*Global Navigation Satellite System (GNSS) Radio Frequency Interference (RFI) against civil aviation*" and RASG-APAC as the lead for "*Turbulence Encounters*." The Meeting noted that both items required close coordination between the two groups.

3.14 The Secretariat emphasized that responsibilities must be clearly defined, and the lead must be aware of their duties, especially considering the extensive cross-domain interfaces. The Secretariat also highlighted that feeding data from these cross-domains is crucial, as it is the primary objective of the entire mechanism.

Agenda Item 4 — Progress Update on Coordination between the APANPIRG and RASG-APAC Sub-Groups to address safety issues/initiatives overlapped between Sub-Groups which had been discussed on 12th PIRG & RASG Regional Coordination Meeting

3.15 The Meeting reviewed five activities from the 12th Coordination Meeting that were designed to address common safety issues. Progress was noted on three coordination items between APANPIRG and RASG in the areas of “*Large Height Deviation and APAC regional hotspots*,” “*Turbulence Encounters*,” and “*GNSS Jamming and Spoofing*.” The meeting also noted that RASG/14 decided not to prioritize the “*Unmanned Aircraft Operations over the High Seas*” and “*Runway Safety*”.

3.16 The Secretariat presented a draft coordination mechanism to be established between the APANPIRG’s and RASG-APAC’s Sub-Groups (please refer to **Appendix E**). The draft coordination mechanism outlined a framework that included necessary actions, communication protocols, and resource considerations. The Secretariat noted that the mechanism was subject to further refinement before it could be formalized within both forums’ handbooks.

3.17 The Meeting agreed that the relevant Sub-Groups Secretariats would review the proposed mechanism before formal submission to the Meetings of APANPIRG and RASG-APAC.

Agenda Item 5 – Other Business

3.18 The meeting discussed Draft Conclusion AOP/SG/9-10, which proposed acknowledgement of the Wildlife Strike as a High-Risk Category of Occurrence (HRC) for the Asia and Pacific regions. It was noted, however, that extensive study and decision at APRAST level were required before determination of the item as HRC.

3.19 It was decided that the 14th APANPIRG & RASG-APAC Coordination Meeting shall take place on last day of upcoming APANPIRG/35 Meeting on 26 November 2025 at 14.00 before the RASG-APAC/15 Meeting scheduled on 27 - 28 November 2025 in ICAO APAC Office. They shall discuss the effective coordination mechanism between PIRG and RASG and overlapping issues that can be laterally coordinated between the Sub-Groups.

Closing of the Meeting

3.20 APANPIRG Vice-Chairs and RASG-APAC Chair and Vice Chair thanked the Secretariat for the concise programme and presentation, which facilitated the discussion very smoothly and effectively. They also thanked all the Sub-Group Chairs for joining the Meeting for the second time and appreciated the need for such coordination between PIRG and RASG Subsidiary bodies. The Regional Director thanked Chairs/Vice-Chairs of both Groups and all the Co-Chairs of Sub-Grouos for their invaluable contribution to the work of the APANPIRG and RASG-APAC. He also thanked all participants for their attendance and valuable contribution to the Meeting.

1. INTRODUCTION

1.1 The thirty-fifth meeting of the Asia/Pacific Air Navigation Planning and Implementation Regional Group (APANPIRG/35) and the fourteenth meeting of the Regional Aviation Safety Group – Asia and Pacific Regions (RASG-APAC/14) were held in Bangkok, Thailand, between 25 to 27 November and 28 to 29 November 2024, respectively.

1.2 The Working Group of the Whole for Strategic Review and Planning (WG/SRP) reviewed the APANPIRG/35 Report presented by Captain Manuel Antonio Tamayo, Chairperson of APANPIRG, Director General, Civil Aviation Authority Philippines and RASG-APAC/14 Report presented by the Vice-Chairperson of RASG-APAC, Ms. Clara Wong, Deputy Director General of Civil Aviation, Hong Kong, China. The meeting was supported by Dr. Manjit Singh, Deputy Regional Director, ICAO Asia and Pacific (APAC) Office, and a team of Technical Officers assigned to the ICAO APAC Office. The WG/SRP thanked Capt. Tamayo, Ms. Wong, Dr. Singh, and their teams for their time and effort in the preparation of this detailed presentation to the SRP.

1.3 The APANPIRG/35 meeting was well attended by 163 participants from 24 Member States, two Special Administrative Regions of China, and five international organizations (Airports Council International (ACI), Civil Air Navigation Services Organisation (CANSO), European Union Aviation Safety Agency, International Air Transport Association and International Federation of Airline Pilots' Associations (IFALPA)). The WG/SRP noted that 11 Conclusions and two Decisions were taken.

1.4 The RASG-APAC/14 was also well attended with 94 participants face to face and 15 participants online from 22 Member States/Administrations and eight international organizations/industry observers (Association of Asia Pacific Airlines, ACI, Airbus, Boeing, CANSO, Flight Safety Foundation, IFALPA and Cooperative Development of Operational Safety and Continuing Airworthiness Programme - South East Asia (COSCAP-SEA)). It was also noted that the meeting adopted ten Decisions.

2. DISCUSSION

2.1 APANPIRG/35 Report

2.1.1 The WG/SRP was presented with key challenges and issues in the field of air navigation, key outcomes and conclusions, as well as outstanding conclusions that require specific action by Headquarters.

2.1.2 With respect to APAC key challenges, WG/SRP noted the slow progress of APAC Ministerial Declaration Commitments in implementing the Priority Elements of the APAC Seamless Air Navigation Services (ANS) Plan.

2.1.3 WG/SRP noted the increasing demand for air traffic services in the Kabul Flight Information Region under contingency situations, as operators are still transiting this airspace due to market demands.

2.1.4 WG/SRP noted the increasing impact and potential hazards associated with the global navigation satellite system signal interference and spoofing, and further noted the lack of uniform guidance and the need for regional cooperation.

2.1.5 WG/SRP noted the slow development for system-wide information management (SWIM) implementation and that delays will impact key air traffic flow management, meteorology (MET), flight and flow – information for a collaborative environment (FF-ICE), and aeronautical information service (AIS) to aeronautical information management transformation. Also, the WG/SRP noted the challenges associated with the dissemination of MET information in the ICAO meteorological information exchange model (IWXXM) form related to the amendment of Annex 3 – *Meteorological Service for International Air Navigation*. WG/SRP inquired as to the specifics of IWXXM challenges; the challenges included resource constraints in less developed countries, difficulties in updating systems to disseminate IWXXM

information, challenges with inter- and intra-regional communication infrastructure, and the evolving nature of ICAO provisions related to IWXXM.

2.1.6 WG/SRP noted the key challenges related to 153 outstanding deficiencies in total, including 37 related to aerodrome certification, eight related to status of aerodrome certification in aeronautical information publication, 18 related to AIS quality management systems (QMS) not implemented, 30 related to search and rescue (SAR) capability below requirement, one related to unreliability of aeronautical fixed service communication, three related to provision of information concerning en-route weather and other phenomena in the atmosphere that may affect the safety of aircraft operations (SIGMET), and three related to world area forecast centre forecasts not available. WG/SRP inquired as to the root cause of the QMS implementation challenges; the challenges are primarily due to lack of resources and understanding of the Standards. The ICAO APAC office has been conducting workshops and seminars to support States in this area.

2.1.7 WG/SRP noted key outcomes of the APANPIRG/35 Meeting including: monitoring of the implementation progress on Asia and Pacific Ministerial Declaration on Civil Aviation (Delhi) through urging States to share challenges; adoption of APAC Seamless ANS Plan, which represents a significant step towards implementation; development of regional guidance for design and operations of airports which could serve as a global model; publication of a revision to regional guidance for space object launch and re-entry coordination; significant progress in the implementation of ground telecommunication infrastructure (CRV) in which 25 States have joined; updates to the regional SIGMET guide to include volcanic events and thunderstorms SIGMET dissemination; and the official opening of the Pacific Small Island Developing States (PSIDS) Liaison Office in Nadi, Fiji, resulting in a number of regional workshops to improve SAR and instrument flight procedures.

2.1.8 WG/SRP inquired on the harmonization of APAC's regional guidance for space object launch and re-entry coordination with guidance developed by other regions, e.g., the North Atlantic. While APAC's guidance was updated, full harmonization efforts were limited, however there is intent for future global harmonization.

2.1.9 WG/SRP inquired whether the Seamless ANS plan version 4.0 would help those States lagging in catching up; the updated Seamless ANS Plan 4.0 includes new elements and prioritizes block zero elements to help States focus on key areas. It aims to support harmonization and improve air capacity and efficiency. The plan's priorities are tailored to the APAC Region, unlike the global plan which includes elements not currently applicable to the region. WG/SRP further inquired on PSIDS deficiencies; air traffic management (ATM) deficiencies are related to limited resources, personnel, and difficulties in attending ICAO meetings and comprehending information or programmes included in State letters. Programmes are in place to assist States with this.

2.1.10 WG/SRP also noted that the following seminars, workshops and webinars were conducted in 2024: one aerodrome pavement workshop; five FF-ICE, ATM contingency, SAR, AIS-QMS implementation; 10 CRV, automatic dependent surveillance – broadcast, frequency use, SWIM, flight inspection and procedure validation; three regional seminars on environment and MET; and four free route airspace, civil-military cooperation, and unmanned aircraft system/remotely piloted aircraft systems.

2.1.11 WG/SRP noted that the APAC Regional Office resolved 18 Air Navigation Deficiencies in 2024 related to aerodrome operations (AOP), ATM, communications, navigation and surveillance (CNS), and MET.

2.1.12 The WG/SRP noted that there are two APANPIRG/35 Conclusions or Decisions which require action by Headquarters:

- a) **Conclusion APANPIRG/35/2.** Regional guidance for design and operations of altiports. APANPIRG/35 concluded that regional guidance for design and operations of altiports developed by Asia/Pacific Aerodrome Design and Operations Task Force (AP-ADO/TF) and endorsed by the eighth meeting of the Aerodrome Operations and Planning Subgroup (AOP/SG/8) be forwarded to the Air Navigation Bureau. The WG/SRP recommends to the ANC that this draft regional guidance be referred to the Ad Hoc Working Group formed under Aerodrome Design and Operations Panel (ADOP) to develop the global guidance on design and operations of altiports.
- b) **Decision APANPIRG/35/6.** Information Management Panel considers the adoption of SWIM discovery service (SDS) as a global standard for globally interoperable service discovery. APANPIRG/35 proposed that the Information Management Panel (IMP) consider adopting the SDS as a global standard for globally interoperable service discovery. The WG/SRP recommends to the ANC that this item be referred to the IMP to consider adopting SDS as a global standard.

2.2 **RASG-APAC/14 Report**

2.2.1 The WG/SRP noted and reviewed the RASG-APAC key challenges, issues, the APAC Ministerial Declaration outcomes, and achievements in 2024. The WG/SRP noted with appreciation the value of the information provided and the continued coordination between the PIRG and the RASG.

2.2.2 With respect to the key challenges faced by the RASG-APAC, the WG/SRP noted that technical assistance missions were being impacted by inconsistent funding and noted the RASG-APAC's recommendation that a triennial overlapping budget be adopted.

2.2.3 WG/SRP noted that with regards to APAC Ministerial Declarations, the APAC effective implementation (EI) of the Critical Elements of the States' safety oversight system level of 66.58 per cent remains below the global average effective implementation level of 70.12 per cent and the Global Aviation Safety Plan (GASP) target of 75 per cent. WG/SRP noted the role that regional diversity played upon Universal Safety Oversight Audit Programme (USOAP) EI progress, with 14 States above 75 per cent, 10 States between 60 and 75 per cent, and 13 States below 60 per cent.

2.2.4 WG/SRP noted that implementation of the Pacific Aviation Needs Analysis study recommendations remains challenging, further noting that the PSIDS warrant special attention.

2.2.5 WG/SRP noted that State safety programme and accident investigation implementation continues to be a low performing area in the APAC Region. For example, only six States have completed implementation, and 16 States are still in progress of implementation. Forty per cent of APAC States have established an independent aircraft accident and incident investigation authority. WG/SRP asked for elaboration on the aircraft accident and incident investigation (AIG) challenges; these challenges include capability, training, procedures and resources. The APAC Region has established an expert working group and an international cooperation mechanism to assist States in establishing these authorities. The goal is to increase the number of States with independent authorities and improve the timely publication of final accident investigation reports.

2.2.6 With regard to the APAC Ministerial Declaration to endeavour to have no Significant Safety Concerns (SSC) under the USOAP Continuous Monitoring Approach (CMA), the WG/SRP noted

that although there was one State that currently holds an SSC, significant progress has been made towards resolution, including airspace redesign, promulgation of regulatory material related to air traffic control, air traffic control officer training, and regional cooperation with a neighbouring State had occurred. WG/SRP asked further questions related to the SSC; progress has been made on the technical aspects of the Southeast Asia (SSE) functional airspace block implementation, particularly through the COSCAP programme. However, institutional agreements between two States are still pending, though there are signs of progress.

2.2.7 WG/SRP noted challenges associated with implementation of the Asia-Pacific Regional Aviation Safety Plan (AP-RASP) Roadmap, which includes collaboration with States and industry under RASG to organize capability-building events for the Region and implement safety enhancement initiatives (SEI). WG/SRP further noted that the implementation of RASP Roadmap for 2023-2025 is in progress and 2026-2028 RASP updates will start soon.

2.2.8 WG/SRP noted key outcomes of the RASG-APAC in 2024, including: the AP-RASP for 2023-2025 is well implemented; the APAC Annual Safety Report 2024 was promulgated on time; RASG-APAC's accident rate remained lower than the global rate over the past decade; ICAO APAC Office developed, updated and activated the "Monitoring Tool" for SEI implementation, national aviation safety plan, AP-RASP and GASP SEI mapping; delivery of seven government safety inspector training courses; EI augmentation via CAT Technical Missions, and that 325 out of 355 international aerodromes certifications were completed.

2.2.9 No conclusions were addressed by RASG-APAC/14 Meeting for ANC action.

3. ACTION BY THE AIR NAVIGATION COMMISSION

3.1 The Air Navigation Commission is invited to:

- a) note the APANPIRG/35 and RASG-APAC/14 Meeting Reports and the WG/SRP report thereon as contained in this paper;
- b) discuss the proposed actions concerning the conclusions that require ANC action as in the appendix; and
- c) request the Secretariat to provide an update on the progress made.

PIRG/RASG Coordination mechanisms (Draft)

1. Consultation of Working Groups

Matters of common interest to APANPIRG and RASG-APAC shall be discussed by the respective Chairs of the relevant working groups under APANPIRG and RASG-APAC (APRAST). The Chairs shall coordinate to determine if the issue warrants further consideration or joint action.

2. Joint Working Papers

When a matter requires joint consideration, States, industry stakeholders, or regional bodies under both groups may develop a joint Working Paper (WP). This WP shall be presented to the relevant subgroups of both APANPIRG and RASG-APAC (e.g., APRAST and relevant APANPIRG working groups).

3. Coordinated Actions

Subsequent actions shall be coordinated between the corresponding working groups. Identified outcomes may include, but are not limited to, the exchange of information, organization of joint activities, or the development of a Safety Enhancement Initiative (SEI).

4. Secretariat Coordination

The ICAO Regional Office Secretariats for APANPIRG and RASG-APAC shall coordinate on common issues to ensure that relevant papers and decisions are addressed appropriately within both forums.

5. Communication and Focal Points

A list of focal points, including their contact details, shall be maintained and exchanged between the relevant subgroups to facilitate effective and timely communication.

6. Resources

When an action item related to air navigation requires specialized expertise, APANPIRG shall nominate relevant subject matter experts from States and industry stakeholders (e.g., CANSO, IATA, FSF) to participate in the working groups of APRAST, as appropriate

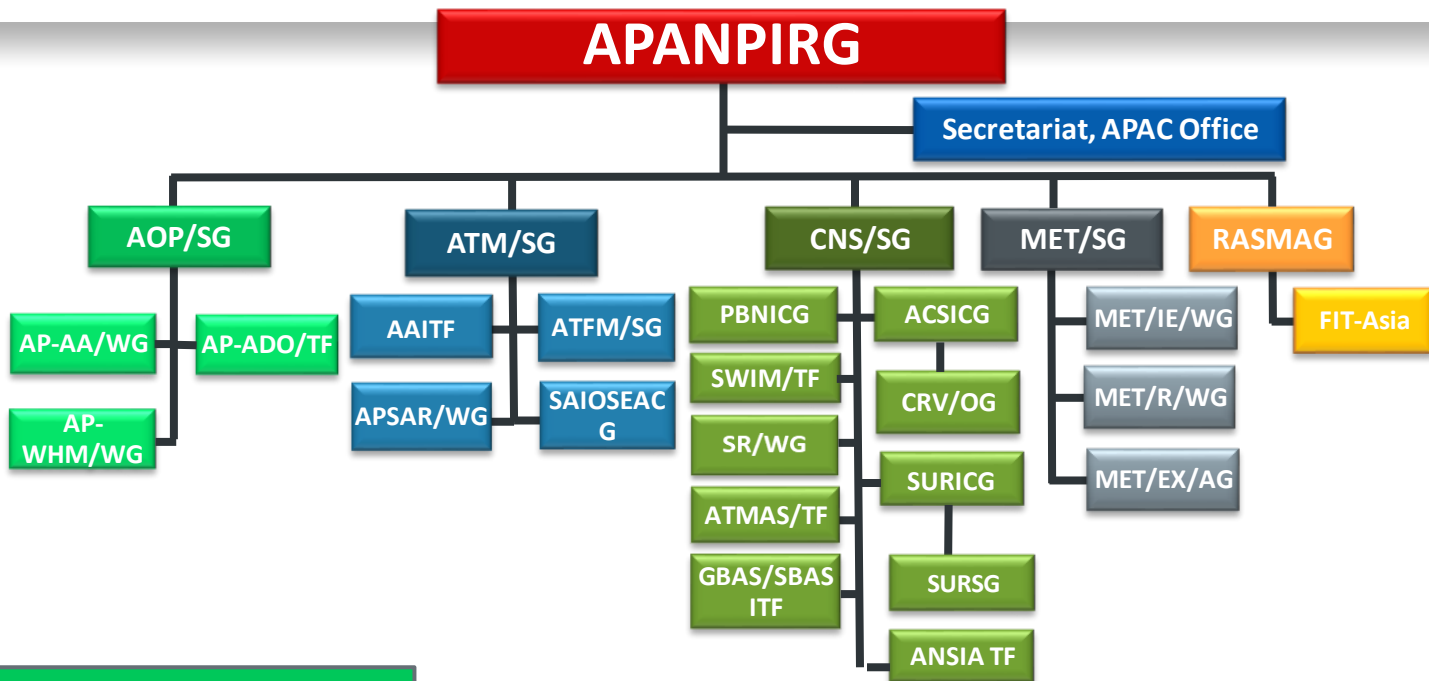

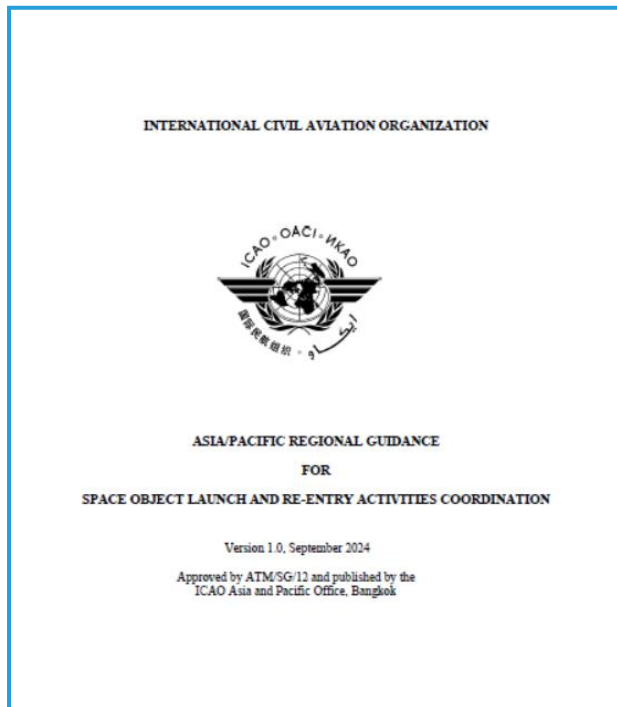

 - a) be uploaded to the Asia/Pacific Regional Office website, to replace the existing Asia/Pacific Planning Checklist for Ballistic Launch and Space Re-entry;*
 - b) be referenced in the Asia/Pacific Seamless ANS Plan; and*
- 2) the related ballistic launch and space re-entry guidance and performance expectations in the Asia/Pacific Seamless ANS Plan be updated accordingly.*

Regional Guidance Document



- Developed by the Space Vehicle Launch and Re-entry Coordination Small Working Group (SVLRC SWG), established under the ATM Sub-group.
- Supersedes the *Asia/Pacific Planning Checklist for Space Launch and Space Re-Entry Operations*, previously available on the ICAO APAC eDocument webpage.
- The Regional Guidance Document was reviewed and endorsed by ATM/SG/12 in September 2024.
- A draft conclusion was presented at APANPIRG/35 (November 2025) for formal adoption of the Regional Guidance Document.

Revised Version

3.2.2 The Launching State Appropriate ATS Authority responsible for coordinating space object launch and re-entry activity should begin coordinating with affected appropriate ATS authorities at least 10 days (ideally 14 days) prior to the proposed activity. The following information should be included in the coordination:

- Tentative launch window commencement time and duration (primary and, if any, backup timing and dates).
- Activity time of day and extent of airspace affected (latitude/longitude coordinates).

Note: In cases where extent of airspace affected crosses multiple FIRs, individual requests should be developed and sent to each impacted FIR. The appropriate ATS authority developing requests should ensure there are shared points for airspace affected spanning across multiple FIRs to ensure safety.

- Identification of POC in the Launching ATS Authority.
- Identification of POC in the Affected Appropriate ATS Authority.
- Any other necessary supporting information.

Action Taken

- In this regard, ICAO Secretariat coordinated and reviewed the matter with the Chair of ATM/SG and received subsequent approval, to include the **"Identification of POC in the Launching ATS Authority"** in para 3.2.2 of the *Asia/Pacific Regional Guidance for Space Object Launch and Re-Entry Activities*.

Next Step

- Subject to APANPIRG Chair/Vice Chair agreement, ICAO APAC Regional Office will circulate a State Letter to APAC States/Administrations regarding ATM and Airspace Safety-Related APANPIRG Conclusions, including the information about the minor amendment to the *Asia/Pacific Regional Guidance for Space Object Launch and Re-entry Activities Coordination*, as published on the ICAO APAC Regional Office eDocuments webpage.

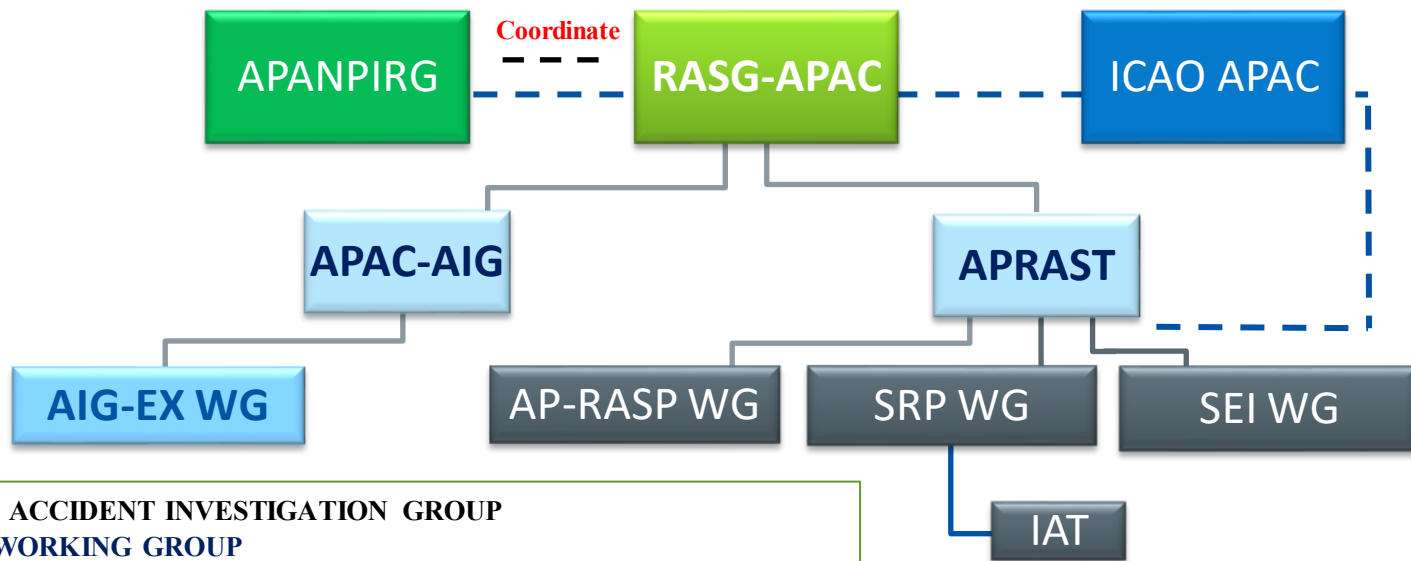

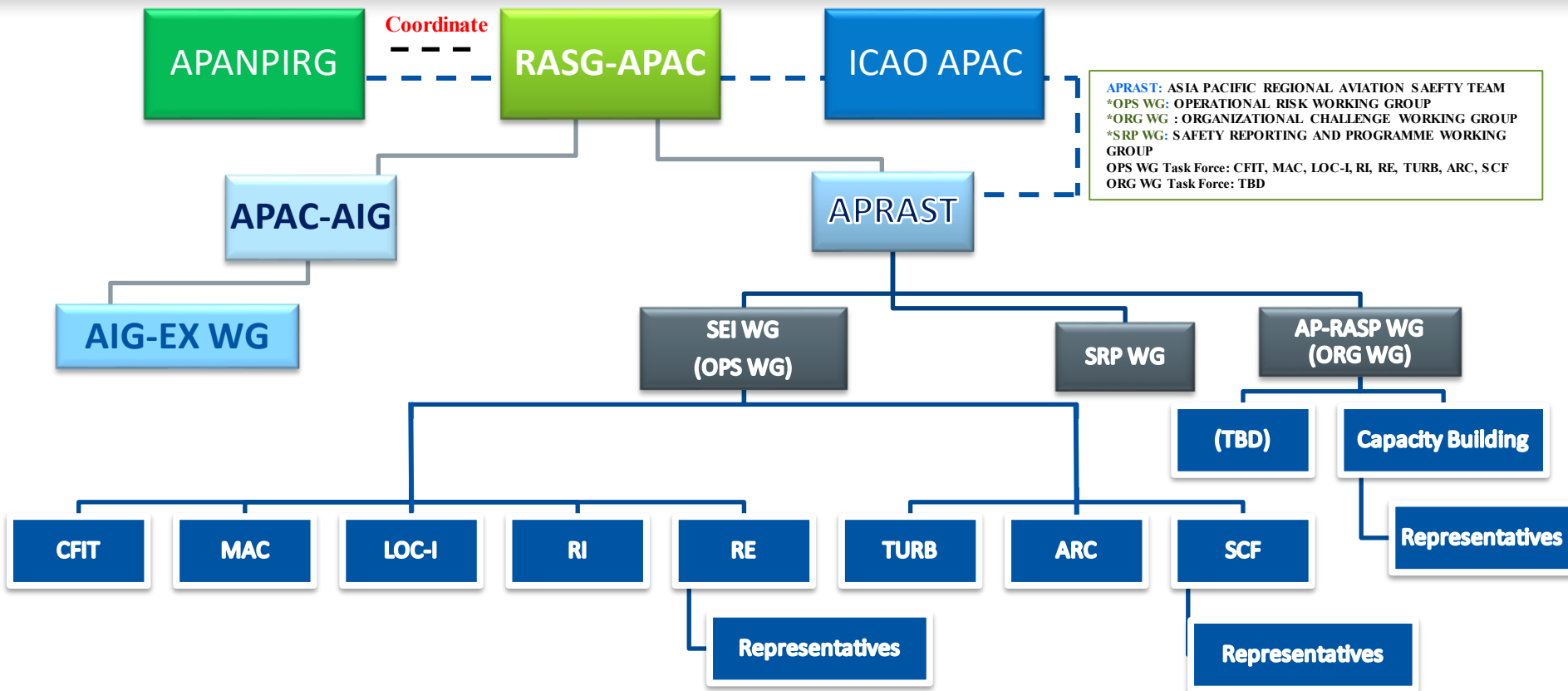
