I am pleased to invite your State/Administration to participate in the Sixth Meeting of the Asia Pacific Air Traffic Management Automation System Task Force (APAC ATMAS TF/6) to be held from *02-04 June 2025* in the ICAO APAC Regional Office, Bangkok, Thailand.

The objectives of ATMAS TF/6 are to discuss and review the latest developments in ATM Automation Systems (ATMAS) and associated technologies; facilitate the implementation, enhancements, operation and maintenance of ATMAS and services; review, identify and address significant issues in technical, operational, safety and regulatory aspects of ATMAS, and oversee and share experiences of the AIDC implementation and provide a coordination framework among States for wider and effective implementation of AIDC across the APAC region. The meeting will also review the regional ATMAS Implementation and Operations Guidance Document (ATMAS IGD) and ATMAS Repository and share ATMAS implementation knowledge and experience of ATM automation systems in the APAC Region. An additional agenda item, ATMAS integration to SWIM, will discuss, assess and review the impact of SWIM implementation on ATMAS.
