

FAA Asia-Pacific Capacity Building Goals

Support safety enhancements in civil aviation to help civil aviation authorities create safer systems by:

- Increasing training capabilities
- Partnering with regional organizations (e.g., ICAO, ASEAN, APEC) to enhance collaboration opportunities
- Promoting positive safety culture
- Identifying needs to prioritize FAA assistance





Increasing Training Capabilities

- Train the Trainer Program
 - The FAA in partnership with Thailand, Singapore, the Boeing Company, and the ICAO APAC regional office, sponsored GSI training efforts to increase capacity in Southeast Asia.
 - Government Safety Inspector (GSI) Continuing Airworthiness (AIR) Course in November 2023
 - Government Safety Inspector (GSI) Personnel Licensing (PEL) Course in May-June 2024
 - Government Safety Inspector (GSI) Flight Operations (OPS) Course in July-August 2024
- Co-chairing the Regional Training Cooperation Framework Working Group (RTCF WG)
 - ICAO Asia Pacific Regional Aviation Training Symposium 2025 "Enhancing Training Cooperation: Building Human Capital for the Sustainable Development of Civil Aviation"
 - Led Regional Training Needs Survey SMG and Report





Illegal Charter Briefings

- Hosted virtual briefing focused on unauthorized charter operations using N-registered aircraft in the region
- Goal to raise awareness
 - Audience: regulators, inspectors, airport personnel, customs/border protection personnel, legal, etc.
 - methods to identify unauthorized operations
 - safety and regulatory concerns
 - potential enforcement measures
- Provided briefings to multiple CAAs and their colleagues





USOAP Lessons Learned and Best Practices Briefings

- Presented information to interested CAAs on what we learned from our experience during our USOAP audit from July 2024
- Discussed preparation and audit process, including:
 - U.S. USOAP audit history
 - Pre-audit activities, challenges and key takeaways
 - On-site audit activities, challenges and key takeaways
 - U.S. Outcome





FAA Seminars on Approved and Unapproved Parts: Strategies for maintaining aviation safety (SUPs)

- In response to Singapore's Information Paper at the COSCAP-SEA April 2024 Steering Committee meeting
- Held two SUPs seminars in Sept. 2024 in Malaysia and Japan
- Although led and coordinated by the FAA, we had heavy support from our partners such as CAA Malaysia, who hosted the SUPs workshop in Malaysia immediately before MASS 2024
