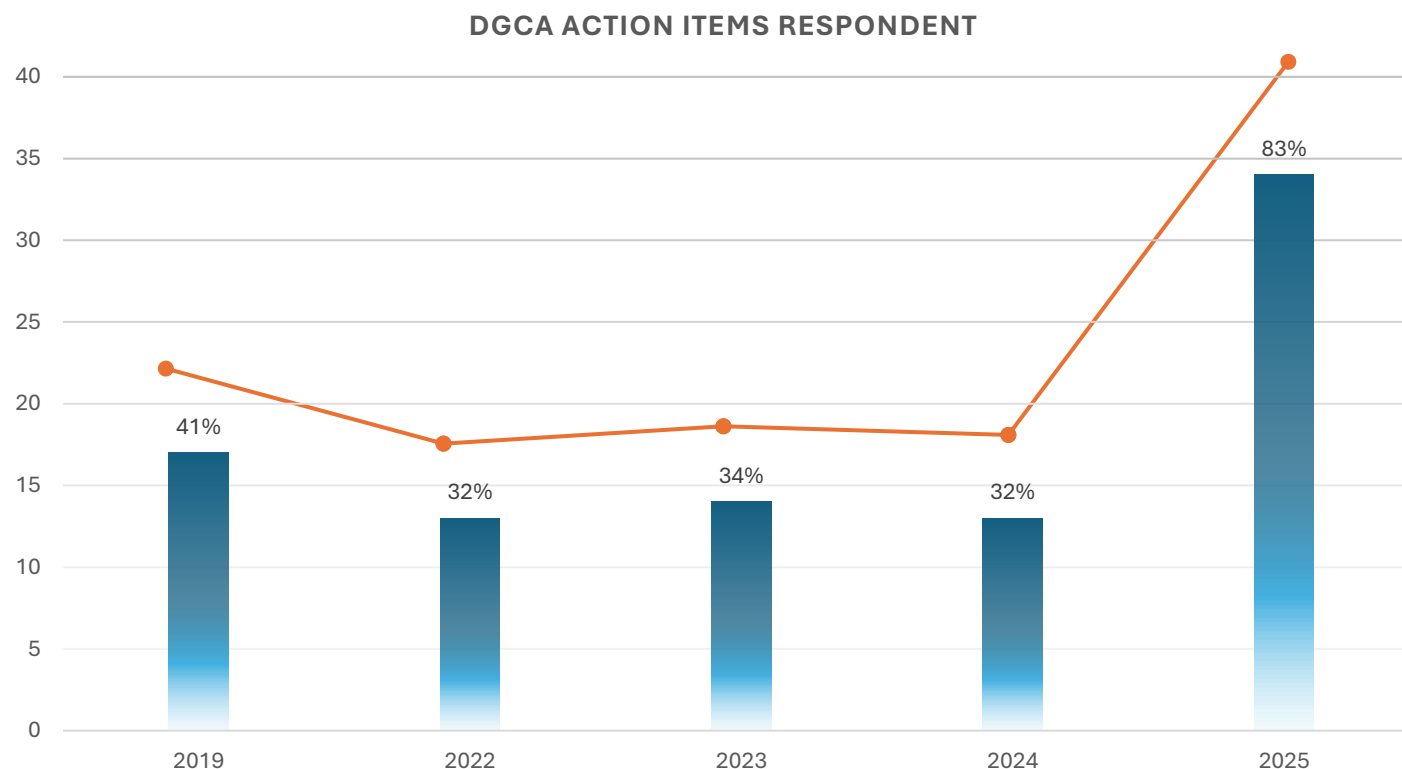

Responses Trend

- The number of States/Administrations that reported follow-up action on the DGCA/59 Action Items showed a significant increase,
 - Response rate of 83%
 - (34 out of 41 States/Administrations).
- In comparison, the number of responses received for follow-up reports on DGCA Action Items over the past years
 - Thirteen (13) in 2024,
 - Fourteen (14) in 2023,
 - Thirteen (13) in 2022, and
 - Seventeen (17) in 2019

Action Items Status

- Action Item 59/1

● To Commence ● Action In Progress ● Completed ● Not Applicable



Responses from various States/Administrations include:

Action 1 (Adopt emerging technologies in accordance with ICAO SARPs and guidance materials): *Some States, indicated plans to review ICAO's Strategic Plan and develop a National Aviation Safety Plan, while others are seeking donor assistance to progress this action.*

Action 2 (Improve gender equality and align with ICAO strategic objectives for sustainable aviation): *States generally noted and supported the action, with some working in coordination with relevant ministries to advance gender equality and sustainability goals.*

Funding and Collaboration Needs:

Some are seeking donor assistance to progress Action 1.

Others are collaborating with national ministries to lead initiatives under Action 2- Gender equality .

From the 32 responses received, the key themes include:

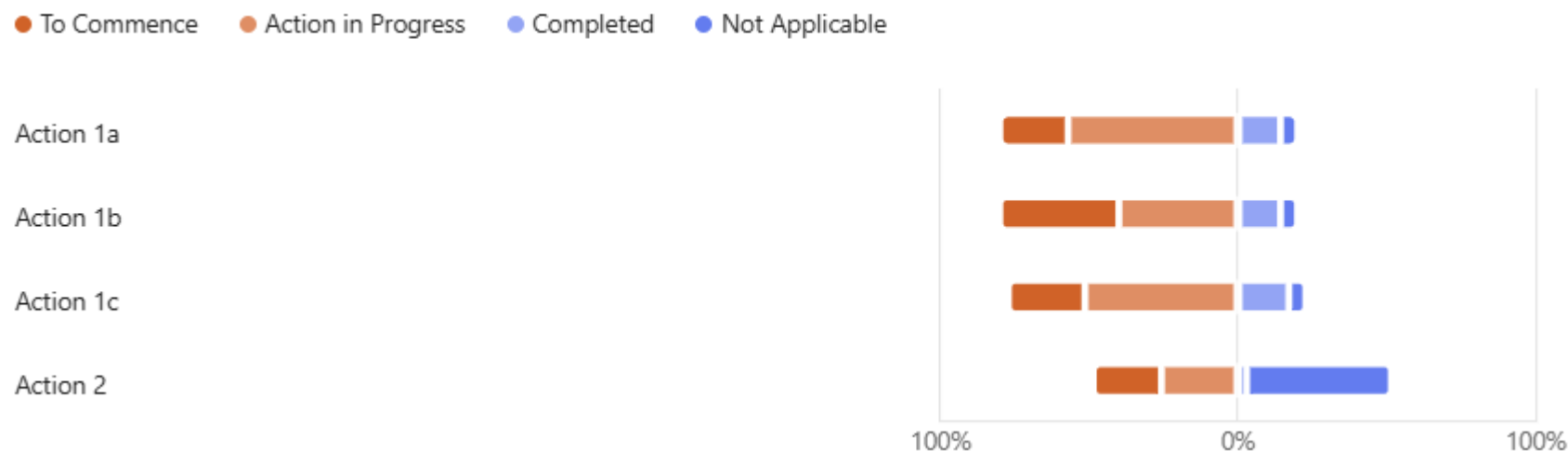
- Many States/Administration noted and supported the actions proposed under this item.
- Requests for Assistance: Several States, explicitly requested technical or financial assistance to implement the data-sharing initiatives.
- **Challenges:**
 - Some responses highlighted that data-sharing frameworks are not yet established, particularly in the Pacific region.
 - However, discussions are underway, and progress is expected to begin later in the year.

Action Items Status (cont'd)

- Action Item 59/4



From the 34 responses received, the key points include:

- General Support: Many States/Administration noted and supported the safety promotion actions under this item.
- There is States/Administration Indicated they are reviewing and addressing the item.
- Challenges Identified, some States, particularly smaller Civil Aviation Authorities (CAAs), acknowledged challenges in implementing safety promotion elements from Annex 19.

Action Items Status (cont'd)

- Action Item 59/5



From the 34 responses received, relates to the implementation and integration of safety data systems, such as ECCAIRS 2, the key points include:

- Many States noted and supported the action item.
- **Requests for Assistance:**
 - Some States requested assistance from IFALPA (International Federation of Air Line Pilots' Associations).
- **Implementation Status:**
 - Vanuatu reported they are awaiting confirmation from EASA to incorporate the ECCAIRS 2 database.
 - It was noted that major operators in some States already have safety database systems in place, indicating partial progress.

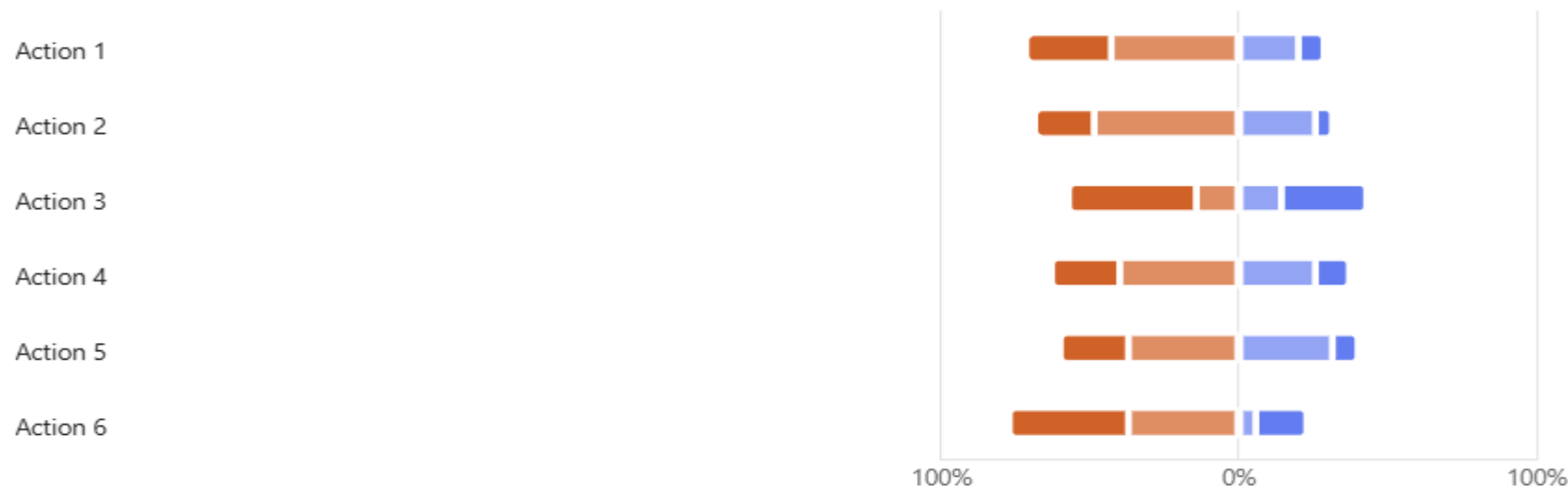

From the 34 responses received, the key points are:

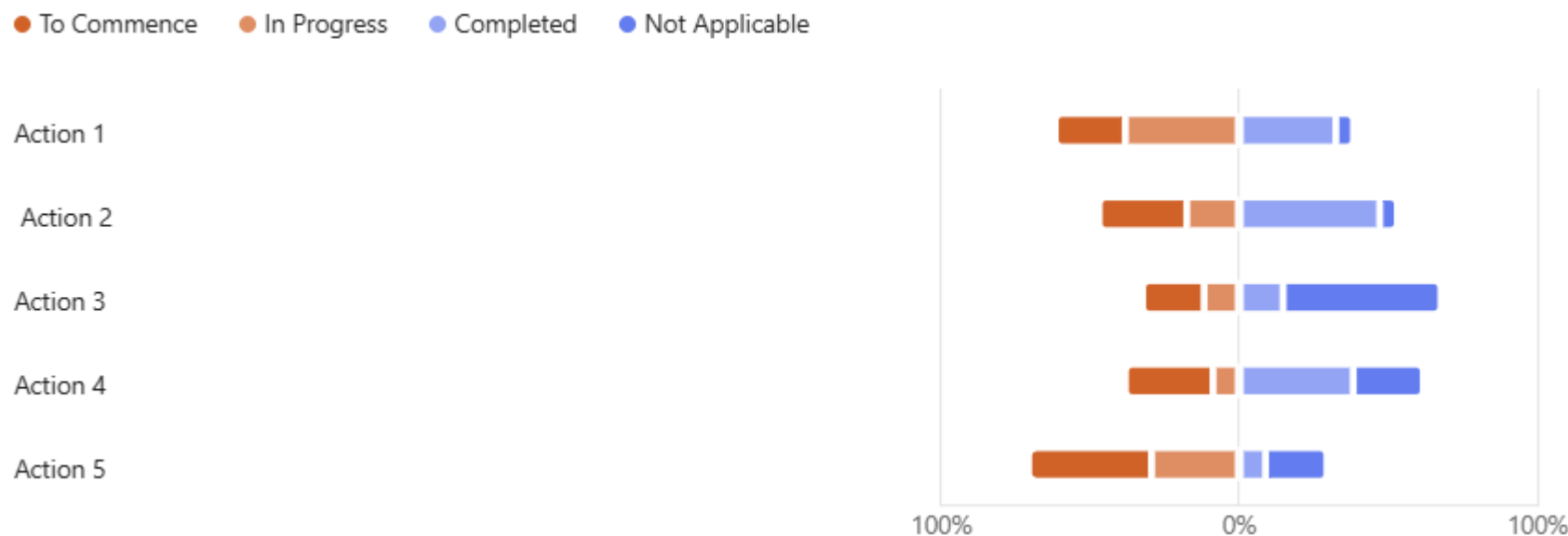
- Many States/Administrations noted and supported the actions.
- **Requests for Assistance:** Several States requested **technical or financial assistance** to implement the action item effectively.
- **Implementation Status:**
 - Some States reported that the items are **not yet incorporated** into their systems.
 - Others mentioned that **some elements have been explored**, but full integration is still pending.

Action Items Status (cont'd)

- Action Item 59/45



Action 1 (Ratify the protocols amending Articles 50 and 56 of the Chicago Convention): States/Administration noted the action; some States are progressing with ratification through national processes.

Action 2 (Nominate a Focal Point for the Ratification of International Air Law Treaties): Generally noted, but many States have yet to nominate a focal point.

Action 3 (Participate in CALAF and ICAO International Air Law Course): Participation is pending; States acknowledged the importance but may face resource constraints.

Action 4 (Inform ICAO of progress via the DGCA tracking matrix by 1 March 2025): Noted by most States; updates are still pending in several cases.

Action 5 (Contact ICAO LEB Treaty Section for assistance): States are aware of the option, but few have reported taking action.

Conclusion

- Overall, the responses to the action items from the 59th APAC DGCA Conference reflect broad support and acknowledgment from participating States and Administrations.
- While many actions were noted and endorsed, a significant number of States indicated that implementation is still pending or requires further assistance, funding, or coordination.
- There is a consistent call for ICAO support, regional collaboration, and capacity-building, especially among smaller and developing States.
- The feedback also highlights appreciation for proposed initiatives and themes, with several States actively progressing on key items such as ratification, training, and sustainability efforts.

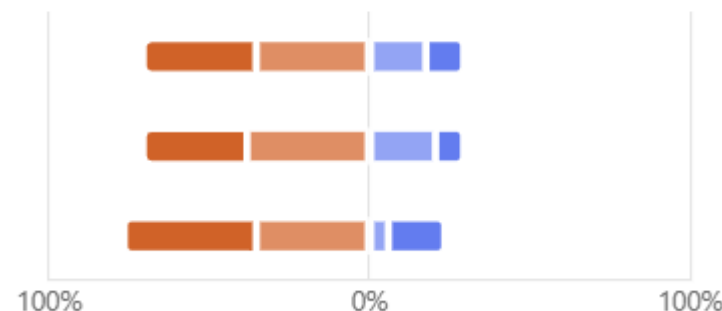

Action Item 59/47 (*Establish effective ICAO State Letter processes and share best practices*):

States noted and supported the recommendation..

- Several States requested assistance to implement this action item.
- **Implementation Gaps:**
 - Some States reported that this is not currently being carried out in their aviation industry.
 - This suggests a need for capacity building and resource support to enable implementation *others acknowledged the need to improve internal coordination and communication mechanisms.*

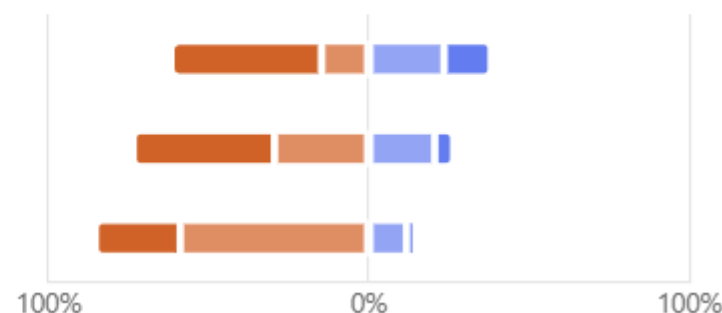

Action Item 59/8 – IATA Safety Charter

Many States expressed general support.

- Implementation Status:
 - Some States have not yet commenced work on the IATA Safety Charter.
 - Others are aware of its importance and are planning development.
- Requests for Assistance: Several States requested technical or financial support.

Action Item 59/9 – Safety Culture Indicators

- Widely supported across responses.
- Implementation Status:
 - Many States have not yet implemented safety culture indicators.
 - Some are in the early stages of development.
- Challenges: Limited resources and expertise were cited as barriers.

Action Item 59/10 – Broader Safety Initiatives

- Strong endorsement from most States.
- Implementation Status:
 - Some States are actively working on integrating broader safety initiatives.
 - Others are still exploring how to incorporate these into their systems.
- Requests for Assistance: Continued need for guidance and capacity building.

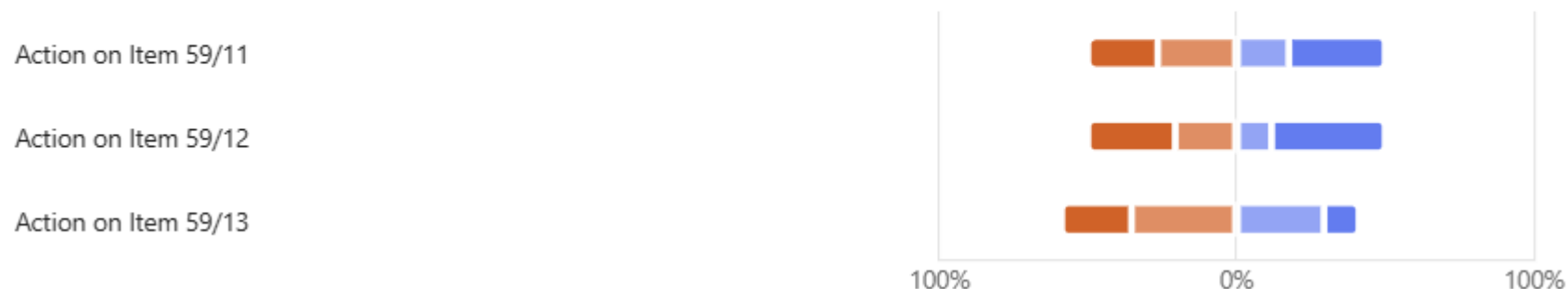

Action Item 59/11 – Strengthening Safety Oversight

- **Implementation Status:** Some States are actively working on strengthening oversight; others are in early stages.
- **Requests for Assistance:** Several States requested help with training and resources.

Action Item 59/12 – Promoting Regional Collaboration

- **Implementation Status:** Some States are already collaborating through regional safety oversight organizations (RSOOs).
- **Challenges:** Smaller States noted difficulty in sustaining collaboration without external support.

Action Item 59/13 – Enhancing Safety Management Systems (SMS)

- **Implementation Status:** Mixed progress—some States have mature SMS frameworks, others are still developing.
- **Requests for Assistance:** Support needed for training, guidance materials, and system integration.



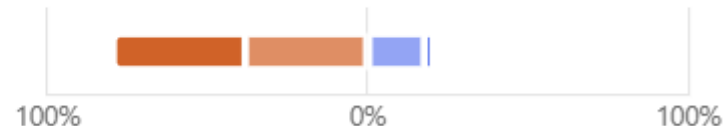

General Support: Most States noted and supported the action item.

- Many States showed interest in joining the Data Analytics Group (DAG) and the Asia Pacific ANSP Committee (AAC).
- Some are already participating or planning to engage.

Implementation Challenges:

- Timing and funding constraints were commonly cited as barriers to participation.

Requests for Assistance:

- Several States requested technical or financial support to enable effective involvement in regional ATM initiatives.

General Support: Many States noted and supported the action item.

- **Implementation Status:**

- Some States have completed upgrades and maintenance of conventional ground-based navigation aids.
- Others marked the item as not applicable or requested assistance.

- **Requests for Assistance:** Several States asked for technical support to implement detection, mitigation, and reporting systems.



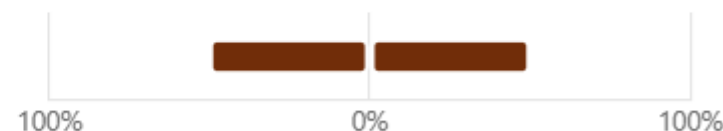

Value of Information Sharing: States like Vanuatu emphasized that such a workshop would be productive for sharing experiences and enhancing regional understanding of GNSS RFI mitigation.

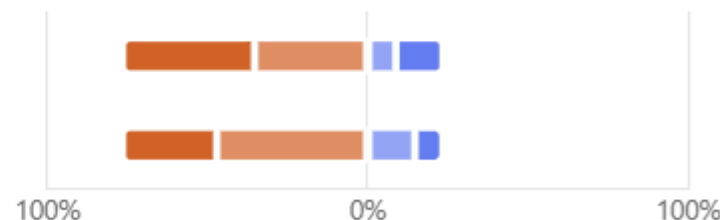

Action Item 59/16 – Implementation of APAC eANP Volumes I, II, and III

Focus:

- **General Support:** Most States supported the action item.
- **Implementation Status:**
 - Some States have already implemented or are in the process of aligning with the eANP.
 - Others are reviewing the requirements or awaiting further guidance.
- **Requests for Assistance:** A few States requested technical support for implementation and compliance.

Action Item 59/17 – Support for APAC Seamless ATM Plan

- **Focus:**
 - **General Support:** Broad agreement on the importance of seamless ATM.
- **Implementation Status:**
 - Some States are actively implementing elements of the plan.
 - Others are in early planning stages or require assistance.
- **Challenges:** Limited resources and technical capacity were cited as barriers by some States.

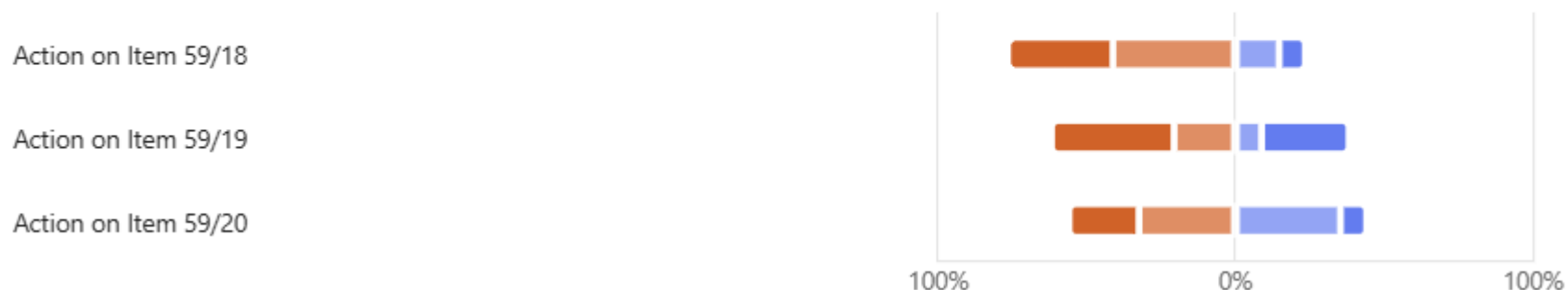

Action Item 59/18: States supported digital transformation in aviation security but requested ICAO assistance due to limited implementation progress.

Action Item 59/20: Strong support for PNR/API implementation, though many States need ICAO help to meet technical and regulatory requirements.

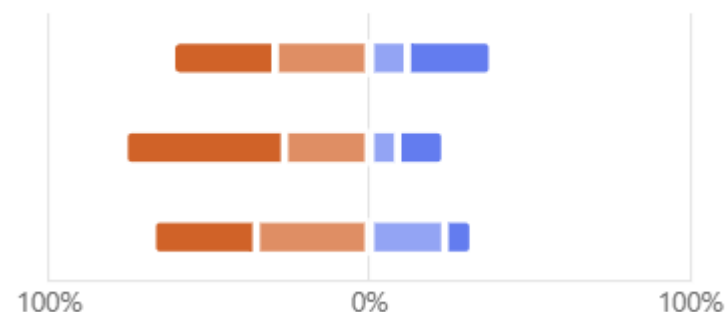

Action Item 59/21: States supported the development of aviation cybersecurity frameworks but emphasized the need for ICAO guidance and capacity-building support.

Action Item 59/22: There was strong backing for cybersecurity collaboration, with several States requesting assistance to implement effective national-level coordination mechanisms.

Action Item 59/23: States welcomed the ICAO Cybersecurity Action Plan and called for continued regional workshops and technical support to aid implementation.

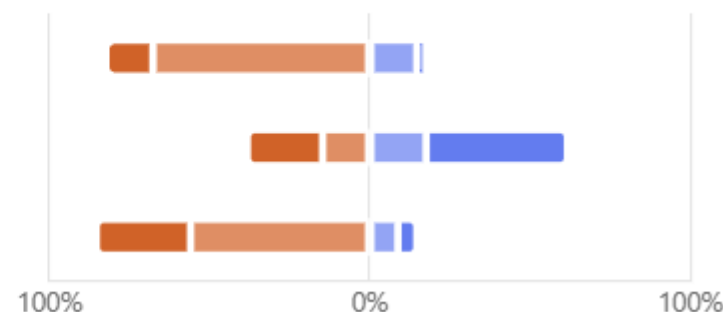

Action Item 59/24: States supported the development of national aviation cybersecurity strategies and requested ICAO assistance for policy guidance and implementation tools.

Action Item 59/25: There was strong support for establishing national cybersecurity oversight frameworks, with several States highlighting the need for capacity-building and regulatory support.

Action Item 59/26: States welcomed the promotion of cybersecurity culture and training, emphasizing the importance of ICAO-led workshops and awareness programs.

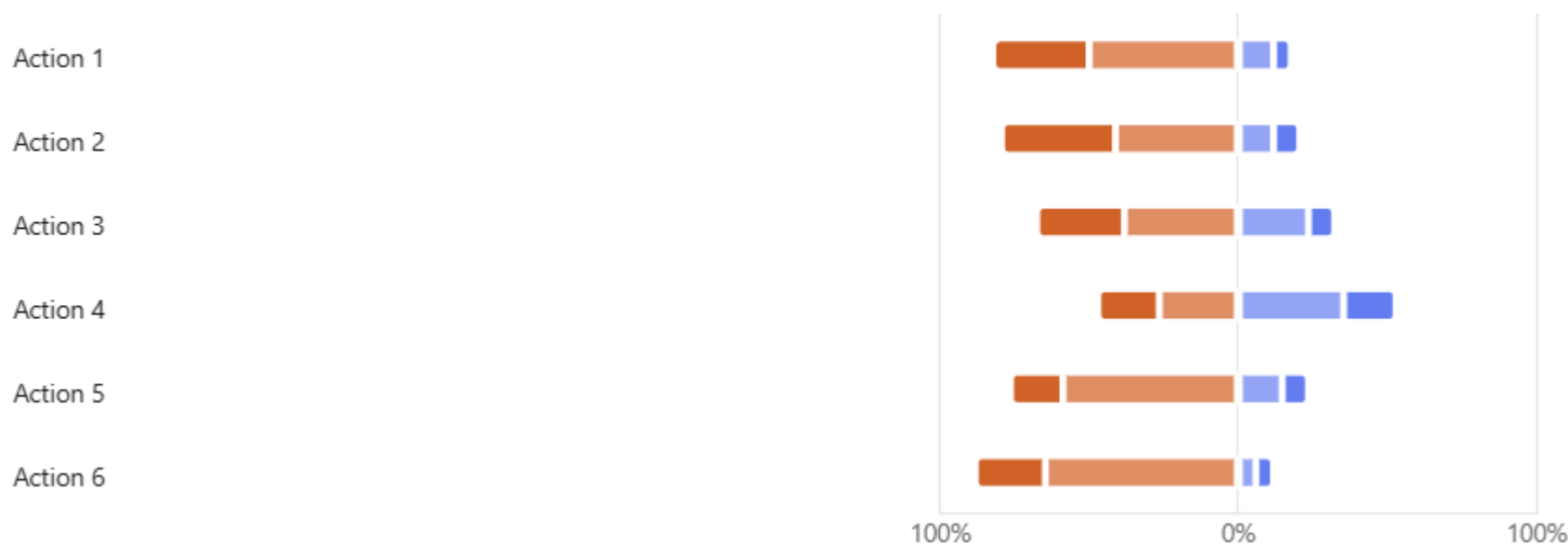

Action 1: Several States have expressed support for the ICAO Long-Term Aspirational Goal (LTAG) and the global framework for SAF/LCAF. While some have already submitted their State Action Plans, others are still in the early stages and have requested assistance to begin implementation.

Action Items Status (cont'd)

- Action Item 59/27

Action 2: Engagement in the ICAO ACT-SAF program is ongoing, though participation remains limited. Many States are still in the early phases of SAF development, with some yet to initiate concrete steps toward production or policy support.

Action 3: A number of States have submitted updated and quantified State Action Plans, while others are still in the process of developing or revising theirs. Continued support and guidance are needed to ensure broader participation and timely submissions.

Action 4: Voluntary participation in CORSIA has seen mixed responses. Some States have already notified ICAO of their involvement, while others are still evaluating the program or require additional support to make a decision.

Action 5: Implementation of CORSIA and participation in ACT-CORSIA is progressing, though unevenly. Several States have requested technical and financial assistance to meet the program's requirements and enhance their capacity for compliance.

Action 6: Participation in ICAO environmental events has been generally supported in principle. However, actual involvement often depends on the availability of funding and scheduling feasibility, with some States highlighting the need for logistical support.



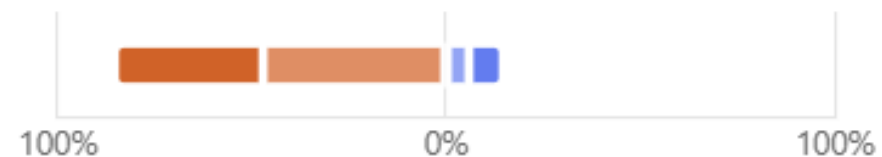

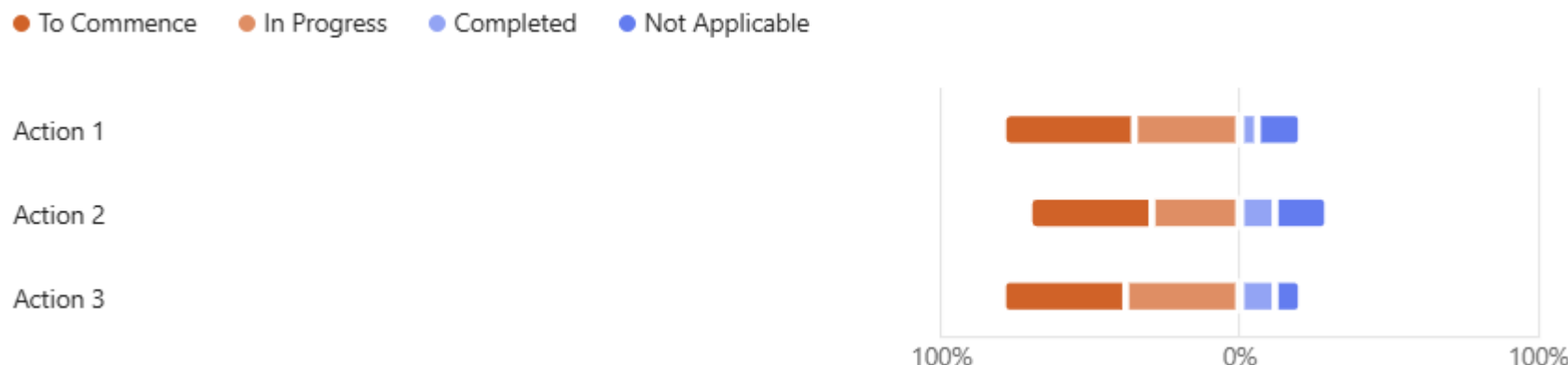
Action Item 59/28: States supported the development of a regional aviation security and facilitation plan and emphasized the need for ICAO coordination and guidance to ensure harmonized implementation across the Asia-Pacific region.

Action 1 – Reporting on CAAF/3 Progress and Challenges:

States noted and supported the action, with some States indicating they are in the initial stages of achieving these objectives and requested assistance.

Action 2 – Sharing SAF Best Practices and Conducting Seminars:

There was general support, but many States emphasized the need for technical and financial support to organize or participate in SAF-related seminars and knowledge-sharing activities.

Action 3 – Establishing National SAF Policies:

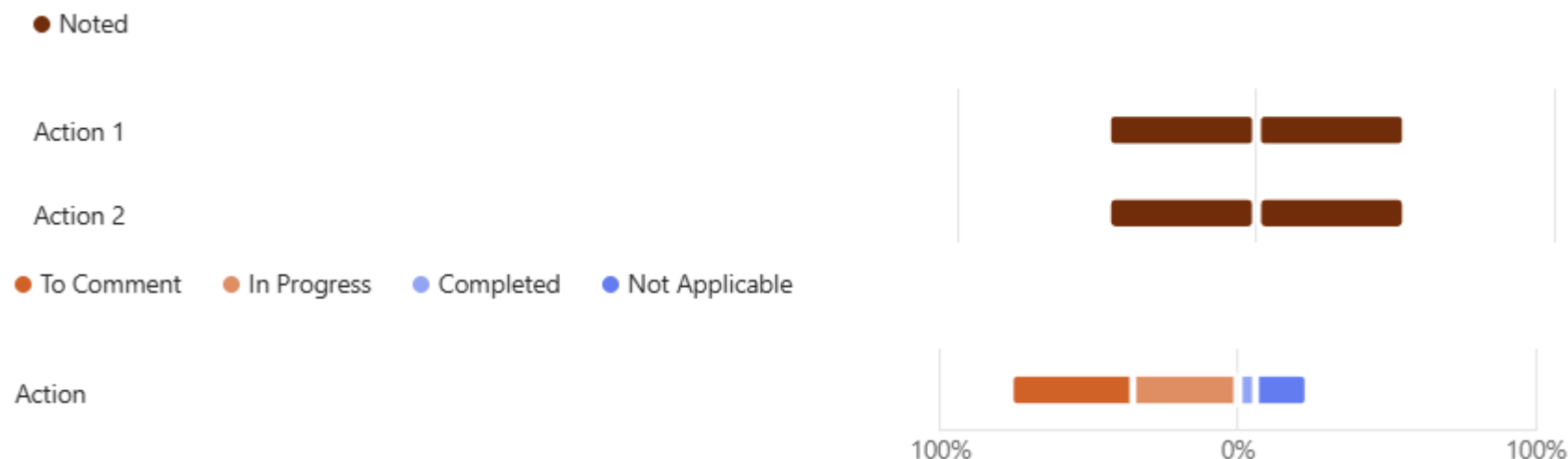
States acknowledged the importance of national SAF policies but highlighted that policy development is still underway in many cases, and guidance from ICAO would be beneficial.
