It is my honor to extend an invitation to your State/Organization to take part in the upcoming **Webinar on the Implementation of Free Route Airspace** (**FRA**) in the Asia-Pacific (APAC) Region to be held virtually from **15 to 16 September 2025**.

The successful implementation of FRA in air traffic management (ATM) presents a valuable opportunity to enhance the efficiency of civil aviation operations while contributing positively to both economic growth and environmental sustainability. With expected air traffic growth in the Asia-Pacific region, FRA implementation continues to be a strategic priority, as outlined in the APAC Seamless ANS Plan.

- To support the development of procedures and training needed to transition toward FRA.

The webinar is intended for personnel from Air Navigation Service Providers (ANSPs), Civil Aviation Authorities, Airlines, Military Authorities, Airspace Planning Experts, ATM System Providers, and other relevant International Organizations.

States are encouraged to participate in the webinar, and to share the best practices and lessons learned about the implementation of FRA implementation.
