SUMMARY

This Paper presents the proposed RASG-APAC 2025/2026 Yearly Work Programme.

1. INTRODUCTION

1.1 The RASG-APAC's Terms-of-Reference call for the development and implementation of a Work Programme that supports a regional performance framework for the management of safety. To prioritise work on the various safety initiatives, RASG-APAC/2 introduced a Yearly Work Programme which is the list of Decisions and Conclusions arising from the Working Papers and Presentations and approved by the RASG-APAC which will be worked out by the relevant Sub-Groups and ICAO within the time span of subsequent RASG-APAC meeting. The Open items shall be carried forward to the next yearly work program for continuity.

2. DISCUSSION

Proposed Work Programmes for 2025/2026

- 2.1 The RASG-APAC 2024/2025 Yearly Work Programmes had three items, where all three Tasks are Proposed to be Closed as the Delhi Declaration has replaced the Beijing Declaration in Task-1, The AP-RASP Road Map under Task-2 will have a Revision for next Triennium (2026-2028) and Task-3 for AIG tasks will also be revised in the upcoming version of AP-RASP 2026-28.
- 2.2 The similar three Task which are continuous in nature will be captured in the Proposed Yearly Work Program 2025/26 and continue to work on the new Tasks arising from 1) Delhi Declaration 2) AP-RASP 2026-28 Roadmap and 3) Consolidated AIG related Tasks arising from AP-RASP 2026-28 Roadmap as shown in **Attachment A**.
