OUTCOMES OF SWIM TF Task Leads (TLs) MEETINGS AND JOINT CRV OG ADHOC EXPERT GROUP AND SWIM TF TLS MEETINGS AFTER SWIM TF/9

(Presented by the Secretariat)

SUMMARY

The paper presents outcomes of SWIM TF TLs Meetings and Joint CRV OG Ad hoc Expert Group and SWIM TF TLs Meetings after SWIM TF/9 meeting held in 2024-2025.

1. INTRODUCTION

1.1 The Ninth Meeting of the System Wide Information Management Task Force (SWIM TF/9) was held from *14 to 17 May 2024* in the ICAO Asia and Pacific Regional Office, Bangkok, Thailand. The Meeting was attended by **110** participants from **18** States/Administrations, **4** International Organizations and **2** industry partners. - 1.2 As an established effective practice in progressing various tasks of the SWIM TF, online Task Leads (TLs) coordination Meetings have been organized from time to time between Task Force Meetings to follow up on the progress of each task more effectively and better understand the regional information exchange requirements to be supported by APAC SWIM as well as the feasible and appropriate approach to establish SWIM over the regional network.
- 1.3 Additionally, the CRV OG Ad-hoc Group Meeting held on 2 June 2022 discussed the need for combined Meetings of CRV OG and SWIM TF to discuss the expectations of SWIM TF from the CRV network. Since then, the joint quarterly meetings have been organized since 2022.
- 1.4 This paper shared information about the outcomes of the SWIM TF TLs Meetings and Joint CRV OG Ad hoc Expert Group and SWIM TF TLs Meetings after SWIM TF/9.

2. DISCUSSION

SWIM TF Task Leads coordination Meetings after SWIM TF/9

2.1 A total of **two** (2) SWIM TF Task Leads coordination Meeting was held after SWIM TF/9 to review the outstanding SWIM TF/7 and SWIM TF/8 action items, which included relevant

SWIM updates such as APAC SWIM implementation roadmap, SIPG and editorial ad-hoc group updates, joint events preparation, SWIM TI-related specifications, etc. The Minutes of the Meetings (MoM) of the two Meetings on 13 August 2024 and 07 January 2025 were shared with SWIM TF TLs. The reports are also provided in Appendix A and Appendix B.

Joint CRV OG Ad hoc Expert Group and SWIM TF TLs Meetings

- 2.2 A total of **four** (4) Joint Meetings of the CRV OG expert Ad-hoc group and SWIM TF TLs were conducted on **12 June 2024**, **17-20 September 2024**, **12 November 2024**, **and 13 March 2025**. Out of four meetings, the 17-20 September meeting was an in-person meeting, which was named the *ICAO Workshop for the preparation of new CRV requirements and specifications for future System Wide Information Management (SWIM)/other aviation services.*
- 2.3 The ICAO Workshop for the preparation of new CRV requirements and specifications for future SWIM/other aviation services was held from 17-19 September 2024 in Guam, USA. The Workshop was attended by 20 participants from Nine (9) Member States/Administrations and two (2) international organizations, namely, Hong Kong China, Fiji, Japan, New Zealand, Singapore, Thailand, Tonga, USA, Vietnam, CANSO, and ICAO. The Workshop reviewed the outcomes of the Joint event of SWIM over CRV Demonstration and Surveillance data over the SWIM Trial to be held from 28 May to 29 May 2024 in Hong Kong China and adapted lessons learned into new CRV technical specifications. The Workshop also deliberated on the current AMHS and other dataflows, planned future dataflows for SWIM messages, and modified new CRV requirements. The Workshop allowed APAC States/Administrations to formulate enhanced CRV specifications to meet future SWIM needs based on their experience in utilizing CRV. Lastly, the Workshop acted as a platform for the SWIM and CRV experts to collaborate to draft improved and efficient new CRV specifications to accommodate future aviation requirements. - Dr. Amornrat shared updates on the SWIM-related discussions at the CNS SG/28 Meeting, especially the way forward regarding information security.
- The Meeting was updated that registry interoperability is being discussed at the IMP under the SWIM Service Registry Interoperability job card and the SDS implementation specifications will be further discussed with the job card team.
- For the need to develop FIXM v4.3 Extension to support APAC regional operational requirements, AEROTHAI is examining the core version of FIXM v4.3. Based on the preliminary result, it was found that FIXM v4.3 Core can be used to support the exchange of ATFM information. However, an Extension would still need to be developed to support information for A-CDM and integrated ATFM/A-CDM operations. Detailed analysis will be provided by AEROTHAI as soon as the thorough investigation is finished.
- Task Leads were encouraged to update SOW and share the updated version with the ICAO Secretariat and Co-Chairs.
- To finalise the proposed APAC Common SWIM Information Services, SWIM TF presented a working paper WP/23 to the 19th Meeting of the ICAO AIS/AIM Implementation Task Force (AAITF/19) in June 2024. However, due to the difference in understanding regarding SWIM information services between AIS and SWIM experts, the AAITF Ad hoc group has been formed to finalise the details of SWIM Common Aeronautical Information Services proposed by SWIM TF.
- Dr. Amornrat presented the Common SWIM Flight Information Services related to FF-ICE to the core team of the FF-ICE Ad-hoc group. The FF-ICE Ad-hoc group plans to conduct a workshop in Q1/2025, in which a review of FF-ICE related SWIM Information Services is planned.

Agenda Item 3: Update on SWIM Implementation Pioneer Ad-hoc Group

- The Meeting discussed about crucial tasks required in-depth discussions among the SIPG members, one of which is the AFTN/AMHS-SWIM transition. The Meeting was informed that an ad-hoc group was established under the ACSICG to work on this matter. Considering the need to timely develop the transition plan to expedite SWIM implementation within the region, the Meeting agreed on the need for SIPG to work in close coordination with this ACSICG ad-hoc group. ICAO Secretariat informed that the ACISCG/12 Meeting is from 24-28 March 2025.
- To efficiently progress the work of SIPG, including planning toward SWIM transition, it
 was concluded that there is a need to conduct a SIPG F2F working session in January
 2025 at the ICAO APAC Office or Singapore. The ICAO Secretariat will share further

 - The hierarchy approach included Gateway EMS, Edge EMS and End Users has been evaluated through the SWIM over CRV Demo.
 - We are planning to submit a working paper to the Coordinating Meeting to analyze the expected QoS for CRV to satisfy regional SWIM requirements based on the QoE of the demonstration.
 - To consider approaches transiting from AMHS to SWIM.



Agenda Item 2: Outstanding SWIM TF/7, SWIM TF/8 and SWIM TF/9 Action Items Review

- The meeting noted that for Action Item 8-8, *Request IMP members within APAC to consider presenting SDS to IMP WG/I-S and WG/G for further deliberation*, a paper, **SWIM Discovery Service Development in APAC** was presented to IMP/WG-I/S/2 from 27 February 1 March 2024 and IMP/WG-G/11 from 18 21 March 2024. The next step is to present details on the registry model analysis to the SWIM Service Registry Interoperability job card team under IMP WG-I/S. The teleconference for IMP WG-I/S is planned for Jan 2025, during which IMP members will present the information.
- The meeting noted that *Draft Decision CNS SG/28/02 (Decision SWIM TF/08/01)- Information Management Panel consider the adoption of SWIM Discovery Service as a Global Standard for Globally Interoperable Service Discovery* was adopted by APAIPIRG/35 as **Decision APANPIRG/35/6**.
- Recalling Action Item 9-3, evaluate FIXM v4.3's suitability to support ATFM, A-CDM, and integrated ATFM/A-CDM operations, the meeting was informed about ongoing actions. It was added that APANPIRG/35 adopted the FIXM 4.3 version as a standard format to support FF-ICE R/1 and cross-border ATFM operations From Q3 to 2026 in the APAC region by Conclusion APANPIRG/35/4.
- Dr Amo informed that after close coordination with Thailand operational experts, Thailand finished the evaluation of suitability and found that most of the data fields of the extension of FIXM version 4.1 and 4.2 will still stand except for the track messages. Thailand is developing the schema and expects to finish the development within this month. By February 2025, the XSD file will be shared with the interested testing parties of the TBO pathfinder project, and the test will be conducted in March 2025.
- Task Leads were encouraged to update SOW and share the updated version with the ICAO Secretariat and Co-Chairs before the SWIM TF/10 Meeting in May 2025.
- The Task 5 lead requested a meeting with SWIM TF co-chairs and other Task leads to discuss updates on Task 5 SOW. Dr Amo will schedule the meeting. **ACTION ITEM 2-1**


- Dr Amo shared key outcomes of the SWIM TF/CRV OG Coordination Meeting held on 12 November 2024.
- It was noted that the CRV OG Co-Chair offered to review the required functionalities for a sandbox to gauge the possibility of providing support in developing one.
- Additional updates provided:
- Meshed Network PCCWG has agreed to support the initial eight states planning on implementing an EMS via a meshed network using GRE tunnels. CRV OG needs to confirm the states and dates.
- Jitter PCCWG agreed to a 100ms jitter SLA.
- Pseudo CRV PCCWG agreed to retain Pseudo CRV until 31 March 2025. CRV OG Co-chair (Asia) has requested that this be maintained as is. They are happy to, but someone must pay for the costs. We discuss the opportunity to reduce the costs by lowering the SLA, i.e., 8/5 instead of 24/7, and other measures as well. They are going to provide pricing for discussion at OG13.
- SWIM Development environment. CRV OG Co-chair (Asia) discussed the concept with the Manager of Air Traffic Service Development (Software) and the CIO, and both agreed with the concept. CRV OG Co-chair (Asia) needs the requirements to investigate their ability to support this further. Dr Amo will share the list of requirements by the end of Jan 2025. **ACTION ITEM 2-2**



1. Mr Vaughan Hickford, CRV OG Co-Chair (Asia), Mr Kelepi Dainaki, CRV OG Co-Chair (Pacific), Dr Amornrat Jirattigalachote, SWIM TF Co-Chair, and Ms Kristin Cropf, SWIM TF Co-Chair, welcomed all delegates and shared opening remarks.

- Dr Amo shared key outcomes of the SWIM over the CRV demonstration. She informed that S3TIG
 demonstrated different scenarios including ATFM scenarios for regional ATFM improvement
 using SWIM Technical Infrastructure and SWIM information services and FF-ICE R1 on Pseudo
 CRV. It was informed that the demonstration went very well and no issues were observed with the
 performance of Pseudo CRV.
- 2. The meeting noted that Singapore and Hong Kong China are compiling lessons learned from the joint event. Hong Kong China informed that they are collecting surveillance data shared by all the data contributors on the pseudo-CRV. They can let CRV OG know the bandwidth used for surveillance data, which is the most bandwidth consumable data.
- 3. Vaughan informed that Pseudo CRV attributes are the same as CRV package D of operational CRV being used by States.
- 4. The meeting noted that in the joint event, Hong Kong China subscribed to 20 Mbps while other participating States subscribed to 2 Mbps.
- 5. It was noted that CRV circuits do not have any bandwidth restrictions. However, the last mile connection can impose some limits on enhancing the bandwidth of CRV circuits as the last mile connection is provided by a third-party service provider of respective States/Administrations on a contractual basis to PCCWG.
- 6. Dr Amo shared key outcomes of the SWIM TF/9 meeting. Xiaodong shared relevant content of the draft APAC SWIM TI profile for CRV OG experts' reference and feedback.
- 7. The meeting noted other key outcomes, including the request for guidance by SWIM TF/9 from CNS SG28 for the group responsible for information security provisions in the APAC region.
- 8. **CRV** data requirements for the SWIM workshop will be organized from 17-19 September 2024 in Guam, USA. To prepare for the workshop, Vaughan suggested SWIM TF TLs provide additional technical specifications shared through a form by CRV OG experts.
- 9. It was informed that the shared form was discussed among the Task Force task leads. The SWIM TF discussed the consideration of the bandwidth and the latency, but the determination of Jitter was difficult. Vaughan informed that Jitter is equivalent to frame delay in digital messages.
- 10. It was discussed that frame delay will depend on the safety criticality of the message, which is still under discussion. Therefore, providing information about this parameter may be difficult.
- 11. Vaughan informed about a free tool which can be used to estimate these paraments. Vaughan will share further guidance on the tool. **ACTION ITEM 6-1**

- 12. Dr Amo shared updates on SIPG work. It was informed that SIPG will continue to work for another year. Pseudo CRV may be discontinued soon, so SIPG is exploring other options to continue the current test.
- 13. The meeting noted that three options are being considered: 1. Pseudo CRV extension by PCCWG, 2. use of residual bandwidth of operational CRV, or 3. move current SWIM TI on the internet. If the use of residual bandwidth of the operational CRV option is selected, SWIM TF TLs will need the help and support of CRV OG experts. The third option required a massive amount of work from SIPG members. Some SIPG members cannot move to the internet due to State security

- 1. Dr Amo shared key outcomes of the *Workshop on CRV requirements for SWIM Services*. All action items of the workshop were reviewed, and updates on action items for which CRV OG was responsible were shared by CRV OG Co-Chair (Asia). The Meeting noted that action item 1-5 of the workshop is closed, while other action items are in progress.
- 2. It was discussed that the COM chart shows the interconnection of various ANSPs in the APAC region. However, it does not reflect which type of network it is using. It was recalled that the ATN Infrastructure table on the CRV portal contains CRV interconnection information. ICAO Secretariat shared that the AMC COM chart has information about New PENS. The ICAO Secretariat will coordinate with AMC to check if CRV network information can be added to the AMC portal. ACTION ITEM 7-1 In addition, it was suggested to download svg file of the COM chart from the AMC portal and try to generate an editable COM chart. Singapore will support generating editable COM charts. ACTION ITEM 7-2
- 3. Dr Amo summarized key outcomes and lessons learned from the SWIM working session.
- 4. CRV experts shared information about how CRV experts provided CRV implementation support to implement CRV during the initial phases of the project.
- 5. The Meeting discussed that each SWIM-capable State has its own SWIM Testbed.
- 6. SWIM TF is interested in developing or purchasing a SWIM Sandbox tool for APAC States/Administration, which can be used to test SWIM in a lab environment. It will help States understand the benefits of SWIM. However, the funding and process required for tool acquisition required further discussion.
- 7. CRV OG Co-chair (Asia) said they have done virtualization work in their corporate operational and secure monitoring spaces. They can host the sandbox if detailed requirements can be shared. Dr Amo will send a list of the functionalities expected from the SWIM sandbox. **ACTION ITEM** 7-3

- Outcomes of SWIM Working Session- 6-8 November 2024
- 1. Vaughan shared key outcomes of the *CRV OG/13*, along with the latest status of the *CRV* contract management process. The timelines of the *CRV II RFI* process were shared with the Meeting.
- 2. The updates about the cost of Pseudo CRV discussion with PCCWG in CRV OG/13 were shared. SWIM experts noted two costs with and without SLA, and that cost is higher in terms of CRV OG/13. Various options discussed in CRV OG/13 to retain Pseudo CRV were shared with SWIM experts. PCCW Global shared their willingness to extend Pseudo CRV till June 2025 to facilitate CRV OG to conduct discussions with SWIM TF.
- 3. SWIM TF noted that Japan shared a request with PCCW Global to prepare a document explaining the configuration of Pseudo CRV to make States understand this network along with the procedure to request connection to this network. It was agreed that this document would be beneficial for States. PCCW Global will draft the document and share it in the next CRV OG Ad-hoc Group meeting on 12 June 2025.
- 4. David shared that there is a need to maintain the pseudo-CRV because SIPG has some states that have categorically stated that testing over the Internet is going to be difficult for them. Discussion on how a contract will be made with PCCWG for Pseudo CRV was discussed.
- 5. Vaughan informed that there is a need to discuss with PCCWG what the contract looks like because, at the moment, each State/Administration has signed up for a five-year contract and then a five-year contract. But now, as we get closer to the contract date, the maximum we can sign for is three years.
- 6. CRV OG experts requested SWIM TF to do an offline discussion and share expected timelines for the setup and future plans with SWIM TF for Pseudo CRV in the first week of April 2025. ACTION ITEM 8-1
- 7. SWIM TF experts asked if individual negotiation or collective negotiation would be possible if required with PCCWG. CRV experts suggested collective negotiation, including information on how many states will need this service and for how much time. SWIM TF experts will share information for further negotiations by CRV OG. **ACTION ITEM 8-2**
- 8. Singapore informed that if Pseudo CRV can be implemented on the Cloud, then **AWS** is **preferred**.
- 9. Vaughan informed that the CRV service provider would not provide internet connectivity.
- 10. David informed that Option 3 was asking the CRV to provide the Internet connection to SWIM, and if that's not possible, then SIPG will have to explore **Options 1 and 2**.
- 11. Vaughan asked how the EMS for SWIM is going to physically connect to the CRV. Singapore informed that as per Singapore's architecture Singapore has two EMS: one for connecting to the CRV and one for Internet. Basically, these are two independent but talking EMS, so they talk to each other, but they're not connected, and they route traffic between each other. Singapore is thinking of setting up the queues properly. The messages that come from the CRV that is bound

for a destination on the Internet can then be routed between the two EMS out to the Internet and vice versa.

- 12. On the question of whether EMS, which is CRV-connected, is connecting to the CRV router directly, Singapore informed that there is Security architecture in place. To route the two, there's a third EMS, which is an internal EMS. So, the traffic comes in from the CRV through a security architecture into our intranet EMS, which is then routed back. Essentially, the Internet EMS is separated from the CRV EMS by two sets of security infrastructure, with a third EMS in between.
- 13. Vaughan suggested doing routing at the network to route the traffic rather than EMS. Singapore informed that SIPG is not doing IP-based routing but message routing, which is in layer 7.
- 14. On the question of SWIM about security architecture for CRV, Vaughan informed that in CRV, each state or user is responsible for the security architecture. CRV OG has not set a minimum of requirements, but it is as per Singapore's description in New Zealand, and some other states have something very similar as well. In addition, CRV OG is not looking to add any more security requirements to the network architecture.
- 15. SIPG informed that they need to discuss in SIPG some security requirements in CRV in case they choose Option 2.
- 16. Vaughan suggested using CIS hardening guidelines, which will be shared by Vaughan. **ACTION ITEM 8-3**
- 17. The Meeting suggested preparing a joint paper for the proposal to form a PKI infrastructure implementation contributory body in CNS SG/29, along with some other recommendations, rationale, and suggestions. **ACTION ITEM 8-4**
- 18. For hosting the sandbox, detailed requirements will be shared by Dr Amo, who will send a list of the functionalities expected from the SWIM sandbox. **ACTION ITEM 8-5**
