SUMMARY

The Meeting is invited to decide and agree on the duration, tentative dates, venue for the next meeting and Provisional Agenda.

1. INTRODUCTION

1.1 In accordance with the APANPIRG Procedural Handbook, Part IV, Section 3, the date and duration of meetings of a Sub-Group of the APANPIRG shall be decided by the Chairperson in consultation with Members and Secretary of that Sub-Group. AOP Sub-Group is expected to decide in every meeting the date, duration and venue of the next meeting.

2. DISCUSSION

2.1 It may be recalled that APANPIRG/1 Meeting (1991) had decided that APANPIRG should meet once a year in order to allow the contributory bodies to review the various air navigation challenges in the Asia/Pacific Region at regular intervals and recommend solutions.

2.2 Further it had been agreed earlier, that APANPIRG Meetings should be scheduled taking into consideration the ANC/Council Programme, so that the review of APANPIRG Reports by the ANC/Council could be completed without delay, thus facilitating timely follow-up action by the States and the Secretariat.

2.3 Taking into consideration the work programme of the AOP Sub-Group and the schedule of APANPIRG/38 Meeting, the Sub-Group may wish to hold AOP/SG/11 Meeting in June/July 2027 with duration of 4-5 days. The venue proposed is ICAO APAC Office, Bangkok unless a State is willing to host the meeting.

2.4 The Meeting is also invited to review the Provisional Agenda for the Eleventh Meeting. A suggested Provisional Agenda is placed at **Attachment A** for consideration.
