ATM POINTS OF CONTACT

SUMMARY

This paper presents the current ATM Points of Contact listed at the ICAO Asia/Pacific Regional Office, and requests that administrations update this information as required.

1. INTRODUCTION

1.1 Since 2005, the ICAO Asia/Pacific Regional Office has maintained a contact list to operational safety matters in accordance with the following APANPIRG Conclusion:

Conclusion 16/62 – State focal point for safety-related activities

That, Asia/Pacific States notify to the Regional Office by the first quarter of 2006 a responsible contact officer or position to act as a focal point for safety related activities and in particular for the submission and coordination of ATS incident reports.

2. DISCUSSION

2.1 APANPIRG Conclusion 16/62 required the nomination by States of a contact officer or position to act as the Point of Contact (POC) for Air Traffic Services (ATS) safety-related activities and in particular for the submission and coordination of ATS incident reports and for the rectification of ATS operational deficiencies.

2.2 From time to time, the ICAO Asia/Pacific Regional Office needs to contact State aeronautical authorities on issues including but not limited to ATM contingency planning and response (*ICAO Annex 11 Attachment C* refers), disaster management coordination, non-routine intervention and support necessitated by uncoordinated hazardous activities, ATS routes and airspace or other air navigation services (ANS) aspects of the Regional Air Navigation Plan, Aeronautical Information Services (AIS) and Search and Rescue (SAR) matters.

2.3 The ATM Points of Contact List is a consolidated resource, including:

- a) Administrative (ADM)
- b) Airport Collaborative Decision Making (A-CDM)
- c) Aeronautical Information Service (AIS)
- d) Asia/Pacific Region ATS Route Catalogue (ARC)

- e) Air Traffic Control (ATC)
Civil-Military Cooperation
- f) Air Traffic Flow Management (ATFM)
- g) Contingency Coordination Team (CCT)
24-Hour Operational Support
- h) Safety - Airspace Safety Monitoring and FIT (SAF); and
- i) Search and Rescue (SAR).

2.4 The ATM Points of Contact List will be separately circulated by the Secretariat to all registered participants for update.

2.5 The meeting is invited to review and update the ATM Points of Contact List (**Appendix A**), notifying any changes by email to apac@icao.int, with a courtesy copy to pchalayonnawin@icao.int.
