I wish to invite your State/Administration to participate in the **Fifteenth Meeting of the Common aeRonautical Virtual Private Network Operations Group (CRV OG/15)** hosted by India.

The CRV OG/15 meeting is organized to discuss key matters related to CRV operations, including CRV OG Reference documents, CRV Governance, the regional SWIM technical infrastructure over CRV, interregional IP network connections, and other relevant issues. The Meeting will also deliberate and decide key decisions related to CRV contract management. All Member States that have already implemented CRV are invited to share their experience with current CRV operations and implementation, bandwidth utilization, and performance to facilitate Member States contracting CRV and refining future CRV requirements.
