EXPLANATORY NOTES ON THE PROVISIONAL AGENDA

Agenda Item 1: Organizational Matters

The meeting will adopt its working arrangements, including Chairperson(s), Secretary, hours of business, and the agenda.

Agenda Item 2: Review of Outcomes from Relevant Meetings

The meeting will review outcomes from recent APANPIRG and MET SG meetings, including those of the MET SG contributory bodies (MET/IE WG and MET/R WG), as well as other relevant ICAO meetings.

Agenda Item 3: Air Navigation Deficiencies

The meeting will review the APANPIRG list of air navigation deficiencies in the meteorology field, including proposals to add or remove deficiencies. States concerned are invited to provide updates on corrective actions and progress achieved.

Agenda Item 4: Regional Guidance Material

The meeting will consider proposals to update existing or develop new regional guidance material to support States in the implementation of meteorological services for international air navigation.

Agenda Item 5: Planning and Monitoring

The meeting will review planning and monitoring activities related to the implementation of ICAO meteorological provisions. This will include consideration of proposed amendments to relevant ICAO Standards and Recommended Practices (SARPs), as well as ICAO global and regional plans and policies.

Agenda Item 6: Turbulence Information

The meeting will exchange experiences, best practices, and recent developments related to turbulence reporting, including how States obtain, produce, and share air-reports, and will identify any regional differences in practices.

Agenda Item 7: Aviation Exercises for Volcanic Ash and Meteorological Events

The meeting will review initiatives and proposals for developing and coordinating exercises that demonstrate the exchange of aeronautical meteorological information and aviation operational responses, with emphasis on volcanic ash and other high-impact, low-frequency meteorological hazards.

Agenda Item 8: Research, Development and Other Initiatives

The meeting will review research, development, and related initiatives—such as trials and demonstrations—that support States' implementation of ICAO meteorological provisions.

Agenda Item 9: Environmental-Related Initiatives and Impacts

The meeting will consider matters relevant to ICAO's environmental protection objectives, including meteorological initiatives aimed at reducing the environmental impact of aviation operations and information on the impacts of climate change on aviation.

Agenda Item 10: Future Work Program

The meeting will review and update the MET SG terms of reference and work plan, taking into account the outcomes of the discussions and ensuring continued alignment with APANPIRG objectives.
