Dear Sir/Madam,

I am pleased to invite your State/Administration to participate in the Tenth Meeting of the Spectrum Review Working Group (SRWG/10) to be held from **04-06 February 2026** in the ICAO APAC Regional Office, Bangkok, Thailand.

The SRWG/10 meeting is organized to discuss critical matters related to aeronautical spectrum utilization and protection. The meeting will review the progress on the tasks resulting from the ninth meeting of SRWG (SRWG/9) and other outstanding action items. The meeting will assess and update, as appropriate, the regional frequency management manual, VHF COM Frequency Allotment Plan and HF utilization for APAC. It will deliberate on using Frequency Finder (FF), frequency assignment issues in APAC states, frequency lists in the Region, and addressing frequency compatibility and interference in the Region. The meeting will also share national, regional, and global updates related to spectrum and discuss the future work programme, including frequency evaluation, implementation of 8.33 kHz separation, a frequency spectrum strategy for APAC, and other emerging issues relevant to aeronautical spectrum utilization. The provisional agenda of SRWG/10 is provided in **Attachment A**.

States/Administrations are encouraged to urge experts involved in aeronautical spectrum management and planning, as well as the designated contact persons in civil aviation responsible for the preparation of World Radio Conference (WRC) positions of States, to participate in the meeting.
