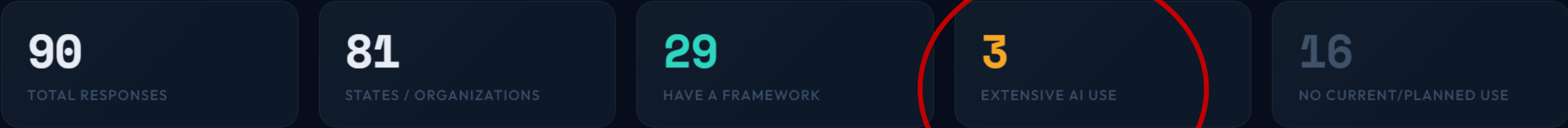

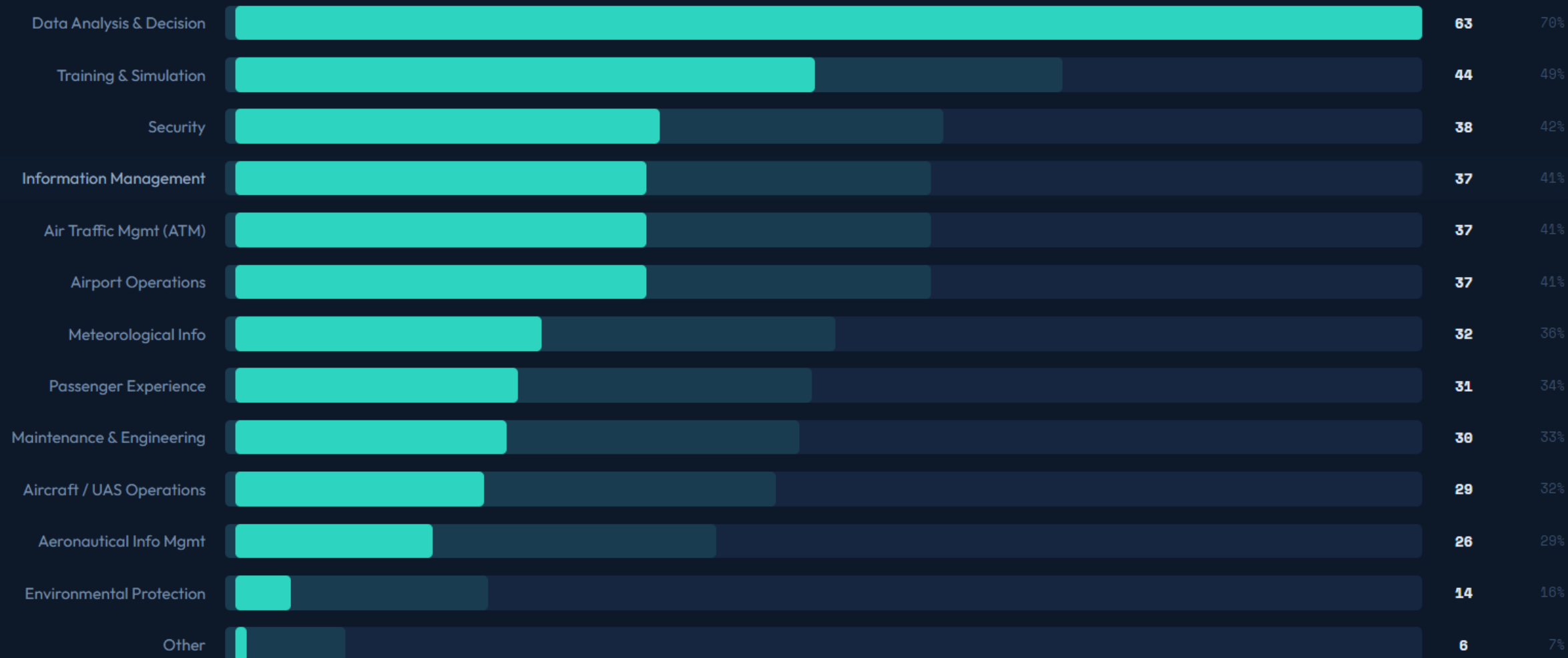

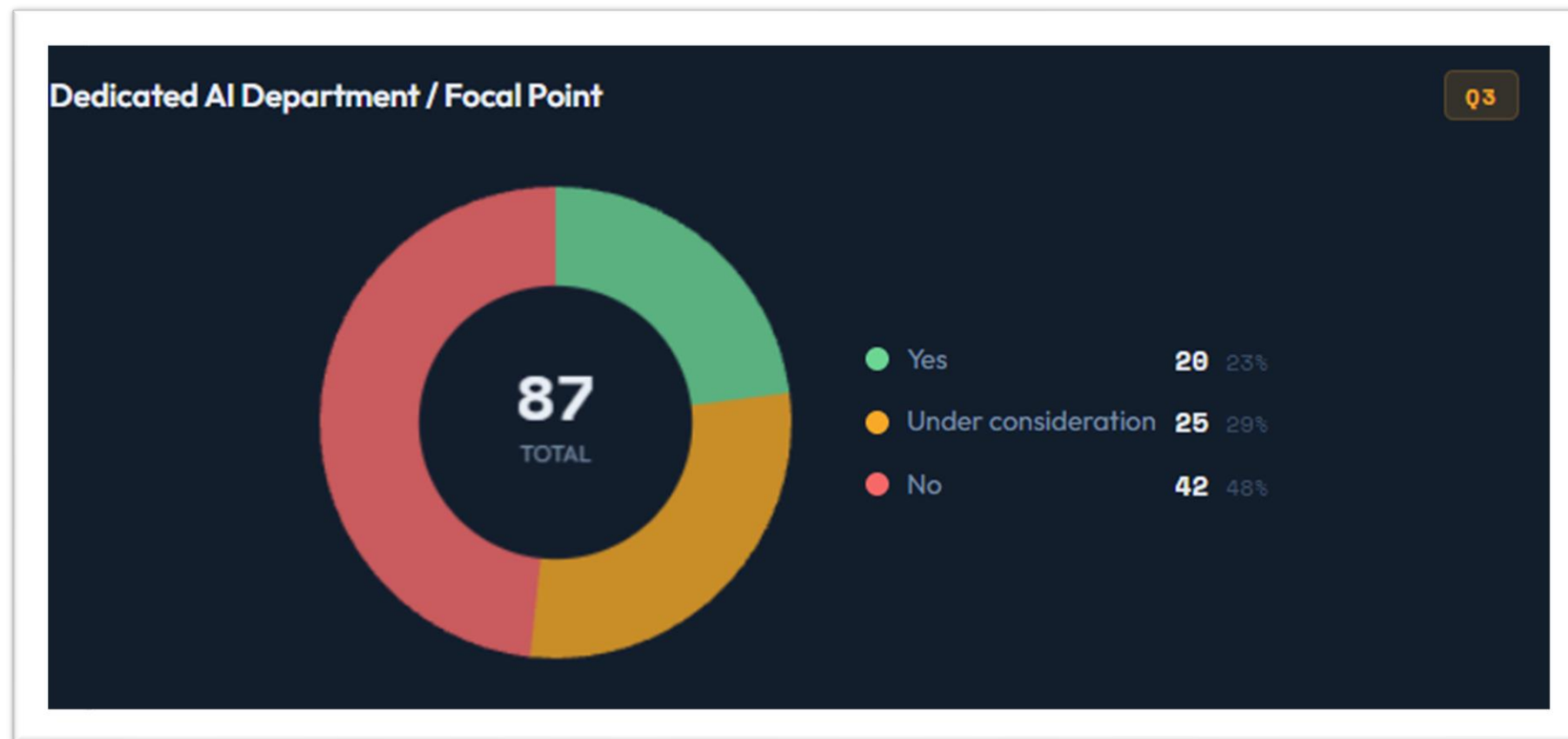


Aviation Domains Using AI (Q5 – select all that apply)

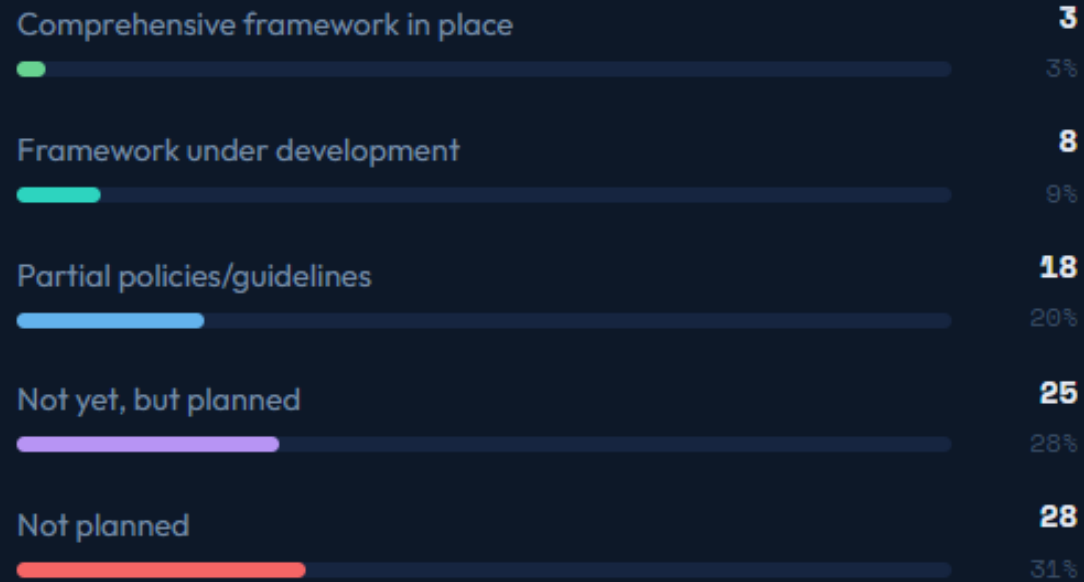

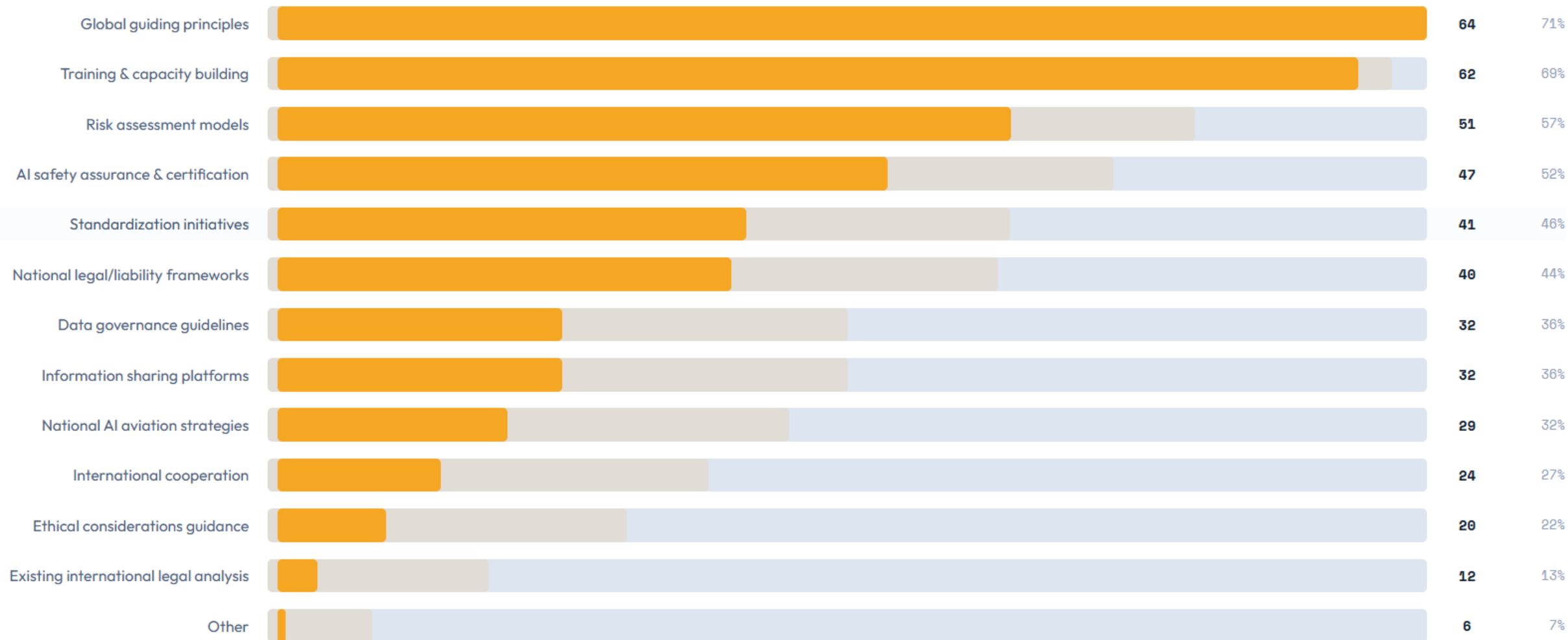

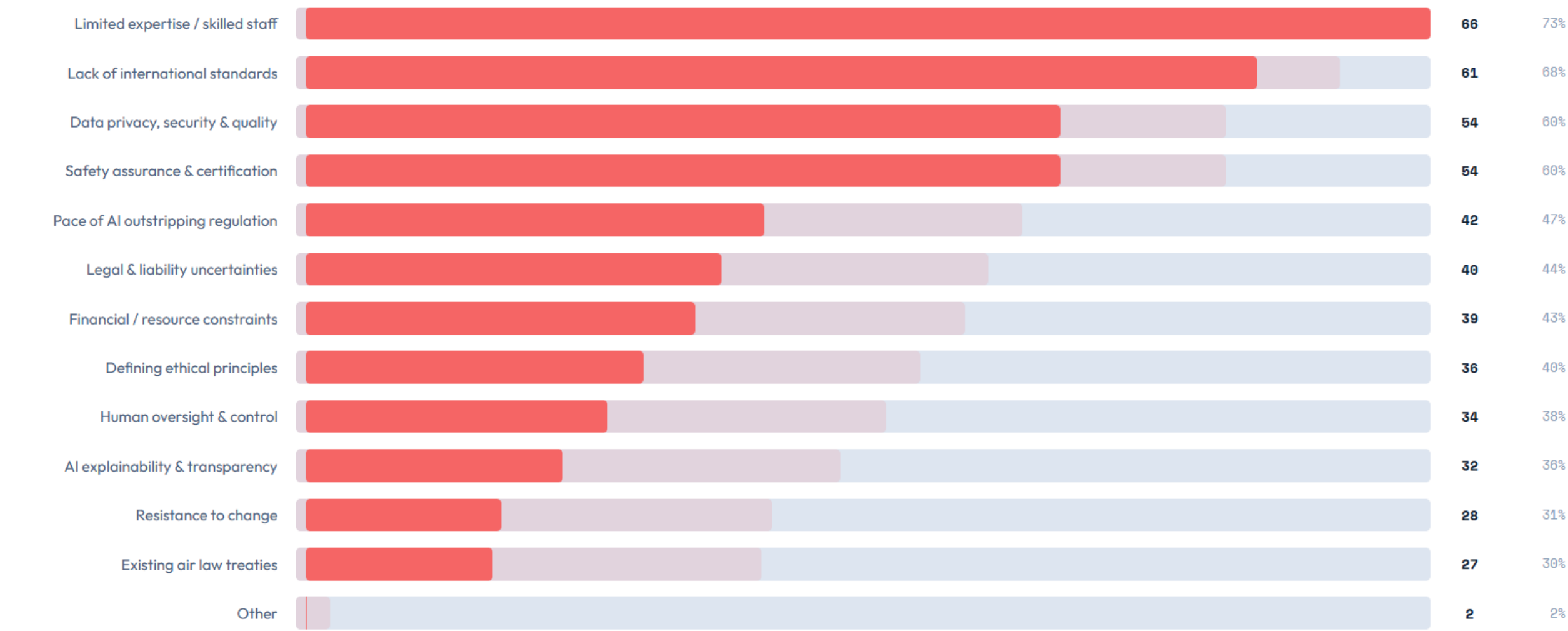
Top 5 Areas Where ICAO Support Is Most Needed (Q11)

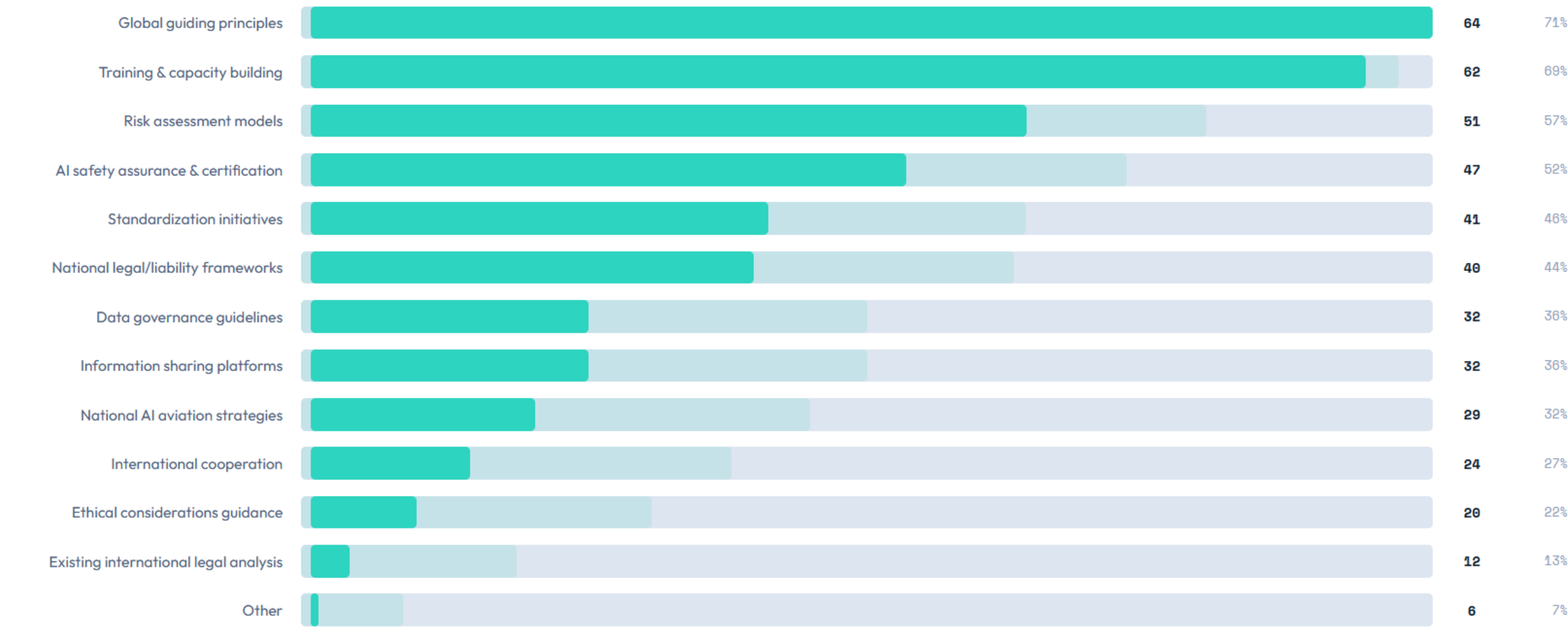
Most Significant Challenges (Q10 – ranked top 3)

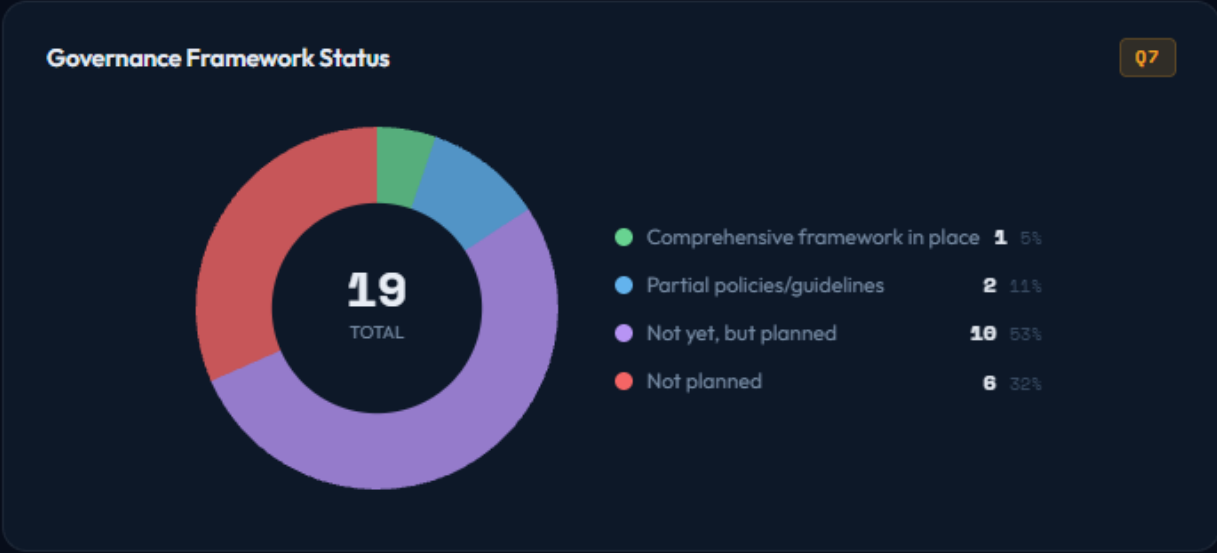

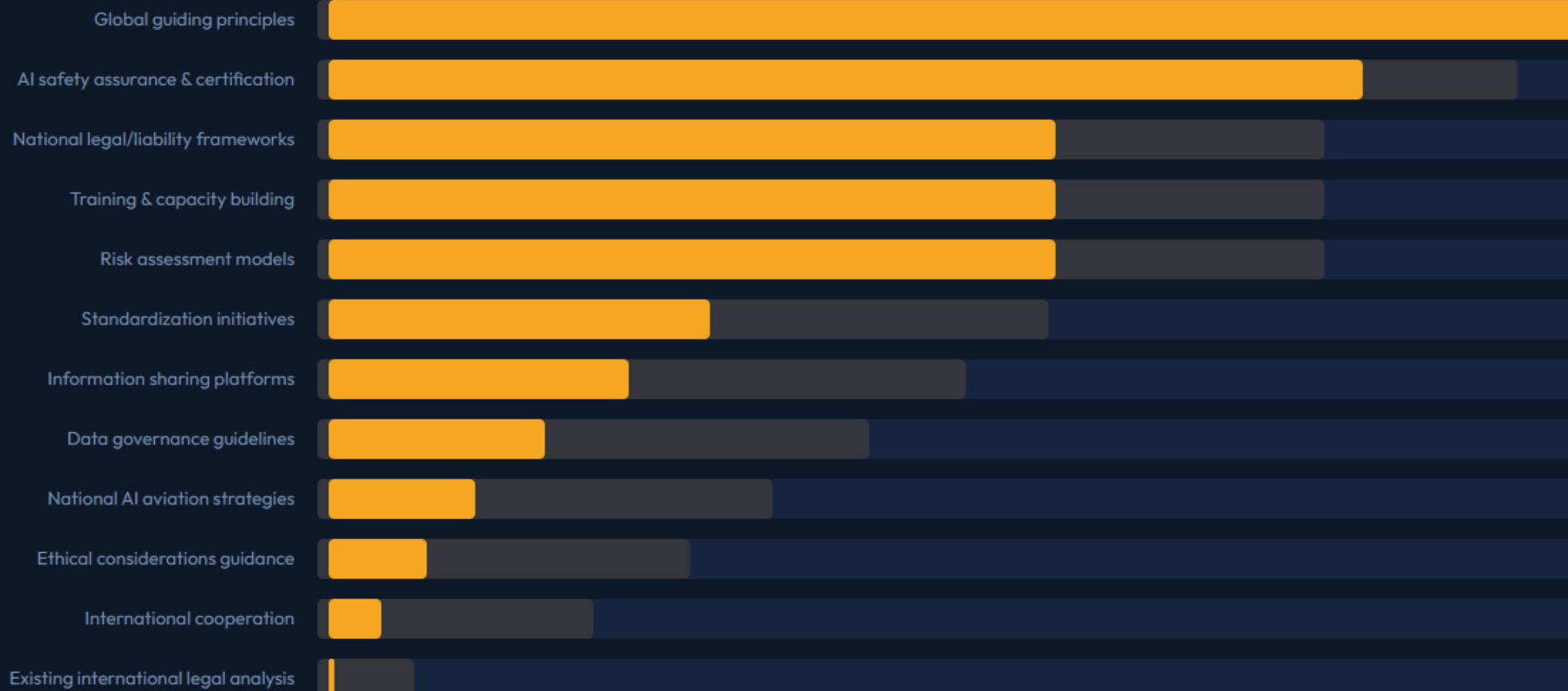

Top 5 Areas Where ICAO Support Is Most Needed (Q11)



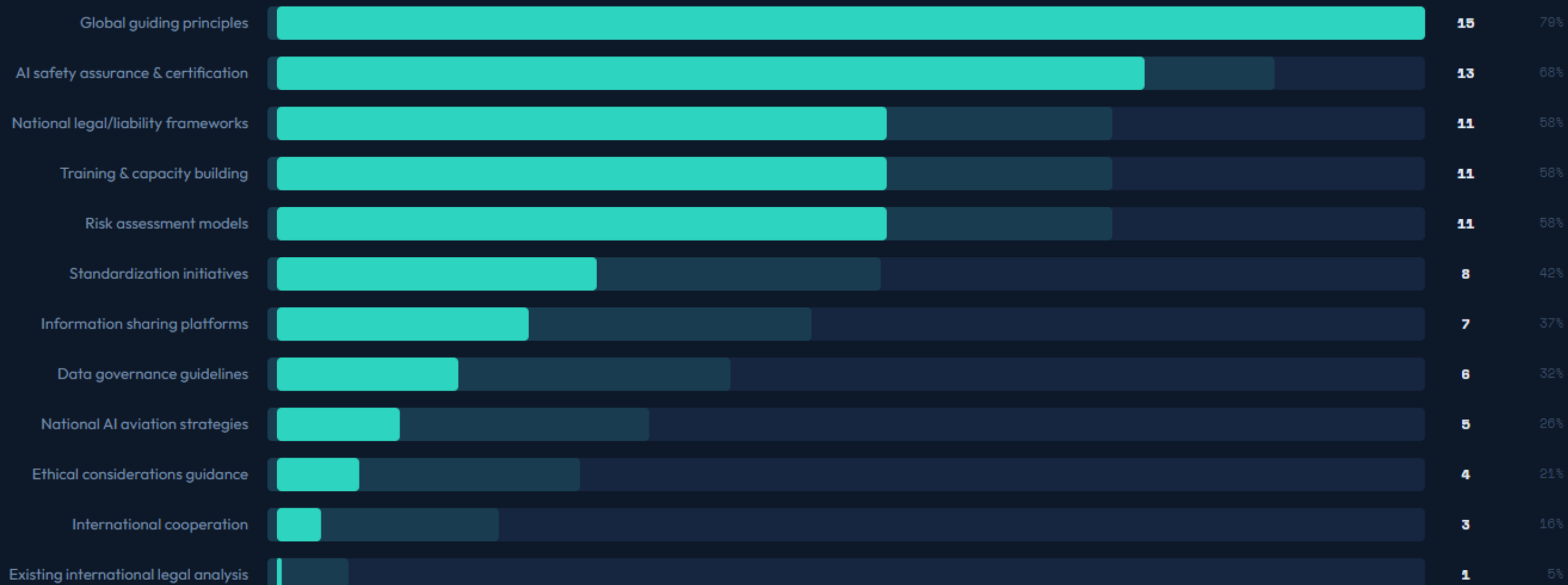

05 Summary of Key Outcomes



Current situation and future needs

1. Of the **81 States/Administrations** that responded to the survey, **29** have a governance framework, and **3** use AI extensively.
2. Of the **19 APAC States/Administrations** that responded to the survey, **3** have a governance framework, and **no one** uses AI extensively
3. Of the **3**, **China** has a **comprehensive governance framework**, while **Australia and Singapore** have partial ones.
4. **Data Analysis & Decision** is the most widely used domain for AI, while **Airport Operations** is the second most widely using AI.



Current situation and future needs

5. Global guiding principles and AI safety assurance & certification are two domains where States need ICAO support.
6. Lack of international standards, Limited expertise / skilled staff, Data privacy, security & quality and Safety assurance & certification are key challenges in using AI.
7. Global guiding principles and AI safety assurance & certification are key areas expected to receive ICAO support.
8. Most of the global and regional challenges are the same.
