SUMMARY

3. Summary of Discussions

Agenda Item 1 — Progress updates on the outcomes of the 4th PIRG and RASG-APAC Regional Coordination Meeting

3.1 The meeting noted the progress on the outcomes of the 4th APANPIRG RASG Regional Coordination meeting.

3.2 The meeting also noted that the Summary Report on APANPIRG/28 and RASG-APAC/7 Meetings was presented to ANC Working Group (SRP meeting) via video conference by the Regional Director on 8 November 2017. RASG-APAC Chairman, Mr. H. M. C Nimalsiri also participated in the video conference from Sri Lanka.

3.3 The Council in its 214th Session noted common challenges faced by Regions which were presented by ANC in its Working Paper. The Council approved actions to be taken by relevant HQ and Regional Offices to address those common regional challenges which are attached in **Appendix B** to C-WP/14758.

3.4 In order to address issues related to Civil/Military Coordination the meeting recommended that, in future, the Secretariat will send the State Letter to the Ministry in charge of Civil Aviation of the State in addition to respective CAAs.

3.5 The meeting was also informed about the first APAC Newsletter published in June 2018 and discussed that a dedicated page may be allocated for publication of an important information/news of the Member States or to provide a link to the respective State's Website.

Agenda Item 2 — Outcome of the First Asia/Pacific Ministerial Conference on Civil Aviation and Follow Up Action Plan

3.6 The Declaration on Asia/Pacific Ministerial Conference on Civil Aviation (Beijing Declaration), endorsed by the First Asia/Pacific Ministerial Conference on Civil Aviation (APACMC) held in Beijing, China from 31 January to 1 February 2018 was reviewed by the Meeting. The meeting also discussed Ministers' commitments on specific activities of safety and air navigation with the target dates for their implementation.

3.7 As follow-up action on Beijing Declaration, the Secretariat would review the Beijing Declaration objectives in 2020 in order to reflect, as required, any resolutions agreed to by the ICAO Assembly in 2019, including those on the endorsement of the new versions of the GASP and GANP, and initiate the organization of the Second Asia/Pacific Ministerial Conference on Civil Aviation in 2020 or thereafter.

3.8 Also, the Secretariat would make efforts to enable the continuous monitoring and annual reporting of the commitments in the Beijing Declaration, and request the RASG-APAC and APANPIRG to establish relevant goals and targets to monitor progress towards the fulfilment of the commitments, as follows:

- a) RASG-APAC and Asia Pacific Regional Aviation Safety Team (APRAST): on aviation safety, accident investigation and human resources development; and
- b) APANPIRG and its contributory bodies: on air navigation services and human resources development.

3.9 The RASG-APAC and APANPRIG, through the APAC Regional Office, would continuously report progress to the annual APAC DGCA Conference.

3.10 In order to discuss and develop concrete action plans on Beijing Declaration's Commitments during the 55th Conference of the DGCA in Fiji, the breakout sessions on following topics would be included in the programme of the 55th DGCA Conference:

- a) **Commitment on Aerodrome Certification:** Certification of all aerodromes used for international operations by 2020;
- b) **Commitment on Implementation of the Asia/Pacific Seamless Air Traffic Management (ATM) Plan by 2022:** Implementation of Air Traffic Flow Management (ATFM) /Collaborative Decision Making (CDM) for high density airports; and
- c) **Commitment on State Safety Programme:** Implement an effective State Safety Programme (SSP) by 2025.

Agenda Item 3 — PIRG/RASG – Way forward

3.11 The meeting was informed about ICAO planning on restructuring of PIRG & RASG for enhancement of these Groups (C-DEC 210/4 refers), including better alignment and harmonization of the groups' working mechanisms; the need to adopt a project-based methodology for the work they undertake; and means to increase effectiveness and efficiency of the groups. The Council decision (C-DEC 210/4) also called for a closer link between the PIRGs and RASGs and States' DGCAs as well as a revision of the groups' Terms of References to support all above points and enhance their working arrangements. The need to align the work of the groups as well as their organizational structures with the latest ICAO Global Plans, such as the Global Aviation Safety Plan which contains clear Goals and Targets for the RASGs. The integration of the groups' work programmes with the ICAO Business and Operational Plans, the need to increase efficiency and avoid overlapping of activities, mainly looking at a new format for PIRG and RASG meetings; and improved reporting by the groups to ensure the necessary information to Headquarters and enhanced monitoring to assess the groups' efforts in reaching their established goals and targets.

3.12 The Meeting agreed that further study and review of the proposal is required.

Agenda Item 4 — Empowerment to APANPIRG Sub-Group

3.13 The meeting was informed about an implementation of APANPIRG/26 Decision 65 on *Empowerment to APANPIRG Sub-Group* which was effective from 2017 meeting year to adopt Conclusions and Decisions on technical matters (especially those concerning guidance to States in the implementation of ICAO SARPs, GANP, RANP, Seamless ATM Plan) that do not have additional economic, environmental or political effects, which should be considered at a higher level at APANPIRG. The review of the empowerment to APANPIRG Sub-Group was done by the Small Working Group formed by APANPIRG/28 meeting and found that it has been working effectively as envisaged by APANPIRG. The similar empowerment policy may be considered in RASG-APAC for APRAST to make conclusions or decisions with respect to Safety Enhancement Initiatives (SEI) developed by APRAST. The Secretariat would prepare and present a working paper to RASG-APAC in this regard.

Agenda Item 5 — Lead Regional Group – Responsibilities

3.14 The meeting reviewed the lead regional group responsibilities assigned and agreed during previous coordination meetings, as shown in the table below.

Agenda Item 6 — Any Other Business

3.16 The meeting was informed of the establishment of the new Task Force based on the 54th DGCA Action Item 25, comprising members from Australia, China, Hong Kong China, Pakistan, Japan, Republic of Korea, Malaysia, New Zealand, Singapore, Thailand and United States of America, to focus exclusively on strengthening and evolving existing regional mechanism for regional cooperation, towards capability and capacity building and technical assistance.

3.17 The first video conference of the Task Force was held on 5th June 2018 and Mr. Tay Tiang Guan, Deputy Director General, Civil Aviation Authority of Singapore was elected as Chairperson of the Task Force.

3.18 The face to face meeting of the Task Force would be held on 1 – 2 August 2018 at the ICAO APAC Regional Office, where Draft TOR of the Task Force would be finalized.

Closing: APANPIRG Chair and RASG Chair thanked ICAO RO for organizing the coordination meetings. The Chairs extended full support necessary for future coordination.

ICAO Regional Director thanked the Chairs and Vice Chairs for their attendance and valued the coordination and support. With these remarks ICAO Regional Director closed the meeting.
