About This Document

Collaborative Decision Making (CDM) is the backbone of effective regional air traffic flow management (ATFM) and efficient air traffic management (ATM) operations. The APAC Bi-Weekly ATFM Web-Conferences are organized every two weeks and serves as a platform to enable regular information exchange and CDM among Asia/Pacific ANSPs. The web-conferences, participated by air navigation service providers (ANSPs) from States/Administrations in the region, include discussions on ATM resource status, traffic demand situation, weather outlook, expected or planned ATFM measures, and other information pertinent to air traffic operations around the region.

This ATM/ATFM Status Update document captures key ATM status, ATFM outlook, and other pertinent information from ANSPs participating in the bi-weekly web-conferences. It is designed to provide ATM situational awareness for the region. Information provided include, e.g., ATM status at various resources, ATS unit staffing levels, runway operations, and expected ATFM measures.

| Traffic Demand Situation | CAA Malaysia's implementation of Air Traffic Flow Management (ATFM) measures for flights to Langkawi Airport due to increased air traffic and congestion due to two daily airspace closure for airshows. These measures aim to manage the surge in demand, ensure operational safety amidst dynamic flight patterns, and manage potential strains on airport resources effectively. Normal AAR for Langkawi is 6 and the government approved for extra flights into Langkawi that make the demand increase up to 11 per hour. Therefore, Ground Delay Program (GDP) was developed to reduce traffic congestion. |
| Significant Weather Outlook | In May, the country's weather conditions are expected to be affected by the southwest monsoon phase. During the southwest monsoon period which usually starts from mid-May to September, thunderstorms and heavy rains are expected to decrease. |
| ATM Status | Across Malaysia, our Air Traffic Service (ATS) units consistently operate at maximum capacity. However, we anticipate a scheduled downturn in arrivals at WMSA (Subang) airport throughout the period from the 14th to the 20th of June, 2023. This temporary adjustment is due to airspace restrictions stemming from planned military activities. |
| ATFM Measure Outlook | <p>On the 18 May, 2023, Malaysia embarked on an operational trial of ATFM involving Langkawi, Subang, and KLIA airports. At present, our teams are actively engaged in conducting simulations for KLIA and Subang, which necessitate managing a high volume of both domestic and international air traffic. Consequently, our ATMFU has prioritized Langkawi as a pivotal training area. This includes issuing CTOT to aircraft in order to effectively balance airport demand and capacity in light of the twice-daily airspace closures due to airshows.</p> <p>Flight schedules collected from marketing sources, the National Slot Coordination Malaysia, and/or flight clearances are used to create strategic and pre-tactical demand profiles, which are then compared to flight plans filed prior to departure.</p> <p>In the event of airspace closure, AAR was reduced to 0. Due to aircrafts arriving after the closure will result in traffic congestion, they were provided with CTOT to meet</p> |
