RECORD OF DECISIONS, CONCLUSIONS AND RECOMMENDATIONS Of the 18th Meeting of the Steering Committee

16-18 May 2018 Hangzhou, China

SC1803 - Adoption of the Agenda

The Agenda of the Meeting was adopted with no changes. (Copy at **Annex I**).

SC1804 - Review of the Record of Discussion of the 17th Steering Committee Meeting

Upon completion of the review of IP1 the Steering Committee noted the actions taken.

SC1805 - COSCAP-NA Programme Progress Report - DP 2

Upon completion of the review of DP2 the Steering Committee confirmed the programme priorities and noted the progress made.

The Members addressed the prioritization of the Programme Objectives and associated Outputs as follows:

The assignment of priorities was based on the following criteria:

- 1) **High** Work to achieve the objectives will be continuous.
- 2) **Medium** Work to achieve the objectives will be carried out as time permits.
- 3) **Low** Little or no work will be carried out to achieve the objectives.

Immediate Objective 1

Assisting Members in meeting ICAO requirements where applicable including any deficiencies identified by the ICAO USOAP CMA activities have been fully corrected.

Steering Committee Priority - HIGH/Medium

Output 1.1

Action Plans, where needed, for correcting outstanding deficiencies, are prepared and implemented as appropriate.

Output 1.2

In response to ICAO's new USOAP CMA, assist Members in reviewing their implementation of SARPs and related safety oversight programmes; provide technical assistance to rectify deficiencies noted and engage suitable short-term experts as requested by Members.

Immediate Objective 2

Establishing a dedicated forum for coordination and cooperation among the Civil Aviation Authorities of Members, with the aim of the continued harmonization of regulations, policies and procedures related to safety oversight, improving safety standards, and applying accident prevention measures.

Steering Committee Priority - HIGH

Output 2.1

The Steering Committee of the COSCAP-NA, formally established by the programme, will have become the forum for flight safety in the North Asia Sub-Region. Given the maturity of the regulatory framework of the COSCAP-NA, harmonization initiatives will focus on new ICAO requirements as they are promulgated.

Output 2.2

In Phase IV and beyond, participation in Regional safety teams (APRAST and NARAST) will play a significant role in both pursuing and assisting in the implementation of the Regional Aviation Safety Group (RASG) approved safety recommendations.

Immediate Objective 3

Assist Members to have the capability to conduct safety oversight of air operators, maintenance organizations, aerodromes and air navigation service providers.

Steering Committee Priority - MEDIUM

Output 3.1

Where Members lack the capability to do safety oversight independently, provide assistance to Members for the conduct of surveillance, inspection and certification of air operators, maintenance organizations, aerodromes and air navigation service providers.

Immediate Objective 4

Assisting Members to have qualified safety oversight inspectors and technical personnel for the conduct of surveillance, inspection, testing, certification and regulation of flight operations, airworthiness, personnel licensing, aerodromes and air navigation service.

Steering Committee Priority - HIGH

Output 4.1

Provide ongoing support (initial and recurrent training) to Members as required.

Immediate Objective 5

Assisting Members to establish effective Safety Management Systems (SMS) in the area of Aircraft Operations, Aerodromes, Maintenance, Manufactures and Air Traffic Management, etc. as required by Annex 19.

Steering Committee Priority – HIGH/MEDIUM

Output 5.1

Regulations, standards and guidance material have been developed by Members to implement ICAO SARPs requiring service providers to implement SMS.

Output 5.2

Training programmes, seminars and safety surveys are conducted to assist Members' service providers with the implementation of SMS.

Immediate Objective 6

Assisting Members in implementing a State Safety Programme (SSP) commensurate with the size and complexity of the respective Member's aviation system.

Steering Committee Priority - HIGH

Output 6.1

Training programmes, seminars and evaluations are conducted to assist Members with the development of and implementation of their respective SSPs.

Output 6.2

Members have completed a gap analysis, in order to ascertain the existence and status of maturity of the components and elements of their respective SSP thereby promoting the development and implementation of a SSP that combines elements of both prescriptive and performance-based approaches to the management of safety.

Output 6.3

Members have developed an SSP Implementation Plan that describes how their organization will put into practice, in a sequential, principled manner, the processes, procedures and means that will allow the Member to discharge its responsibilities associated with the management of safety in civil aviation.

SC1806 - COSCAP-NA Work Plan 2018 - DP4

Upon completion of the review of DP4 the Steering Committee confirmed the proposed 2018 Work Plan with a change requested by ROK to move the proposed SMS training from August to late September.

Action(s) to be Taken:

ASC1806.1

The CTA is to finalize the Work Plan for 2018, adjust the proposed mission dates in consultation with Members and circulate for review, comment and confirmation as appropriate. The planned dates of delivery may have to be adjusted in consideration of the readiness of the new CTA but every attempt shall be made to provide the requested missions as planned.

SC1807 — Contributions and Budget - DP5

Following the discussions arising from the presentation of DP5 the Steering Committee:

"Approved the updated budget for 2018 and encouraged donors and partners to continue their contributions to the Programme, in funds and in-kind."

Action(s) to be Taken:

ASC1807.1

The CTA is to advise ICAO Montreal that the 2018 Budget as proposed by ICAO and contained in DP5 was approved by the Steering Committee

SC1809 Safety Management Update - DP7

Following the discussions arising from the presentation of DP7 the Steering Committee supported the following:

"That States are invited to share tools and examples which support effective safety management implementation to be considered for posting on the Safety Management Implementation (SMI) website."

Action(s) to be Taken:

ASC1809.1 The CTA will support Members as requested in submitting information to be posted on the SMI website.

SC1810 - Regional Aviation Safety Team Report - DP3

Upon completion of the update in DP3 the Steering Committee agreed that:

"Members update the RASG/APRAST Safety Implementation Tracking Tool on the APAC ICAO Bangkok website: http://imtsei.org/

As approved by the Steering Committee, the CTA is to update the Implementation Status Report and provide it to Member Administrations for their review and further input.

As approved by the Steering Committee, the CTA is to support Member Administrations in the implementation of the safety enhancement actions."

Action(s) to be Taken:

ASC1810.1 The CTA will update the COSCAP-NA NARAST as per Steering Committee approval.

ASC1810.2 The CTA continue to review OPEN items with the respective members during regular missions.

ASC1810.3 Members are to update the RASG/APRAST Safety Implementation Tracking Tool on the APAC ICAO Bangkok website: http://imtsei.org/. The CTA will support Members in this activity as requested.

SC1812 – USOAP CMA Update DP9

Following the discussions arising from the presentation of DP9, the Members approved the following draft conclusion:

"That States are urged to fulfil their obligations under the USOAP CMA Memorandum of Understanding (MOU) and to take actions as needed to provide up-to-date information on their safety oversight systems, with particular attention to:

- a) States with an SSC, focus on implementing sustainable corrective and immediate mitigation actions to resolve the SSC with a high priority;
- b) finalise draft and submit the Corrective Action Plans (CAPs) on the On-line Framework (OLF), informing the ICAO Regional Office when complete and ready for review;
- c) complete the compliance checklist/EFOD and update the SAAQ;
- d) implement the CAPs and complete the self-assessment of the PQs on the OLF, including uploading the evidence documents, to report the progress on the OLF, informing the ICAO Regional Office when complete and ready for validation; and
- e) request assistance from the ICAO Regional Office and COSCAP, if required."

Action(s) to be Taken:

ASC1812.1

The CTA is to support Members in all USOAP CMA activities as requested.

SC1813 Results of the Second Global Runway Safety Symposium DP10

Following the discussions arising from the presentation of DP10, the Meeting approved the following draft conclusion:

"That States and industry support the implementation at a regional and national level of the Global Runway Safety Action Plan in order to take measures to enhance runway safety using a multidisciplinary and collaborative approach; including the needed components and activities to reduce runway incursions and excursions, such as the implementation of RSTs."

Action(s) to be Taken:

ASC1813.1 The CTA is to support Members in the development/implementation of Runway Safety Teams as requested.

SCSC1929 Update to GASP DP8

It was noted by the representative from Macao that the APRAST is reviewing and revising the Regional Priorities and Targets with reference to the draft GASP 2020-2023. It will be further discussed at the next APARST/12 to be held in Bangkok at the end of May. Following the discussions arising from the presentation of DP11 the Steering Committee Members noted the contents of this paper and endorse the following conclusion:

That States:

a) are requested to establish a national aviation safety plan, including goals and targets consistent with the regional aviation safety plan, and in line with the GASP, including the global aviation safety roadmap, and based on the operational safety needs; and

b) are invited to provide ICAO feedback on the new global aviation safety roadmap and suggestions for the future 2020 - 2022 Edition of the GASP via email to: GASP@icao.int.

Action(s) to be Taken:

ASC1812.1

The CTA is to continue to focus on providing assistance in support of the GASP Global Safety Priorities.

SC1813 Results of the Second Global Runway Safety Symposium DP10

SC1828 – COSCAP-NA Policy On Training – DP11

Following the discussions arising from the presentation of DP11 the Steering Committee Members noted the contents of this paper and endorse the following conclusion:

Members approved the proposed policy statement for inclusion in the Institutional Framework and Administrative Procedures Manual (IFAPM). It should be noted that the APAC ICAO RSO is willing to provide a venue free of charge for COSCAP-NA events in the future.

Action(s) to be Taken:

ASC1819.1

The CTA is to amend the IFAPM accordingly and submit to the Executive Chairman Captain Jin Yibin for signature. Once the IFAPM has been signed the CTA is to distribute to Members.

The CTA is to inform ICAO of the Objective priority levels agreed to by the Members of COSCAP-NA.

SC1832 — Any Other Matters

Members expressed their gratitude to CAAC for hosting the 18th Steering Committee meeting and for the opportunity to experience the beautiful city of Hangzhou.
